**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Fresno's Chaffee Zoo Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Fresno's Chaffee Zoo Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

#### NOTE 1: DESCRIPTION OF PLAN

The following brief description of the Fresno's Chaffee Zoo Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all eligible employees of Fresno's Chaffee Zoo Corporation (the Company). It is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility** – An employee of the Company is eligible to participate in the salary deferral portion of the Plan immediately upon their date of hire provided they have attained age 21. The Company contributions will begin on the first day of the month coincident with or next following the employee's completion of one year of service with the Company in which at least 1,000 hours are worked and attainment of age 21.

**Administration** – The Plan is sponsored and administered by the Company. Costs of administering the Plan that are not paid by the Plan are paid by the Company.

**Employee Contributions** – Each year, participants may make pre-tax salary deferrals up to the maximum amount allowed by law (\$23,000 and \$22,500 in 2024 and 2023, respectively). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions (\$7,500 in 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified defined benefit plans, defined contribution plans or traditional IRAs. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant.

**Employer Contributions** – The Company may elect to make discretionary match and profit sharing contributions to the Plan. Discretionary matching contribution will be allocated to participants with elective salary deferrals and complete at least 1,000 hours in the plan year. Profit sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. Participants must be employed on the last day of the Plan year and complete at least 1,000 hours during the plan year to receive a profit sharing allocation. There were no discretionary matching or profit sharing contributions for the year ended December 31, 2024.

The Company also makes safe harbor matching contributions equal to 100% of the participant's elective deferrals, not to exceed 3% of eligible compensation, plus 50% of the participant's elective deferrals exceeding 3%, not to exceed 5% of eligible compensation, regardless of the employee's hours of service or employment on the last day of the plan year. The safe harbor matching contribution for the year ended December 31, 2024, was \$322,838.

***Participant Accounts*** – Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, the Company's profit sharing and safe harbor match contributions, if any, and plan earnings, and charged with withdrawals and an allocation of plan expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting*** – Participants are vested immediately in their contribution and the Company's contributions plus actual earnings thereon.

***Forfeitures*** – Forfeitures (participants' allocated interest in plan assets which are not vested because employment is terminated before the vesting period is complete) remain subject to being restored for five years after a participant terminates employment. Forfeited nonvested accounts totaled \$0 and \$22 for the years ended December 31, 2024 and 2023, respectively. The forfeitures may be used to offset future contributions or to pay plan administrative expenses.

***Payment of Benefits*** – In the event of termination of service, death, disability or retirement, a participant's vested interest in the Plan is distributed as a lump sum, as soon as administratively feasible.

***Investment*** – Participants are allowed to direct their contributions and contributions by the Company into any of the various investment options offered by the Plan.

***Notes Receivable From Participants*** – Participants may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant's vested account balance. Participant loans are to be repaid with interest at least quarterly and in a time period not to exceed five years, unless the loan is for the purchase of the participant's principal residence, in which case the loan must be repaid with interest within fifteen (15) years. Participant loans bear a reasonable interest rate as determined by the plan administrator. The interest rate on outstanding participant loans currently range from 5.25% to 10.50%.

**NOTE 2: SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting*** – The financial statements of the Plan are prepared under the accrual basis of accounting.

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's custodian, Charles Schwab Trust Bank, certified the value of the investments held by Charles Schwab. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends and capital gains are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable From Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the plan agreement.

*Administrative expenses* – The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan, including fees charged directly to the participant's account for notes receivable from participants and distributions, that are paid by the Plan are recorded as deductions from the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

*Payment of Benefits* – Benefits are recorded when paid.

**NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds).* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Collective trusts.* Units held in a collective trust (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. #### NOTE 6: INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Charles Schwab Trust Bank, the custodian of significantly all assets, has certified to the completeness and accuracy of:

1. Cash and investments as of December 31, 2024 and 2023, included on the accompanying statements of net assets available for benefits.
2. Net appreciation in fair value of investments, dividends, capital gains, benefits paid to participants and administration expenses, included on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### NOTE 7: FEDERAL INCOME TAX STATUS

The IRS ruled on June 30, 2020, that the volume submitter plan document adopted by the Company is qualified, in form, under Section 401(a) of the Internal Revenue Code (the "Code") and the underlying trust is, therefore, exempt from federal income tax under Section 501(a) of the Code. The Plan itself has not received a determination letter from the IRS on the current plan document. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S Federal jurisdiction. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
