NOTE 1 – PLAN DESCRIPTION

The following brief description of the Pope Group 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General: The Plan is a salary deferral and savings profit sharing defined contribution plan covering all full-time employees of Pope Automotive Group, Inc., D&C Imports, LLC (d/b/a Five Star Nissan), Five Star Ford Lincoln Mercury, LLC (d/b/a Five Star Ford Lincoln), Five Star Dodge, Inc., Five Star Ford Stone Mountain, LLC, Robins Chevrolet-Cadillac, LLC (d/b/a Five Star Chevrolet, Cadillac, GMC, and Buick), Warner Robins Motors, LLC (d/b/a Warner Robins Chrysler Jeep Dodge), Albany Imports, LLC (d/b/a Five Star Nissan of Albany), Tilley Lenoir City, LLC (d/b/a Lenoir City Chrysler Jeep Dodge), Five Star Florence, LLC, Formation Advertising, LLC, Gwinnett Automotive Holdings, LLC (d/b/a Gwinnett Chrysler Dodge Jeep Ram) Milledgeville Imports, LLC (d/b/a Five Star Toyota of Milledgeville), Five Star Nissan of Florence, LLC, Milledgeville Chrysler Dodge Jeep Ram, Tuscaloosa Ford, LLC, Middle Georgia Finance, LLC, Albany Motors, LLC (d/b/a Five Star Chrysler, Dodge, Jeep, and Ram), Five Star Hyundai Albany, LLC, Lafayette Buick GMC Cadillac, LLC, Lafayette Ford, LLC, Five Star of North Olmstead, LLC, Five Star of Middleburg Heights, LLC, BMW of North Canton, and Toyota of North Canton. Effective May 14, 2024, FS of Huntsville LLC (d/b/a Lexus of Huntsville) was added as a participating employer of the Plan. There is no service requirement for elective deferrals, while the service requirement for matching contributions is six months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is qualified under Section 401(a) and 401(k) of the Internal Revenue Code.

Effective October 15, 2024, the Plan was merged into the IMA Wealth Pooled Employer Plan (the “PEP”), a multiple employer plan administered by Standard Retirement Services, Inc. In connection with the merger, all assets and participant account balances of the Plan were legally transferred in trust to the PEP.

Contributions: Participants can contribute any amount of their gross wages during the Plan year subject to certain limitations. Participants are automatically enrolled at 4% deferral rate upon becoming eligible to participate in the Plan. The Company makes a matching contribution equal to 15% of participant deferrals, up to a maximum of 8% of participants’ eligible gross compensation. The Company may also make an annual discretionary profit sharing contribution. There was no discretionary profit sharing contribution during 2024.

Investment Options: Participants may direct contributions into various investment options and may change their investment options daily.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Payment of Benefits: Upon termination of service, participants may elect to receive either a lump-sum distribution or a direct rollover amount equal to the value of his or her vested interest in their account. In certain circumstances, participants may make “hardship withdrawals” as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution and (b) Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, earnings or account balances, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Forfeited Accounts: The nonvested portion of terminated participants' accounts plus earnings thereon are forfeited and can be used by the Plan to pay expenses or reduce the amount of future employer contributions to the Plan. The forfeitures balance totaled \$0 and \$30,773 on October 14, 2024 and December 31, 2023, respectively. For the period January 1, 2024 to October 14, 2024 there were no forfeitures used to pay plan expenses or reduce employer contributions. Forfeiture balance of \$137,618 was transferred to the PEP Plan on October 14, 2024.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. A participant becomes vested in matching contributions and employer discretionary contributions as follows:

Notes Receivable from Participants: Participants may not borrow from their fund accounts.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 10, 2025, which is the date the financial statements were available to be issued. All assets and participant account balances of the Plan were physically transferred to the PEP on November 4, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures, and actual results could differ from those estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity and credit risks. Market risks includes risks associated with ongoing global events.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit-responsive contracts, are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2023, and net appreciation in fair value of investments, and interest and dividends for the period from January 1, 2024 through October 14, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, FSB ("Nationwide Trust") and Nationwide Life Insurance Company, the Trustee and Custodian, respectively, of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

At December 31, 2023, the Plan held fully benefit-responsive investment contracts that are reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's fully benefit-responsive investment contracts, by general type, are presented below:

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (Continued)

Traditional Guaranteed Investment Contract: At December 31, 2023, the Plan held a fully benefit-responsive investment contract with Nationwide Life Insurance Company (“Nationwide Life”; Issuer). Nationwide Life maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions. Nationwide Life’s general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan’s investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan’s loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 14, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – PARTY-IN-INTEREST TRANSACTION AND INVESTMENTS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan held a guaranteed investment contract issued by Nationwide Life and shares of mutual funds managed by Nationwide Fund Advisors. Nationwide Life and Nationwide Fund Advisors are affiliates of Nationwide Trust, who is the Plan custodian and, therefore, these transactions and the Plan’s payment of custodian fees and investment management fees to Nationwide Trust qualify as party-in-interest transactions.
