INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
JT Logistics 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of JT Logistics 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matters

Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 and schedule of delinquent participant contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 — DESCRIPTION OF PLAN

The following brief description of the JT Logistics 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement (Agreement) for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of JT Logistics Solutions, LLC (the Company or Plan Administrator) who have completed 30 days of service, except leased employees and employees of JT Staffing Solutions. Plan participants may enter the Plan on the first day of the next month following the date the employee meets the eligibility requirements. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for the oversight of the Plan.

Plan Administration

The Company has contracted with Principal Trust Company (Principal and Custodian) to hold the Plan's assets, execute investment transactions, perform contributions and investment earnings allocations, and make benefit payments.

Contributions

The Plan allows for employee contributions up to 100% of eligible compensation, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans (rollover).

The Plan provides for matching Company contributions equal to 100% of the participants first 5% of contributions. Additional discretionary contributions may be made by the Company from time to time. In 2024 and 2023, employer discretionary contributions amounted to \$46,365 and \$0, respectively.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is increased or decreased by the participant's contributions, withdrawals, and an allocation of Plan earnings (losses), net of administrative expenses, and an allocation of the Company's contributions. Allocations to participants are based on the funds selected by the participant, as defined in the Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings and Company matching contributions. For employer discretionary contributions made prior to January 1, 2022, a participant is 100% vested after 5 years of credited service. Beginning January 1, 2022, participants are vested in employer discretionary contributions after completing 3 years of service.

NOTE 1 — DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Outstanding loans are limited to two per participant at any given time, are secured by the balance in the participant's account, and bear a reasonable fixed interest rate, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment, death, retirement, or disability, the participant may elect to receive a lump sum amount equal to the value of the participant's vested account balance, leave the balance in the account to share in investment gains and losses if the participant is not of retirement age, or select one of the monthly retirement and death benefit options. Balances less than \$5,000 are automatically paid in a lump sum.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Management fees and operating expenses charged to the Plan investments in the general and separate accounts and registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Forfeitures

Forfeitures may be used to pay Plan expenses or to offset employer contributions. As of December 31, 2024 and 2023, the Plan had no unallocated account balances. In 2024 and 2023, forfeitures amounting to \$2,458 and \$755, respectively, were used to pay Plan expenses and offset employer contributions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accrued benefits of all participants shall be distributed to participants as provided in the Agreement.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (GAAP).

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the Plan Administrator to make certain estimates and assumptions that affect the reported amount of net assets available for benefits and changes therein at the date of the financial statements and the reported amounts of contributions, investment income, and deductions during the periods reported. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. Because participant notes receivable are 100% collateralized by the participant's vested account balances, no allowance for credit losses is deemed necessary as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Contributions

Contributions from participants are recorded in the year in which they are withheld from compensation.

NOTE 3 — INVESTMENT INFORMATION CERTIFIED BY CUSTODIAN

The Company has elected the method of compliance permitted by 29 CFR 2520.103.8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certification from the Custodian that all the investment information provided by the Custodian, and included in the accompanying financial statements, notes to financial statements, and supplemental schedules is complete and accurate. Investment and related investment income information, including net appreciation (depreciation) on fair value of investments appearing in the accompanying financial statements, are presented based solely upon that certification. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023 and for the years then ended.

NOTE 4 — FAIR VALUE MEASUREMENTS

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is a market based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering market participant assumptions in fair value measurements, a fair value hierarchy was established, which prioritizes the inputs used in measuring fair values. The hierarchy gives the highest priority to Level 1 measurements and the lowest priority to Level 3 measurements.

The three levels of the fair value hierarchy are described as follows:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets that are not active;
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals); and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs may include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation methods used for assets measured at fair value.

Collective investment trusts

The fair values of units held in the collective trust fund are valued based on quoted redemption values, also known as net asset values (NAV), determined by using available market information and appropriate valuation methods, as provided by the Custodian and represent the value at which the Plan (or the participant) could initiate a transaction with the Custodian.

Pooled separate accounts

The fair values of units held in pooled separate accounts are valued based on quoted redemption values, also known as NAVs, determined by using available market information and appropriate valuation methods, as provided by the Custodian and represent the value at which the Plan (or the participant) could initiate a transaction with the Custodian. There are no imposed redemption restrictions on participants, except for certain short-term trading restrictions, which prohibit participants from reinvesting into the same account within 30 days.

NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS

Transactions resulting in Plan assets being transferred to, or used by a related party are prohibited under ERISA unless specific exemption applies. Principal Life Insurance Company is a party-in-interest because Plan participants are able to invest in certain pooled separate accounts or collective investment trusts offered by affiliates of the Custodian. These transactions are exempt and are not prohibited by ERISA. Fees paid by the Plan for investment management services were included as a reduction of the return on each pooled separate account or collective investment trust. Additionally, a participant who requires a participant loan is a party-in-interest. However, these transactions are exempt and are not prohibited under ERISA.

NOTE 6 — RISKS AND UNCERTAINTIES

Under the Plan, participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 — INCOME TAX STATUS

The Plan was created from a prototype plan developed by Principal Life Insurance Company. The IRS has determined and informed Principal Life Insurance Company, by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and therefore, is acceptable for use by employers for the benefit of their employees.

The letter also states that the IRS is not making a determination as to whether plans created from the prototype, such as this one, are designed in accordance with applicable sections of the IRC, but that such plans would be considered qualified provided all the terms of the prototype plan are followed and plan provisions are not more favorable to certain individuals. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan's management believes that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that "more-likely-than-not" would not be sustained upon examination by the IRS. Plan management has not identified any uncertain tax positions.

NOTE 8 — NONEXEMPT TRANSACTIONS

During 2022 and 2021, the Company inadvertently failed to deposit \$76,283 and \$6,598, respectively, of participant contributions within the required timeframe as stated by the DOL regulations. The Company intends to deposit lost earnings to correct these failures in 2025. The Plan will file Form 5330 and pay applicable excise tax to the IRS. The correction and any excise taxes will be made from Company assets.

NOTE 9 — SUBSEQUENT EVENTS

The Plan evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
