NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Methodist Theological School 403(b) DC Plan** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - On January 1, 1960, the Methodist Theological School in Ohio (the "Organization") adopted a Section 403(b) defined contribution plan. In accordance with the IRS requirements, the Plan restated its documents utilizing a pre-approved plan with an effective date of July 1, 2019. The Plan allows all permissible employees of the Organization, as defined in accordance with the universal availability standards, to enroll on their date of hire. In accordance with the SECURE Act, effective January 1, 2024, long-term part-time employees who were at least 21 years of age and worked at least 500 hours in each of the prior three years are eligible to participate in the Plan. Upon satisfaction of the eligibility requirements these employees may enter the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions.

Effective July 1, 2019, employer non-elective contributions are equal to 8% of eligible compensation and no longer requires an employee to contribute to the Plan. Additionally, employees with a senior scholar agreement as of July 31, 2019, and employees that have provided written notice of termination of employment with an effective date of December 31, 2019 by July 31, 2019 will receive a 10% employer contribution. Effective July 1, 2020, employees with senior scholar status effective on or before July 1, 2021, and for a period of four or more years, will receive a 10% employer contribution. Employees with a senior scholar status on or before July 1, 2021 and for a period of less than four years will not receive an employer contribution for Plan. Employer non-elective contributions are not provided to long-term part-time employees who worked less than 1,000 hours but were eligible to participate in the Plan under the SECURE Act.

No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the Internal Revenue Service. The Plan allows for Roth contributions.

Participant Accounts - TIAA and CREF are the Custodians of Plan investments. Each participant's account is credited with the participant's contributions, Organization contributions, net earnings or losses, distributions, and withdrawals. Organization contributions are allocated based on participants' compensation as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment the participant contribution and employer contribution are to be invested.

Vesting - Participants are immediately vested in all contributions and corresponding earnings.

Benefits Paid - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, or payments over a period of time in cash installments, or in a form agreeable to the Plan Administrator.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Forfeitures - Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions. No forfeitures were used during 2024 and 2023. Unallocated forfeitures at December 31, 2024 and 2023 were \$130 and \$124.

Investment Options - Upon enrollment in the Plan, a participant may currently direct contributions investment options in increments of one percent. Participants may change their investment options at any time via phone or the Internet. Deferral percentages can be changed via the enrollment form or the Internet.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Financial Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments, with the exception of the fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The fully benefit-responsive investment contracts are valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Excluded Contracts and Accounts - The Plan Administrator has elected to exclude certain contracts and accounts from Plan assets in accordance with DOL FAB 2009-09 due to the fact that:

- The contract or account was issued to a current or former employee before January 1, 2009;
- The employer ceased to have any obligation to make contributions (including employee salary reduction contributions), and in fact stopped making contributions to the contract or account before January 1, 2009;
- All the rights under the contract or account are legally enforceable against the insurer or custodians by the individual owner of the contract or account without any involvement by the employer; and
- The individual owner of the contract is fully vested in the contract or account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Notes Receivable from Participants - Beginning in June of 2017, participants could borrow amounts from TIAA and CREF using the assets of the Plan as collateral for the loans. General guidelines are that the minimum loan amount be \$1,000, while the maximum was equal to the lesser of \$50,000 or 45% of their vested account balance. The loans do not reduce the balance of the participants' accounts unless the loan is in default at the time when the benefits are distributable. The contract requires the participants to maintain at least 110% of the loan as collateral within the TIAA Traditional Annuity GSRA. The loans bear interest at variable rates tied to the Monthly Average Corporate Bond yield, published by Moody's Investor Service, plus 1%. Principal and interest are paid directly to TIAA and CREF.

At December 31, 2023, participants had outstanding loan balances with TIAA and CREF, collateralized by Plan assets, totaling \$445. There were no loans outstanding with TIAA and CREF that were collateralized by Plan assets at December 31, 2024.

Effective April 8, 2020, the Plan loan administration was changed so that participants may borrow amounts directly from their vested account balances and may have up to three outstanding loans at one time. Participants may borrow from their fund account balance in an amount up to 50% of their vested account balance, not to exceed \$50,000, and no less than \$1,000. Loans bear interest at the prime rate plus 1%. Loan terms are for a period not exceeding five years. A longer term may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participants' accounts. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - A portion of the administrative fees of the Plan are paid indirectly by the Plan participants, as a reduction of investment earnings. The Organization pays certain administrative expenses that are not paid by the Plan.

Subsequent Events - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF (the Custodians of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Investments in registered investment companies: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate fund: Valued using the market value of the underlying real estate holdings or other real estate related investments.

Non benefit-responsive contracts: Valued using the market value of the underlying Plan contracts.

NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The TIAA Traditional Annuities are fixed annuity contracts that are fully and unconditionally guaranteed by TIAA. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal, and guaranteed minimum rate of interest, and the potential for additional interest if declared by TIAA. When the accumulation in the TIAA Traditional Annuities are converted to annuities based on life expectancy, the present value of the stream of payments is equal to the accumulation. The contracts are included in the statements of net assets available for benefits at contract value.

Certain events, such as premature termination of the contract by the Plan, or the termination of the Plan, would limit the Plan's ability to transact at contract value with the Custodians. The Plan Administrator believes the occurrence of such events, which would also limit the Plan's ability to transact at contract value with Plan participants, is not probable.

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan assets are invested with TIAA and CREF. Thus, TIAA and CREF, as Custodians defined by the Plan, qualify as parties-in-interest. Fees paid by the Plan for custodian services for the years 2024 and 2023 totaled \$9,081 and \$7,412.

Pensionmark Financial Group, LLC., as investment advisors, qualifies as a party-in-interest. Advisory fees paid by the Plan for the years 2024 and 2023 totaled \$13,694 and \$16,481.

The Retirement Plan Company, as investment advisors, qualifies as a party-in-interest. Advisory fees paid by the Plan for the year 2024 totaled \$4,968.

The Organization provides certain accounting, recordkeeping, and administrative services to the Plan, for which it receives no compensation.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right to terminate the Plan subject to the provisions of ERISA and its related regulations.

NOTE 8 - TAX STATUS

The Plan adopted an ERISA 403(b) volume submitter plan, which received a favorable opinion letter from the Internal Revenue Service dated August 7, 2017, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS

At December 31, 2024 and 2023, there were no amounts due to participants who have withdrawn from the Plan and requested benefit payment prior to year-end.

NOTE 11 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For the years 2024 and 2023, there were no differences between the financial statements and the Form 5500.
