33. The Plan (and the trust established under the Plan) is qualified under the appropriate section of the Internal Revenue Code and intends to continue as a qualified plan (and trust). The Plan sponsor has operated the Plan and trust in a manner that did not jeopardize this tax status.
34. The Plan has complied with the DOL's regulations concerning the timely remittance of participants' contributions to trusts containing assets for the Plan.
35. The Plan has complied with the fidelity bonding requirements of ERISA.

We have obtained the service auditor's reports from our service organizations, ADP's Workforce Now Services System (payroll service provider) and Fidelity Workspace Services, LLC ("Fidelity", the plan recordkeeper). We have reviewed each report, including the complementary user controls, and we have implemented the relevant user controls which were in operation for the year ended December 31, 2024.
38. We are aware of certain operational failures that may constitute prohibited transactions that, if not properly corrected, could be treated by the IRS as qualification failures. This consists of the issuance of participant loans from 2022 to 2025 at interest rates below market rates, which is not in accordance with plan document which states that "loans shall bear a reasonable rate of interest as determined by the Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances". During 2024, an amendment was passed for Fidelity to administer loans issued to ensure interest rates were commensurate with market rates (to be issued at the Prime Rate plus 2 points). However, loans continued to be issued at rates below market through September 2025, at which time Fidelity ensured that this process was corrected. We are currently in the process of determining the impact of any corrections needed, including restoration of any lost earnings for interest payments made on loans with rates below market during this period. If necessary, the tax

qualification issues will be resolved directly with the IRS, however, we believe that the Plan will retain its tax-qualified status.

39. We are aware that a true-up calculation was made for a participant's employer matching contribution, which was remitted to the Plan in January 2025. The Plan's adoption agreement does not permit true-up calculations and, as of the date of this letter, we are working with Fidelity to resolve this matter. Accordingly, we believe that the Plan will retain its tax-qualified status.
40. We have no knowledge of any officer or director of the Plan or Plan Sponsor, or any other person acting under the direction thereof, having taken any action to fraudulently influence, coerce, manipulate, or mislead you during our audit.
41. We have not been made aware of any discrepancies in the account balances or investment selections of current or former employees who are participants in the Plan.

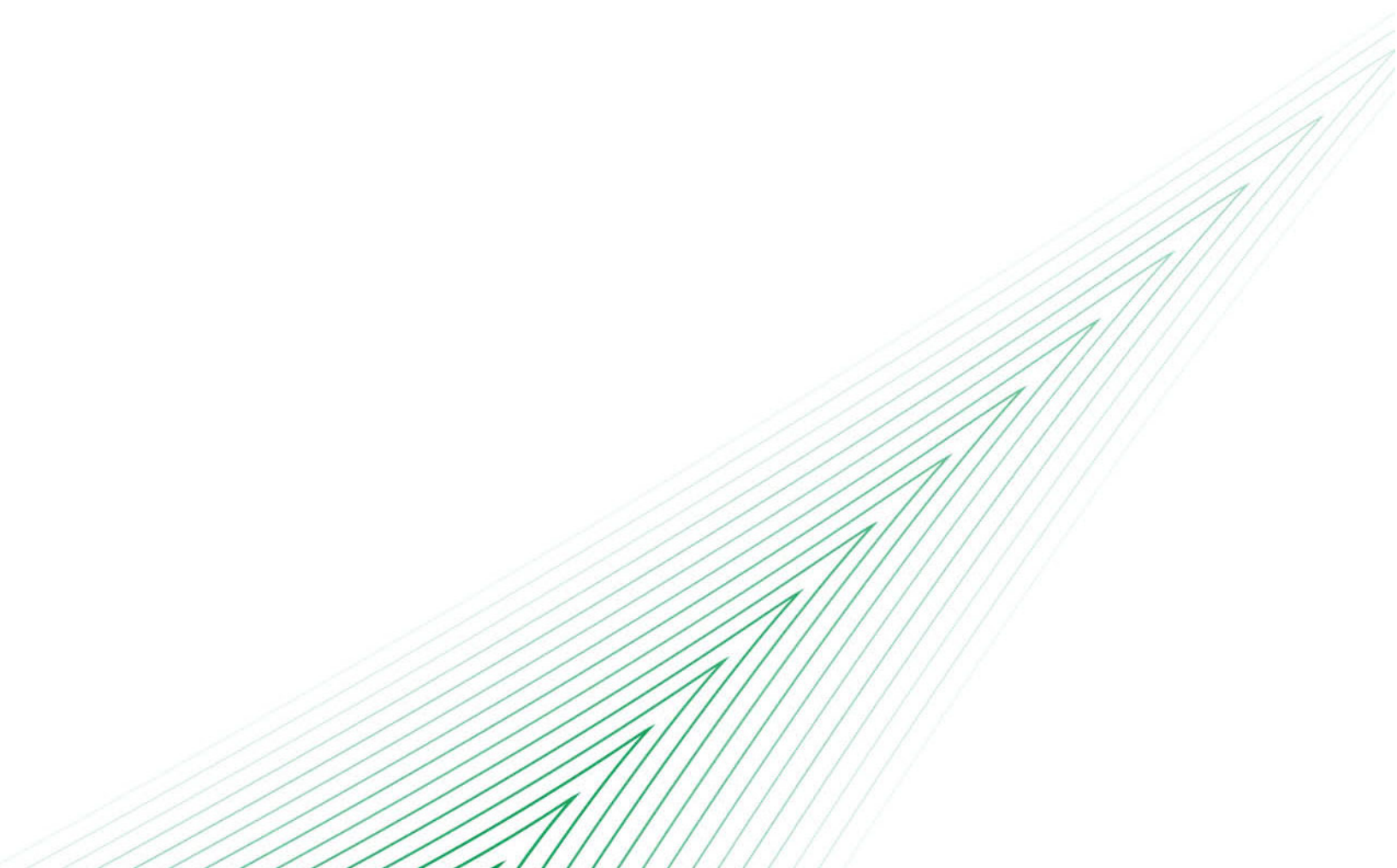

INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of the Medlogix 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General - The Plan is a defined contribution plan sponsored by Medlogix, LLC (the "Company" or "plan sponsor") for the benefit of its full-time employees and employees of related employers, Michigan Evaluation Group, Inc. and Integrity Medicolegal Enterprises, LLC, who have two months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's administrative committee is responsible for overseeing the Plan. The administrative committee, with the assistance of an investment advisor, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions - Each year, participants may contribute to the Plan up to 92% of eligible compensation, as defined in the Plan document. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation.

The Company matches between 50% and 87.5% of the first 4% of base compensation that the participant contributes to the Plan, depending on years of service. Additional amounts may be contributed at the discretion of the plan sponsor. During the year ended December 31, 2024, the Company did not make any discretionary nonelective profit-sharing contributions. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant investment account options - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.

Participant accounts - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution, portion of their accounts is based on years of continuous service, as follows:

Notes receivable from participants - Under defined conditions and approval by the plan administrator, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the interest rate for outstanding loans is 4.25%.

Payment of benefits - On termination of service due to death, disability, or retirement, a participant or his or her beneficiary(ies) may elect to receive either a lump sum amount or an annuity equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, and in qualifying instances of hardship, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited accounts - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,225 and \$2,996, respectively. Forfeitures may be used to pay Plan expenses such as administrative fees or can be used to reduce employer contributions. During the year ended December 31, 2024, the Plan used approximately \$29,400 of forfeitures to reduce employer contributions.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses for maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment fees are generally assessed as a percentage of assets invested and are deducted directly from net appreciation/depreciation in fair value of investments. Transaction-based fees, which are associated with optional services offered under the Plan, are charged directly to the participant's account as administrative expenses.

(3) **Information prepared and certified by the trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company ("FMTC"), the trustee of the Plan.

(4) **Fair value measurements**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the ASC Topic 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Comprised primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank's collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

(5) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(6) Tax status

The Plan has adopted a prototype nonstandardized 401(k) profit-sharing plan and trust. The trustee has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype Plan document was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize the tax liability (or asset) if the Plan has taken an uncertain tax position that "more likely than not" would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

(8) Related-party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds and a common collective trust managed by Fidelity Investments. FMTC, an affiliate of Fidelity Investments, is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for certain investment-related and recordkeeping expenses for the year ended December 31, 2024, totaled \$3,212.

(9) Operational failures - interest rates on notes receivable from participants

The Plan sponsor noted certain operational failures relating to notes receivable from employees issued from 2022 through 2024, where the interest rate established on these notes receivable was below the market rate as prescribed by the plan document. Loans not considered to be in conformity with the plan documents could be considered by the IRS to be prohibited transactions. The Plan sponsor is currently in the process of evaluating these operational failures for the necessary corrections.

(10) Subsequent events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.
