## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Pinewood Preparatory School 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### **1. Description of Plan**

The following description of the Pinewood Preparatory School 403(b) Plan ("the Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan that operates under Section 403(b) of the Internal Revenue Code covering all employees of Pinewood Preparatory School (the "School") except for non-resident aliens with no U.S. earned income. Employees become eligible for the School's matching contribution after 12 months of service except for those who normally work less than 20 hours a week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective May 16, 2024, the Plan was amended for the following:

- Hourly and substitute employees are excluded from the employer matching contribution.
- Loans are limited to non-residential general purposes.
- Plan compensation excludes PTO payout.
- Immediate vesting provision removed for employees under a union contract.

#### ***Contributions***

Each year, participants may contribute up to 100 percent of eligible compensation, as defined by the Plan, not to exceed the annual maximum allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The School contributes 100 percent of the first 3 percent of eligible participants' compensation which is contributed to the Plan. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and the School's matching contributions, as well as allocations of plan earnings. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions into selected investment options as made available and determined by the Plan Administrator. The Plan currently offers participants mutual funds and a fixed annuity contract as investment options for participants.

#### ***Vesting***

Participants are vested immediately in their elective contributions, plus actual earnings thereon. Participants become 100 percent vested in employer contributions after 3 years of service or upon attaining normal retirement age, death, or disability. Participants employed under a union contract are immediately vested in all contributions, plus actual earnings thereon through May 16, 2024. Subsequently they are subject to the Plan's vesting schedule.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 1 percent, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

### ***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, fixed installments, or an annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service and hardship distributions are permitted from a participant's vested portion of their account.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested account balances totaled \$9,701 and \$1,056, respectively. Forfeited accounts may be used to reduce future administrative expenses or employer contributions. No forfeitures were used during 2024.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value except for the fixed annuity contract which is reported at contract value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. During 2024, there were no new loans deemed to be in default.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the School and are excluded from these financial statements. Recordkeeping and third-party administration fees are charged to the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation(depreciation) of fair value of investments.

### **3. Unaudited Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group Trust Company, Inc. ("Lincoln") has certified that the following data included in the accompanying financial statements is complete and accurate.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:** Mutual funds are recorded at their net asset value.

**Other Registered Investments:** Other registered investments are a separate account which is divided into sub-accounts. The sub-accounts are the unit of account for the plan, as these are the offerings to the participants. These sub accounts are separate accounts that each hold a single registered investment. As the separate account does not file as a direct filing entity, the underlying investments are reported on the Form 5500. These investments are reported at NAV as their practical expedient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) The registered investments are separate accounts that invest in a single, open-ended mutual fund which is generally identified in the name of the separate account. The investment strategies of the separate accounts are consistent with each of the mutual funds identified in the name of the fund.

### 6. Investment Contracts

The Plan has investment contracts available through Lincoln. The contract holder maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each premium allocated to the fixed annuity investment contract buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited.

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, as reported to the Plan by Lincoln. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### 8. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unvested Participants would become 100 percent vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the School may determine is appropriate.

### 9. Tax Status

The Internal Revenue Service has issued an opinion letter on the volume submitter 403(b) plan document that the plan utilizes, dated March 31, 2017. The Plan may be periodically amended, however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **10. Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **11. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds and an investment contract managed by Lincoln and units of separate accounts managed by Empower as administrative provider for contracts issued by TRLIC. Lincoln and Empower are the record keepers. Maxus Plan Solutions is the third party administrator, and Merrill Lynch is the Plan advisor. Transactions with these parties qualify as party-in-interest transactions.

### **12. Non-Exempt Transactions**

During the plan year ended December 31, 2024, employee withholdings amounting to \$11,731 were not remitted to the Plan within the appropriate time frame by the Company. These transactions constitute prohibited transactions as defined by ERISA. The Company remitted these contributions to the Plan during the Plan year. The lost earnings are in the process of being calculated.

### **13. Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan amended its definition of compensation to exclude bonus pay.
