### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Royal Realty Corporation Employees 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

#### Note 1. Plan Description

The Royal Realty Corporation Employees 401(k) Plan (the Plan) is a defined contribution plan, which was established January 1, 1985. Participants should refer to the basic Plan document for a complete description of the Plan's provisions.

**Eligibility and contributions:** The Plan covers all eligible nonunion employees of Royal Realty Corporation and Royal 1 WTC Management, LLC (collectively, the Company, Plan Sponsor or the Employer) and is funded by employee contributions as well as discretionary Employer matching contributions. Eligible employees can elect to make contributions up to 80% of their annual compensation subject to the maximum allowable under the Internal Revenue Code (IRC). The Employer matching contribution is a discretionary percentage or fixed amount, which is determined by the Plan Sponsor on an annual basis. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). For the year ended December 31, 2024, the Plan Sponsor elected to match the lesser of one half of the participant's contribution or 4% of W-2 compensation. The Plan also allows for profit sharing contributions in an amount, if any, to be determined by the Employer. No profit sharing contributions were authorized for the year ended December 31, 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2017, the Plan was amended so that matching contributions (other than safe harbor matching contributions) made by the Employer that the Plan Administrator designates as qualified matching contributions and are allocated to a participant's account, not distributable to a participant until distributable from the Plan, nonforfeitable when allocated to a participant's account and distributable only in accordance with the distribution provisions that are applicable to pretax contributions (other than the hardship withdrawal provisions). Qualified matching contributions may not be withdrawn on account of a hardship.

Effective January 1, 2017, the Plan was amended so that contributions (other than matching contributions, safe harbor matching contributions or qualified matching contributions) made by the Employer, which the Plan Administrator designates as qualified nonelective contributions and are allocated to a participant's account, not distributable to a participant until distributable from the Plan, nonforfeitable when allocated to a participant's account and distributable only in accordance with the distribution provisions that are applicable to pretax contributions (other than the hardship withdrawal provisions). Qualified nonelective contributions may not be withdrawn on account of a hardship. If selected in the Adoption Agreement, a prevailing wage contribution made on behalf of a non-highly compensated employee shall constitute a qualified nonelective contribution to the extent such contribution does not exceed the limit set forth in Treasury Regulation Section 1.401(m)-2(a), as amended, or other applicable Internal Revenue Service guidance.

To be eligible to participate in the Plan employees must have attained the age of 21 and completed three months of service starting with their hire date. Enrollment in the Plan occurs on the first of the month following the date in which the employee has satisfied the eligibility requirements.

**Participant accounts:** Each participant account is credited with the participant's contribution, allocations of the Employer's matching and profit sharing contributions and Plan earnings and is charged with an allocation of certain administrative expenses. Upon enrollment in the Plan, participants may direct contributions to their accounts among several fund investments. The investing objectives of each fund have been made available to the participants.

#### Note 1. Plan Description (Continued)

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested in the Employer's contributions plus actual earnings thereon based on years of continuous service. A participant vests 20% per year beginning with the second year and becomes 100% vested after six years of service.

**Payment of benefits:** Under the Plan, a participant who reaches normal retirement age or postpones retirement, dies or becomes permanently disabled, as defined in the Plan, receives the amount in his or her account either in a lump sum or installments. Hardship distributions are permitted.

Upon termination of employment prior to normal retirement age, except by virtue of disability or death, the participant is entitled to his or her vested interest in the account either in a lump sum or installments. A participant's consent is not required for vested account balances less than \$5,000, and the account will automatically be distributed from the Plan.

**Forfeitures:** Forfeitures are used to offset administrative expenses and then to reduce Company contributions. Forfeited nonvested accounts totaled \$88,582 and \$55,535 at December 31, 2024 and 2023, respectively. During 2024, \$94,573 was used to offset administrative expenses, and no forfeitures were used to reduce Company contributions.

**Notes receivable from participants:** Loans receivable are from participants who borrow against their vested amounts in an amount up to the lesser of 50% of the value of the participant's account or \$50,000. The loan, by its terms, must require repayment (principal and interest) be amortized in level payments, not less frequently than quarterly, over a period not extending beyond five years from the date of the loan; provided, however, that the proceeds of the loan were used to acquire a dwelling unit which within a reasonable time (determined at the time the loan is made) would be used as the principal residence of the participant, the repayment schedule may be for a term in excess of five years. The loans are secured by the balance in the participant's account and bear interest between 4.25% and 9.50%.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The Plan's financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are maintained by Bank of America, N.A. (BOA), the trustee of the Plan and are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. If a participant or beneficiary defaults on a loan that is secured by the participant's vested account balance, then a participant's vested balance may be offset by the amount of the outstanding balance of the loan to the extent there is a distributable event permitted by the Department of Labor (DOL) Regulation code section 2550. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of benefits:** Benefits are recorded when paid.

**Contributions:** Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent events:** For the year ended December 31, 2024, subsequent events were evaluated through October 10, 2025, the date the financial statements were available to be issued.

#### **Note 4. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

All transfers between fair value hierarchy levels are recognized by the Plan at the end of each reporting period. There were no significant transfers between Levels 1, 2 and 3 during the year.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the best level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Note 4. Fair Value Measurements (Continued)

**Self-directed investments:** Self-directed investments mainly consist of common stocks, which are valued at the closing price reported on the active market on which the individual securities are traded, mutual funds and a money market fund.

**Money market fund:** The fund seeks to provide current income while maintaining liquidity and a stable share price of \$1.

**Common collective trust:** Valued at the NAV of shares in each account held by the Plan at year-end. The NAV is not a publicly quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

#### Note 6. Tax Status

The Plan is a nonstandardized defined contribution pre-approved plan, and an opinion letter was received dated June 30, 2020, stating that the Plan is acceptable under Section 401(a) of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan, as amended, is currently designed, and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

The Plan Sponsor's management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that required adjustments to the financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024. Therefore, no provision or liability for income taxes has been included in the financial statements.

#### Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that change in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
