## Independent Auditor's Report

To the Plan Administrators  
Connecticut On-Line Computer Center, Inc. 401(k) Plan  
Southington, Connecticut

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Connecticut On-Line Computer Center, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### **NOTE 1 - DESCRIPTION OF THE PLAN:**

The following description of Connecticut On-Line Computer Center, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General:

The Plan is a defined contribution 401(k) profit-sharing plan covering all eligible employees of Connecticut On-Line Computer Center, Inc. (the “Company”), who are age 20½ or older. Eligible employees may participate in the Plan after 1/12 of a year of service. Effective May 3, 2021, the eligible age was changed to 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan Sponsor’s Board of Directors.

##### Contributions:

Each year, participants may contribute up to 100% of pre-tax annual eligible compensation and voluntary after-tax Roth 401(k) contributions, as defined by the Plan. Participants who attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing eligible distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds comprised of money market accounts, stock funds, bond funds, and governmental funds, as well as a collective investment trust and a self-directed brokerage account as investment options for participants. Effective May 2021, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. Automatically enrolled participants will have their deferrals increase 1% each year, up to a maximum of 10% of eligible compensation.

The Company also makes non-discretionary safe harbor matching contributions equal to 100% of the first 3% of the eligible participant’s Plan compensation that a participant contributes and 50% of the next 2% of the eligible participant’s Plan compensation that a participant contributes on a payroll basis. Additional profit-sharing amounts may be contributed at the option of the Company’s Personnel Committee. For the year ended December 31, 2024, the Company elected to make a discretionary profit-sharing contribution of \$2,191,297, before forfeitures applied of \$66,192. Contributions are subject to certain IRS limitations.

**NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED):**

Participant Accounts:

Each participant's account is credited with the participant's contributions and Company non-discretionary safe harbor matching contributions, as well as allocations of the Company's profit-sharing contribution and the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions and the Company's non-discretionary safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's profit-sharing contribution is based on years of continuous service as follows:

<u>Completed Years of Service</u>	<u>Percent of Company's Contribution</u>
1	25%
2	50%
3	75%
4	100%

The value of the account of any employee becomes fully vested upon death or permanent disability.

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at one percent above the Wall Street Journal's published prime rate. Principal and interest are paid ratably through payroll deductions.

#### **NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED):**

##### **Payment of Benefits:**

Upon termination of service due to death, disability, retirement, or the attainment of the age of 59½, a participant may elect to receive either a lump-sum amount, deferred lump-sum amounts, or in installments equal to the value of the participant's vested interest in his/her account. If upon withdrawal, a participant has a vested account balance less than \$1,000, participant will receive a lump-sum amount equal to the value of the participant's vested interest in his/her account. For participants with a vested account balance greater than \$1,000, but less than \$5,000, the Plan administrators will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrators.

Withdrawals from a participant's vested account may also be made in the event of a financial hardship in accordance with the provisions specified in the Plan.

##### **Forfeited Accounts:**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$66,192 and \$61,957, respectively. These accounts will be used to reduce future employer contributions. During 2024, the 2023 employer profit-sharing contribution was reduced by \$61,957 from the forfeited non-vested accounts.

#### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

##### **Basis of Accounting:**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrators to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):**

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management and the Investment Committee determine the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit is recorded.

Payment of Benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events:

Plan management has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.

#### **NOTE 3 - FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. The collective investment trust is excluded from the fair value hierarchy as the fund's fair value is measured using the net asset value per share practical expedient. This change in valuation methodology has been applied retrospectively.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Investments in mutual funds have been designated level 1 instruments.

*Self-directed brokerage account:* Common stocks held by the self-directed brokerage account are valued at the closing price reported on the active market on which the individual securities are traded. The money funds are valued using significant observable inputs, particularly dealer market prices as of the valuation date. Mutual funds are valued as noted in the aforementioned paragraph. Investments in the self-directed brokerage account have been designated level 1 instruments.

#### **NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED):**

*Collective investment trust:* Valued at net asset value (“NAV”) of the fund. The NAV is calculated by the fund based on “net assets”, which includes fully benefit-responsive investment contracts at contract value. This NAV represents the Plan’s fair value since this is the amount at which the Plan transacts with the fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value for the collective investment trust stable value fund. The Fund seeks to provide preservation of principal and consistent returns by investing primarily in high-quality fixed-income securities and benefit-responsive contracts.

As of December 31, 2024 and 2023, there were no level 2 or 3 investments.

#### **NOTE 5 - RELATED PARTY TRANSACTIONS:**

Certain Plan investments were managed by John Hancock Trust Company LLC (“John Hancock”). John Hancock is the trustee as defined by the Plan, and therefore these transactions qualified as party-in-interest transactions. Fees incurred by the Plan for the investment management services were included in net appreciation in fair value of investments, as they were paid through revenue sharing, rather than a direct payment. The Plan sponsor pays directly any other fees related to the Plan’s operations.

John Hancock provides certain administrative services to the Plan pursuant to a service agreement. The service agreement provides for service-based pricing in which John Hancock receives revenues from mutual funds in the Plan's core menu. These revenues are first used to satisfy John Hancock recordkeeping fees. The excess revenues are deposited into an unallocated plan expense reimbursement account. This amount is held for the exclusive purpose of defraying reasonable Plan expenses or providing benefits for participants. If the revenues do not cover the fees owed, the Plan Sponsor is billed for the difference.

At December 31, 2024 and 2023, the plan expense reimbursement account had a balance of \$15,506 and \$3, respectively.

#### **NOTE 6 - PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested.

#### **NOTE 7 - INCOME TAX STATUS:**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the “IRC”). The Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.
