INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the
Great Lakes Medical Imaging, LLC Profit Sharing 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Great Lakes Medical Imaging, LLC Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO THE FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Great Lakes Medical Imaging, LLC (the Company). The Plan was established February 1, 2009 and is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Administration: The Plan is administered by the Company. The 401(k) Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors performance, and reports to the Board of Directors. Newport Trust Company, LLC (Newport) was the trustee and custodian of the Plan as of and for the year ended December 31, 2023 and for the period January 1, 2024 through November 13, 2024. Effective November 14, 2024, Ascensus Trust Company (Ascensus) acquired Newport and became the trustee and custodian as of and for the period November 14, 2024 through December 31, 2024.

Eligibility and Contributions: An employee shall become eligible for purposes of 401(k) employee and employer contributions upon reaching age 21 and completing one year of service as defined in the Plan Document. Each year, participants may contribute up to the maximum amount allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). All participants who are eligible to make elective deferral contributions may elect to designate all or any of their deferral contributions as a Roth elective deferral contribution. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor match contribution equal to 3% of eligible compensation, as defined by the Plan. The safe harbor contribution for the year ended December 31, 2024 is \$518,551 (\$465,659 - 2023). In addition, the Company may make discretionary matching and profit sharing contributions. No discretionary matching contributions were made for the years ended December 31, 2024 or 2023. The profit-sharing contribution for the year ended December 31, 2024 is \$1,000,922 net of forfeitures (\$888,294 - 2023). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and Company safe harbor contributions, as well as allocations of the Company's discretionary profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through bi-weekly or monthly payroll deductions.

Payment of Benefits: Upon termination of service due to death, disability, retirement, or for termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Installments are only permitted for participants or beneficiaries who must receive minimum required distributions. Balances under \$5,000 are automatically distributed and do not require participant consent. A non-spouse surviving beneficiary must withdraw within 5 years and a surviving spouse may elect to defer payment up to the year in which the participant would have attained age 72. Hardship withdrawals are allowable from elective deferral, employer matching, and employer profit sharing accounts if IRS guidelines are met. Distributions, without penalty, may be made upon the attainment of age 59-1/2.

NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Forfeited Accounts: At December 31, 2024, forfeited non-vested accounts totaled \$69,608 (\$68,332 - 2023). Employer matching contributions forfeited by participants are used to reduce future employer contributions. During the year ended December 31, 2024, \$72,501 of employer contributions were funded from forfeited non-vested accounts (\$17,500 - 2023).

Reclassification: Certain prior period amounts have been reclassified for consistency with the current year presentation.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits: Benefit payments are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Committee (ASC) 820 are described as follows:

NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust: Valued based on the NAV per unit of the fund provided by the trust. The NAV is used as a practical expedient to measure fair value. Unit values are determined by dividing the fund's net assets, which represents the fair value of the underlying investments, by its units outstanding at the valuation date.

Self-directed brokerage funds: This investment consists of various investments valued based on Level 1 and Level 2. The investments based on Level 1 inputs consist of mutual funds, common stocks, preferred stocks, exchange traded funds, money market funds, and cash and cash equivalents valued at readily determinable market prices of the associated investment. The investments based on Level 2 inputs consist of convertible preferred stock, and corporate bonds valued using pricing models maximizing the use of observable inputs for similar securities.

NOTE 4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Ascensus. Ascensus is the custodian and trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will be fully vested in their employer contributions.

NOTE 6. TAX STATUS

The Plan adopted a non-standardized pre-approved plan sponsored by Ascensus. The non-standardized pre-approved plan has received an opinion letter from the IRS dated June 30, 2020 as to the non-standardized pre-approved plan's qualified status. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 6. TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8. FINANCIAL CERTIFICATION

The following unaudited financial information has been furnished by the Plan Administrator and was certified as complete and accurate by the current custodian, Ascensus, for the period November 14, 2024 through December 31, 2024, and the former custodian, Newport, for the period January 1, 2024 through November 13, 2024 and as of and for the year ended December 31, 2023. The incorporation of this financial information in the accompanying financial statements is based solely on their certification, and the information relating to assets and transactions has not been audited by independent accountants.
