16. The methods and significant assumptions used to estimate fair values of financial instruments are disclosed in the financial statements in Note 4. The methods and significant assumptions used result in a measure of fair value appropriate for financial measurement and disclosure purposes.
17. For any securities that do not have a readily determinable market value, we are in agreement with the methods used to estimate fair value or the approach used by the appraiser. We agree with the findings of specialists in evaluating the stock value and have adequately considered the qualifications of the specialist in determining the amounts and disclosures used in the financial statements and underlying accounting records. We did not give or cause any instructions to be given to specialists with respect to the values or amounts derived in an attempt to bias their work, and we are not otherwise aware of any matters that have had an effect on the independence or objectivity of the specialists.
18. The values of nonreadily marketable securities represent good faith estimates of fair value determined by SC & H Capital.
19. We have no plans or intentions that may materially affect the carrying value or classification of assets and liabilities.
20. We have no intentions to terminate the Plan.
