Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedules Required by ERISA**

The supplemental schedule of Form 5500 Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to

prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTES TO FINANCIAL STATEMENTS**  
**Years Ended December 31, 2024 and 2023**

**A. DESCRIPTION OF PLAN**

The following description of the Misfits Market, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan’s provisions.

*General:* The Plan is a defined contribution plan covering substantially all employees of Misfits Market, Inc. (“Company”). Employees are eligible to contribute to the Plan and receive employer matching contributions after reaching age 21 and completing 4 consecutive months of service beginning on the employee’s date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Directors is responsible for the governance of the Plan.

In 2022, the Plan Sponsor acquired Imperfect Foods, Inc. and allowed their participants to roll into the Misfits Market, Inc. 401(k) Plan. Participants with loans from the Imperfect Foods, Inc. 401(k) Plan were allowed to transfer them to the Misfits Market, Inc. 401(k) Plan. No new loans are allowed to be taken.

*Contributions:* Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan, subject to limits defined by the Internal Revenue Service (IRS). Roth deferrals are also permitted.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, and their contributions are invested in the designated default fund until changed by the participant. For these participants, the deferral rate increases by 1% at the beginning of each Plan year up to a maximum of 8%, unless otherwise updated by the participant.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company has the option to make discretionary and profit-sharing contributions to the Plan. However, neither were provided in the current Plan year aside from a discretionary contribution to correct errors from the prior years.

Participants may direct the investment of their contributions into various investment options offered by the Plan, otherwise they are automatically invested in the designated default fund. The Plan currently offers various mutual funds as investment options for participants. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution, applicable discretionary matching and profit-sharing contributions by the Company, an allocation of Plan earnings (losses), and charged with administrative expenses as applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions, Company discretionary matching and profit-sharing contributions, plus actual earnings thereon.

Notes Receivable from Participants: Participants with loans from the Imperfect Foods Inc. 401(k) Plan were allowed to borrow from their accounts. When Misfits Market Inc. acquired Imperfect Foods, Inc. in 2022, those participants with loans outstanding were grandfathered in and allowed to transfer their loans to the Misfits Market, Inc. 401(k) Plan. The notes are secured by the balance in the participant's account and bear an interest rate commensurate with interest rates charged by local commercial banks for similar loans. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Upon termination of service, death, disability, or retirement (age 65), a participant may elect to receive either a single-sum payment equal to the value of the participant's vested interest in his or her account or partial payments requested from time to time. The Plan allows for in-service withdrawals if a participant reaches age 59<sup>1/2</sup>, and hardship distributions subject to Plan provisions.

If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan Administrator will authorize a lump-sum benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the benefit will be rolled into an individual retirement account in the participant's name. Participants are given notice prior and have 30 days to move the balance themselves before these cash-out provisions become effective.

Forfeited Accounts: As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7 and \$1 respectively. There were \$59 and \$11,099 of forfeitures used to reduce plan sponsor fees during the years ended December 31, 2024 and 2023, respectively. These accounts will be used to reduce future plan sponsor fees.

## **B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting.

### Estimates and Assumptions:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### Investment Valuation and Income Recognition:

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at

the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based on the terms of the Plan document.

Benefit Payments:

Benefit payments are recorded when paid.

Administrative Expenses:

Certain administrative expenses of the Plan are paid directly by the Company and are therefore excluded from these financial statements. Administrative expenses of the plan are allocated to participant accounts.

Excess Contributions Payable:

Amounts payable to participants totaling \$53,428 and \$64,258 as of December 31, 2024 and 2023, respectively for contributions in excess of amounts allowed by the IRS were recorded as accounts payable, with a corresponding reduction to 2024 and 2023 contributions, respectively. The Plan will distribute the 2024 excess contributions in 2025 and distributed the 2023 excess contributions during 2024.

**C. INVESTMENTS (UNAUDITED)**

The investment activities and balances included on the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statements of Changes in Net Assets Available for Benefits for the year then ended, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the trustee, Ascensus Trust Company, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information certified includes total investments of \$10,722,863 and \$8,608,806 at December 31, 2024 and 2023, respectively, notes receivable from participants of \$16,470 and \$2,007 as of December 31, 2024 and 2023, respectively, and related investment income of \$1,352,256 and \$1,119,760 respectively, for the years then ended.

**D. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Mutual funds are quoted daily at publicly available prices, based on the market value of its underlying investments. Mutual funds are deemed to be actively traded.

## **E. PARTY-IN-INTEREST TRANSACTIONS**

Ascensus Trust Company is the trustee and The Vanguard Group, Inc. is the Plan Administrator as defined by the Plan. Certain Plan investments are managed by the trustee, Plan Administrator, or other affiliated companies.

Administrative services are offered through the Plan Administrator. Total direct charges and fees, including asset charges, Plan service fees, and transaction fees, are paid by the Plan Sponsor to The Vanguard Group, Inc., an affiliated company of the trustee. Certain fees incurred by the Plan for the investment management services are included in administrative expenses, including auditor fees and the cost of ERISA bond coverage.

All of these party-in-interest transactions are exempt from the prohibited transaction rules and ERISA.

## **F. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. During the current Plan year, the Company did not provide contributions to the Plan, but could begin contributing in future years.

## **G. TAX STATUS**

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the form of the Plan was acceptable under the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan has annual regulatory filing requirements to the Department of Labor (“DOL”) of the Form 5500.

## **H. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
