### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Brookhaven Memorial Hospital Medical Center DBA Long Island Community Hospital Retirement Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. Description of the Plan**

The following description of the Brookhaven Memorial Hospital Medical Center DBA Long Island Community Hospital Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a complete description of the Plan’s provisions. Copies are available from the Plan sponsor, NYU Langone Hospitals (the “Hospital”).

On March 1, 2025, Long Island Community Hospital at NYU Langone Health (d/b/a Long Island Community Hospital) (“LICH”) completed a full asset merger into NYU Langone Hospitals and changed its name to NYU Langone Hospital – Suffolk. Accordingly, NYU Langone Hospitals became the Plan Sponsor.

**General**

The Plan was established effective July 1, 2002. The Hospital is the sponsor of the Plan. The Plan is subject to the provisions of *Employee Retirement Income Security Act* (“ERISA”).

The Plan is a defined contribution plan under Internal Revenue Code (“IRC”) Section 401(a), which includes a deferred arrangement that is intended to qualify under IRC Section 401(k). The Plan covers all eligible employees of LICH who have attained the age of 18. An eligible employee is defined as any person employed by LICH, with the exception of those employed by LICH as contract, stipend, or fee-for-services employees, interns, or residents. All eligible employees become eligible to receive an allocation of non-elective and matching contributions after they have completed one year of service in which they have worked 1,000 hours and have attained age 21.

Employees hired on or after May 1, 2008, are automatically enrolled in the Plan with an elective deferral of 3%, unless they notify the Plan that they elected not to participate or have an affirmative election in effect. In April 2016, the Plan was amended with an effective date of January 1, 2016. The amendment provided for an automatic escalation to employees who did not have an affirmative election in effect on January 1, 2016, or did not notify the Plan that they elect not to participate. The initial “default period” begins on the date the first automatic deferral of 3% is made and ends on March 31 of the plan year following the plan year in which the “default period” began. Subsequent “default periods” are based on 12 consecutive-month periods beginning on April 1. The escalation of 1% begins with the second “default period” and caps at 10%. In addition, for eligible employees who have an affirmative election to contribute less than 10% of their compensation, effective with the first payroll period beginning on or after April 1, the elective contribution will increase by 1% up to 10% of the eligible employee’s compensation, unless an affirmative election against the increase is provided.

Empower Annuity Insurance Company of America (“Empower”) processes and maintains participant data and is the current Plan custodian. The Hospital, as the Plan Administrator, controls and manages the operation and administration of the Plan. Each participant’s account is credited with the participant’s contribution, the Hospital’s matching contribution, the allocations of the Hospital’s non-elective contribution, Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, and specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Contributions**

Each year, participants may contribute from 1% to 90% of their pre-tax annual compensation, as defined in the Plan, subject to statutory limits. Contributions for any year may not exceed the limitations as specified in the IRC. Pre-tax contributions may not exceed the 2024 pre-tax limit of twenty-two thousand five hundred dollars as established by the IRC. Participants age 50 and over are eligible to contribute extra pre-tax contributions (“catch-up contribution”) above the annual Internal Revenue Service (“IRS”) limitations up to seven thousand five hundred dollars in 2024. Participants can elect an amount to be contributed from each paycheck as their catch-up contribution. This amount will be in addition to the pre-tax and post-tax contribution percentages that participants have elected.

The Hospital, at its discretion, contributes a matching percentage each year, equal to 50% of the first 4% of compensation that the participant contributes, up to a maximum of one thousand seven hundred dollars per participant. The Hospital’s matching contribution is invested based on the participants’ elected allocation percentages.

The employer non-elective contributions are a discretionary dollar amount, as determined by the Hospital. Contributions are allocated to eligible employees, as outlined in the Plan Document, as a percentage of compensation based on a participant’s years of service. The allocation rate (if any) for each contribution period shall be determined by the Hospital in its sole discretion, unless specified otherwise in a collective bargaining agreement.

**Vesting**

Participants are vested immediately in their contributions, plus actual earnings thereon. Participants become 100% vested in the Hospital’s contributions and earnings thereon upon death, total and permanent disability, or attainment of normal retirement age. Otherwise, vesting in the Hospital’s contributions plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after three years of credited service.

**Forfeited Accounts**

Where a participant’s employment with LICH is terminated before they are 100% vested in employer contributions, the unvested portion of their employer contributions will be forfeited. The balance in the forfeiture account will be used first to restore returning employees whose balances were forfeited or to fund administrative expenses and employer contributions required to be made to the Plan. As of December 31, 2024 and 2023, amounts available in the forfeiture account totaled \$152 and \$101, respectively. The Hospital utilized \$347 and \$70 of forfeitures to reduce employer contributions and fund administrative expenses for the year ended December 31, 2024.

**Notes Receivable From Participants**

Participants are eligible to borrow against their annuity contract or custodial account, a minimum of one thousand dollars up to a maximum equal to the lesser of 50% of their individual vested account or fifty thousand dollars. Participants are allowed to have only one loan at any time. At December 31, 2024 and 2023, participant loans in the amount of \$2,796 and \$2,845, respectively, are included in notes receivable from participants in the statements of net assets available for benefits. For the participant loans outstanding, the interest rate ranged from 4.25 to 9.50% for December 31, 2024 and 2023.

**Payment of Benefits**

On termination of service due to death, disability, or retirement a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, unless the participant elects to receive the distribution in a series of cash installments not exceeding the life expectancy of the participant, or the participant's beneficiary. For termination of employment for other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution.

If the value of a participant's vested interest in their account is five thousand dollars or less, the participant's account will be "cashed out" by distributing the participant's vested interest by a single-sum payment or by direct rollover to an individual retirement account or other eligible retirement plan as soon as reasonably practicable following the date the participant's employment terminates. The participant's account will be cashed out even if the participant does not consent to the distribution. If the value of the participant's vested interest is more than five thousand dollars, distribution of the account balance cannot be made before the participant's normal retirement date without the participant's written consent.

**Investments**

Upon enrollment in the Plan, participants allocate contributions made on their behalf amongst the investment options in whole percentages to purchase accumulation units or annuity contracts. The number of units purchased is based on the net asset value ("NAV") per unit on the day their contributions are received. Investment return is allocated to participants' accounts based upon the number of units the participant owns in each investment.

The Plan allows participants to direct the investment of their accounts into various investment options, including but not limited to, Empower Group Annuity Contract, various mutual funds, and several pooled separate accounts. Participants may change their investment options at their discretion.

**2. Summary of Significant Accounting Policies**

**Basis of Presentation**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of Estimates**

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingencies at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from these estimates and such differences could be material.

**Valuation of Investments and Income Recognition**

The Plan's investments are held by Empower and are stated at fair value except for the fully benefit-responsive investment contracts that are stated at contract value. Shares of mutual funds are valued at daily closing price as reported by the fund. The fair value of the pooled separate accounts is valued on a daily basis using net asset value (NAV) as a practical expedient. The NAV, as provided by the Plan's custodian, is calculated based on the net assets of the underlying pool of securities. The underlying securities in the pooled separate accounts include various debt securities and securities that are listed on national securities exchanges and valued on the basis of year-end closing prices. The investments are redeemable at NAV on a daily basis with no redemption restrictions. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The mutual funds are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value to transact at that price and are deemed to be actively traded. Investments in pooled separate accounts and variable annuities are valued at current fair value, which represents the net asset value of the units held at year end. Investments in fully benefit-responsive investment contracts are valued at contract value which equals the accumulated cash contributions and interest credited to the contracts less any withdrawals.

The Plan has a fully benefit-responsive investment contract with Empower. Empower maintains contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contract. As of December 31, 2024 and 2023, contract value approximated fair value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of the net realized gains or losses and the net unrealized appreciation on those investments less expenses.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income is recorded on the accrual basis.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses of the Plan**

Custodian related expenses are deducted from the net assets of each account each valuation day for investment management, administration, and distribution. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Investment management and operating expenses charged to the Plan for investments in mutual funds and money market funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management and operating expenses are reflected as a reduction of net appreciation (depreciation) in the fair market value of such investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Other fees incurred for administration of the Plan, such as audit fees, are reflected separately as administrative expenses on the statement of changes in net assets available for benefits.

The Plan had a revenue sharing agreement with Empower for the reimbursement of Plan expenses. Revenue earned from this agreement was used to pay Plan expenses. Any excess revenue over the Plan expenses during the year form part of the Plan assets and would be used to pay future Plan expenses. Effective January 1, 2024, the Plan terminated the revenue sharing and the Plan is now charged an annual administrative fee, collected quarterly by Empower. This administrative fee is used to pay the expenses and the remainder will be deposited in the expense account. For the year ended December 31, 2023, revenue earned from this agreement amounted to \$333. The Hospital utilized \$26 and \$15 of revenue earned to fund administrative expenses in 2024 and 2023, respectively. These amounts are reflected in administrative expenses on the statement of changes in net assets available for benefits, respectively.

**Risks and Uncertainties**

The Plan invests in various types of investment securities, including mutual funds, variable annuities, pooled separate accounts, and fixed-dollar annuity contracts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**4. Fair Value Measurements**

Accounting standards establish a framework for measuring fair value. The framework sets forth a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The levels of the fair value hierarchy are described below. Authoritative guidance on fair value measurements, Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a hierarchy of valuation methodologies based on the extent to which asset valuations are observable in the marketplace. The following describes the hierarchy of methodologies used to measure the fair value of investments:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for

Level 3 Inputs to the valuation methodology are unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used, need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**5. Plan Termination**

Although the Plan has not expressed any intent to do so, the Hospital has the right to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA and the IRC. In the event of plan termination, Plan assets will be distributed to the Plan participants. In the event of plan termination, participants would become 100% vested in their employer contributions.

**6. Tax Status**

The Plan has been designed to qualify for tax-exempt status under Section 401(k) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 401(k). The Hospital believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 401(k) of the IRC and, therefore, believes the Plan is qualified and the related (custodial) accounts (and tax-deferred annuities) are tax-exempt. Therefore, no provision for income tax has been included in the Plan's financial statements.

**7. Party-in-Interest and Related-Party Transactions**

Certain assets of the Plan, as noted in Schedule H, Line 4i are investments managed by Empower and, therefore, these qualify as party-in-interest transactions. Purchases and sales of these funds are open-market transactions at fair market value. Administrative expenses paid to Empower by the Plan amounted to \$416 and \$53 for the years ended December 31, 2024 and 2023, respectively. Notes receivable from participants also qualify as party-in-interest transactions. The total fair value of such investments managed by Empower was \$168,153 and \$159,407 at December 31, 2024 and 2023, respectively. The Plan Administrator and the Plan's counsel believe that the Plan's transactions with related parties are permitted by the U.S. Department of Labor's prohibited transaction exemptions.

**8. Subsequent Events**

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued and has determined that no other events occurred that would require recognition or disclosure in the financial statements.

Effective July 1, 2025, the Trustee under the Plan was changed to TIAA, FSB from Empower.
