NOTE 1 – DESCRIPTION OF PLAN

The following description of the Ruston Paving Co., Inc. Employees 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Ruston Paving Co., Inc. (the Plan Sponsor or the Company) who have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Participants may contribute up to 86% of their eligible base compensation subject to the maximum allowable contributions under the Internal Revenue Code. Participants may change the amount of their salary reduction contributions effective with the payroll period following the date of change.

The Company will make safe harbor matching contributions equal to 100% of participant elective deferrals up to 4% of eligible compensation. In addition, the Plan allows additional employer matching contributions. In 2024 and 2023, there were employer matching contributions of \$590,592 and \$594,378, respectively.

Discretionary profit sharing contributions may be made at the option of the Plan Sponsor. These contributions are subject to certain limitations. There were no discretionary profit sharing contributions made in 2024 or 2023.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

NOTE 1 – DESCRIPTION OF PLAN – Continued

Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching contributions and allocations of (a) the Company's profit sharing contribution and (b) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions and safe harbor matching employer contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions is based on years of continuous service. Participants are vested based on qualifying years of service as follows:

2 Years	20%
3 Years	40%
4 Years	60%
5 Years	80%
6 Years or More	100%

Notes Receivable from Participants

Active participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms of the notes may not exceed five years. The notes' interest rates are the prime rate plus 1%.

The notes are secured by the balance in the participant accounts. Participants may only have one loan outstanding at any given time. The interest rates remain fixed throughout the duration of the loans. Principal and interest are paid ratably through weekly payroll deductions.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN – Continued

Payment of Benefits

Upon termination of service due to disability or retirement, if a participant's vested account balance exceeds \$5,000, the participant must consent to a distribution. Participants may elect to receive a distribution of their vested account balance in the form of a single lump-sum payment, installments, partial payments or rollover contribution to another qualified plan or IRA. That distribution would be equal to the value of the participant's vested account balance. If the balance is not greater than \$5,000, the participant's vested balance must be distributed directly to the participant in the form of a lump sum without the participant's consent.

Upon termination of service due to death, the participant's beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, annual installments or partial payments over a period of not more than the participant's or participant's beneficiary's assumed life expectancy.

Hardship Withdrawals

Hardship withdrawals are permitted and subject to certain limitations imposed by the Internal Revenue Service and specified in the Plan Document.

Forfeitures

Upon termination, participant's non-vested account balances are forfeited. Forfeitures are retained in the Plan and may be used to reduce future employer contributions or to pay the Plan's administrative expenses. At December 31, 2024 and 2023, there were no forfeited non-vested account balances. During 2024 and 2023, no forfeiture balances were used to reduce employer contributions or to pay Plan expenses.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for discussion of fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES – Continued

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. The expenses paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Certain administrative and recordkeeping functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Subsequent Events

Management has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained certification from Ascensus Trust Company (the “trustee”) that all of the information provided by them is complete and accurate.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

NOTE 4 – FAIR VALUE MEASUREMENTS – Continued

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust: Valued at the net asset value, based on the fair values of the underlying investments reported by the trustees of the funds. Fair values for the underlying assets were based on either quoted prices in active markets or observable inputs or quotations from inactive markets.

**NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST
TRANSACTIONS**

Ascensus Trust Company is the trustee of the Plan's assets. Transactions involving participant notes receivable also qualify as party-in-interest transactions. As described in Note 2, the Company or the Plan paid certain expenses related to plan operation and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA and are exempt from prohibitive transaction rules.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

NOTE 7 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and Plan's tax counsel believe that the Plan is designed and is being operated in compliance with applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
