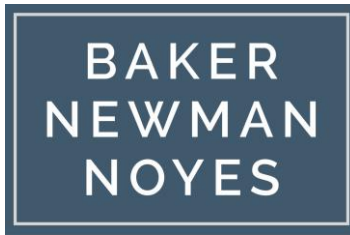

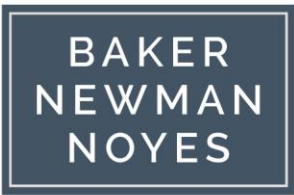

INDEPENDENT AUDITORS' REPORT

To the Finance Committee and Participants
SolutionHealth & Elliot Health System 403(b) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the SolutionHealth & Elliot Health System 403(b) Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, and schedule of delinquent participant contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following brief description of the SolutionHealth & Elliot Health System 403(b) Savings Plan (the Plan) provides only general information. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Participants should refer to the Plan document for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

General

The Plan, established on July 1, 2000, is a defined contribution plan qualified under Section 403(b) of the U.S. Internal Revenue Code (IRC) covering all employees of participating affiliates under SolutionHealth, Inc. and Elliot Health System (the System), as defined in the Plan.

During 2018, the board of the System, accompanied by the board of Southern New Hampshire Health System (SNHHS), approved an affiliation agreement between the organizations. The sole corporate member of the System became SolutionHealth, Inc. There was no impact to the Plan as a result of this affiliation.

During 2022, the board of the System, accompanied by the board of Home Health and Hospice Care (HHHC), approved an affiliation agreement between the organizations where SolutionHealth, Inc. became the sole corporate member of HHHC. Effective July 1, 2022, the Plan was amended to allow for crediting of service hours and vesting status for participants who transfer between the Southern New Hampshire Medical Center 401(a) Retirement Savings Plan or the Home Health and Hospice Care Employer Sponsored 403(b) Plan. During 2023, account balances totaling \$14,141,752 and notes receivable totaling \$97,567 were transferred into the Plan.

Participating affiliates at December 31, 2024 and 2023 include: Elliot Hospital, Elliot Physician Network, Elliot Professional Services, VNA Home Health & Hospice Services, VNA of Manchester and Southern New Hampshire, VNA Personal Services, Inc. and SolutionHealth, Inc.

Effective June 1, 2022, the Plan was amended to change the name of the Plan to the SolutionHealth & Elliot Health System 403(b) Savings Plan. The Plan was formerly known as the Elliot Health System 403(b) Savings Plan.

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

1. Description of Plan (Continued)

Contributions

Each year, participants may contribute pre-tax and after-tax annual compensation up to 100% of eligible compensation up to an amount not to exceed the applicable limitations imposed by the IRC. Participants are eligible for enrollment in the Plan and to begin making contributions upon their hire date. Rollover contributions are subject to the conditions stated in the Plan and in the appropriate sections of the IRC.

The Plan allows for the System to change the employer matching contribution percentage on an annual Plan year basis. The employer matching contribution was 50% of the first 4% of compensation that a participant contributes to the Plan for the years ended December 31, 2024 and 2023.

The Plan provides a "core employer contribution" for eligible employees. Employees are eligible if they have 1,000 hours of service within the period of January 1 to December 31 and are employed on December 31. Eligible employees receive a core employer contribution of 3% of their compensation. In September 2020, the Board of Directors of the System voted to change the core employer contribution from a fixed 3% of annual employee base pay to a yearly determined amount at the discretion of the Board of Directors of the System. For the years ended December 31, 2024 and 2023, core employer contributions totaled 3% of annual employee base pay. The core employer contribution was \$10,046,119 and \$9,593,459 for the years ended December 31, 2024 and 2023, respectively.

Participants are eligible for the matching and core employer contributions upon completion of six months of credited service and enter the Plan on the first day of the month coincident with or immediately following meeting the eligibility requirements of the Plan for matching contributions.

If a participant transfers from the SolutionHealth & Elliot Health System 401(k) Savings Plan to this Plan, the participant's pay with the System for the part of the Plan year that the participant participated in the SolutionHealth & Elliot Health System 401(k) Savings Plan will be counted for purposes of core contributions.

Upon enrollment, participants may direct their contributions to any of the Plan's fund options. Participants may change their investment options daily.

Vesting

Participants are immediately vested in their contributions and the System's employer matching contributions, including the related investment earnings or losses. For the core employer contributions, there is a five year graded vesting schedule. For participants that joined the Plan prior to October 1, 2013, the following five-year graded vesting schedule is used for core contributions: 0% after one year, 25% after two years, 50% after three years, 75% after four years and 100% after five years. For participants that joined the Plan after October 1, 2013, the following five-year graded vesting schedule is used for core employer contributions: 0% less than one year, 20% after one year, 40% after two years, 60% after three years, 80% after four years and 100% after five years.

Participant Accounts

Each participant's account is credited with the participant's contributions, the System's contributions and an allocation of Plan earnings or losses. The benefit to which a participant is entitled is the vested portion from the participant's account.

Notes Receivable From Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000, or 50% of their account balance. Repayment terms range from 1-5 years or longer for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined quarterly by the Plan Administrator. The notes bear interest at rates that range from 3.25% to 9.50% at December 31, 2024, with various maturities through October 2038. Principal and interest is paid ratably through bi-weekly payroll deductions.

Forfeitures

Forfeitures of amounts attributable to the nonvested portion of employer contributions may be used to pay Plan expenses or reduce future employer contributions. During 2024 and 2023, forfeitures and related income totaled \$797,157 and \$465,811, respectively. In 2024 and 2023, forfeitures of \$584,692 and \$450,338, respectively, were used to reduce employer contributions. The unallocated forfeiture balance was \$644,495 and \$432,030 as of December 31, 2024 and 2023, respectively.

Participant Withdrawals

The Plan provides for participants to withdraw their funds at any time after reaching normal retirement age (65). Such withdrawals are based on the amount in the participant's vested account at retirement date. The Plan also provides for withdrawal in the event of death, disability, hardship or termination. Participants may also receive a distribution of all or any portion of vested accounts upon attainment of age 59 1/2 while still employed at the System.

Plan Termination

Although it has not expressed any intent to do so, the System has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, the custodian, once notified by the System of the termination date, will distribute to each participant their account balance on that date in accordance with the terms of the Plan. In the event of Plan termination, participants will become 100% vested in their accounts.

Administrative Expenses

The System pays certain expenses incurred in the administration of the Plan.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are stated at contract value). See Note 7 for further discussion of fair value measurements. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments are recorded when paid.

Contributions

Participant contributions are recorded in the period in which payroll deductions are made. Employer matching contributions are recorded in the period in which the related participant contributions are withheld. Core employer contributions are recorded effective December 31 during the 2024 and 2023 Plan years.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Reclassifications

Certain 2023 amounts have been reclassified to permit comparison with the 2024 financial statements presentation format.

Subsequent Events

Events occurring after the statements of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through October 9, 2025 which is the date the financial statements were available to be issued.

On July 14, 2025, SolutionHealth, Inc., SNHHS and the System filed a joint Notice to the Director of Charitable Trusts in connection with SNHHS's and the System's proposed withdrawal from and dissolution of SolutionHealth, Inc. As of the date of these financial statements, the proposed dissolution is still under review. There is expected to be no impact on the Plan as a result of this dissolution.

3. Information Certified by the Custodians

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by Empower Annuity Insurance Company of America (Empower) and Empower Trust Company, LLC (Empower Trust) as of and for the years ended December 31, 2024 and 2023, except for comparing such information certified by the custodians to information included in the Plan's financial statements and supplemental schedules. The Plan Administrator has determined that the Custodians meet the requirements of a qualified institution defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan's investments (except for other investments carried at \$81,585 at December 31, 2024 and 2023), notes receivable from participants, related income and transactions, including net appreciation in fair value of investments, were certified by Empower and Empower Trust. The Plan's other investments and related income were subjected to auditing procedures.

4. Investments

The Plan's group annuity contract, Empower Select Guaranteed Fund, is backed by the general assets of Empower and meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value and withdrawals are permitted at any time. The occurrence of an event outside the normal operations of the Plan which would limit the Fund's ability to transact at contract value is not considered probable. There is no reserve against contract value for credit risk of the contract issuer or otherwise. The interest rate is reset each quarter for new deposits received and is guaranteed for the remainder of the current calendar year. A renewal interest rate is then established each subsequent calendar year and is guaranteed for one calendar year.

5. Tax Status

The Plan has adopted a nonstandardized preapproved plan sponsored by Empower Retirement LLC. The nonstandardized preapproved plan has received a favorable opinion letter from the IRC dated November 14, 2022 which stated that the Plan, as then designed, was qualified under Section 401(a) of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

The Plan was amended since receiving the opinion letter, however, the Plan Administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes the Plan is qualified and tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

6. Party-in-Interest Transactions

The Plan invested in the Empower Select Guaranteed Fund issued by Empower, which provides recordkeeping services for the Plan for the years ended December 31, 2024 and 2023. Certain Plan investments are also issued through Brighthouse and Transamerica, who are custodians for certain Plan assets. Therefore, transactions with these parties qualify as party-in-interest; however, they are exempt from the prohibited transaction rules under ERISA.

Certain direct expenses charged to the Plan and paid to the custodians during 2024 and 2023 totaled \$693,815 and \$514,873, respectively. Certain fees incurred by the Plan are paid through revenue sharing, rather than direct payments. Notes receivable from Plan participant, and the related interest income and transactions, are also considered party-in-interest transactions.

7. Fair Value Measurements

Fair value is the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023. There have been no changes to the methodologies used for the years ended December 31, 2024 and 2023.

Mutual funds: Valued at the quoted net asset value of shares held by the Plan at year end which are traded in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's assets carried at fair value consist exclusively of level 1 mutual funds totaling \$456,017,822 and \$385,068,541 at December 31, 2024 and 2023, respectively.

8. **Reconciliation of the Financial Statements to Form 5500**

Form 5500 reports participant loans as investments. For financial statement purposes, participant loans are treated as notes receivable.

9. **Delinquent Contributions**

Due to a payroll system conversion in 2023, the System was late remitting contributions for one pay period in the amount of \$8,281. The lost earnings related to the contributions are not material to the financial statements. The System evaluated the amount of lost earnings to be remitted to the Plan, which were insignificant, and corrected in 2024.
