Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

General

The Finger Companies 401(k) Plan (the Plan) is a defined contribution plan established on January 1, 1999 for employees of FEMCO, Inc. dba The Finger Companies (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The following description of the Plan provides only general information and is as of December 31, 2024, unless otherwise noted. Participants should refer to the Summary Plan Description or the Adoption Agreement, including amendments thereto, for a complete description of the Plan's provisions.

Administration

The Company serves as the Plan Sponsor and Plan Administrator of the Plan. The Plan Administrator is responsible for the oversight of the Plan. The Plan Advisory Committee (the Committee), which includes key members of the Company's management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's management. The Plan was amended and restated effective July 15, 2022. Nationwide Trust Company, FSB and Nationwide Life Insurance Company serve as Trustee and Custodian, respectively, of the Plan. The custodian holds all of the Plan's assets and executes all of the Plan's transactions. SS&C serves as the Plan's recordkeeper, processing participant transactions. Alliance Benefit Group (ABG) is the Plan's third-party administrator and one of ABG's related parties serves as the investment advisor.

Eligibility

All employees of the Plan Sponsor are eligible to participate in the Plan on the first of the month coincident with or next following the completion of 60 days of service.

Contributions to the Plan

Each year, participants may make salary deferral contributions of up to 100% of pretax annual compensation, as defined in the Plan agreement, and subject to Internal Revenue Code (IRC) regulations. Participants who have attained age 50 before the end of the year are also eligible to make a catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan includes a provision whereby all newly eligible employees are automatically enrolled in the Plan at a contribution rate of 3% of compensation unless they opt out. Auto-enrollment contributions are invested in a designated fund until changed by the participant. The deferral rate for all active participants is automatically increased by 1% each year up to a maximum of 10% of compensation, unless they opt out. Such increases will take effect as of the first day of each Plan year. Participants may change their contribution rates as of the first day of any calendar month or may suspend contributions at any time.

The Company may elect to make discretionary matching and profit-sharing contributions to the Plan. The Company made matching contributions equal to 50% of each employee's elective deferrals, including any catch-up contributions, subject to a maximum deferral of 5% of the employee's annual compensation. Accordingly, the Company's maximum matching contribution for any employee did not exceed 2.5% of that employee's annual compensation. No profit-sharing contributions were made during the year ended December 31, 2024. Total discretionary matching contributions for 2024 were \$149,035.

Participants direct the investment of both their individual contributions plus their share of employer contributions into the various investment options offered by the Plan. The Company's contributions are allocated in the same manner as that of the participant's elective contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with or reduced by the participant's contributions, the allocation of the Company's contributions, Plan earnings and administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the balance of his or her vested account.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, but not more than \$50,000 nor less than \$1,000, subject to certain Department of Labor and IRS requirements. Loan terms range from one to five years, or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the local prevailing rates as determined by the Committee. Principal and interest are paid through payroll deductions.

Distribution of Benefits

On termination of service, participants with vested account balances of \$5,000 or less are subject to involuntary cash-outs, in which automatic distribution of their account balance will occur without direct consent unless they elect a rollover. Participants whose vested account balances exceed \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments as indicated in the Plan agreement. The method of distribution is subject to the Committee's approval. Additionally, they may also elect to defer the distribution of their plan balance. Participants who elect to have their benefit payments deferred continue to share in allocations of investment income and losses, but do not share in subsequent allocations of employer contributions. Special rules apply to distributions due to death, disability and retirement. Participants should refer to the full plan document for details.

The Plan allows for in-service distributions upon attainment of age 59 1/2 for all deferral contributions, discretionary employer matching contributions, and rollover contributions for any reason. The Plan also allows for in-service distributions prior to attainment of the Plan's normal retirement age due to financial hardship, as defined in the plan document, from vested account balances.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contribution accounts, plus actual earnings thereon, is based on years of credited service. Vesting is based on a graded scale with a participant becoming 100% vested after 6 years of credited service. Participants also become 100% vested upon death, disability, or attainment of normal retirement age.

Forfeited Accounts

Forfeited balances may be used to reduce future Company contributions. During the year ended December 31, 2024, employer contributions were reduced by \$83,084 from forfeited non-vested accounts. At December 31, 2024 and 2023, the balance in the forfeiture account was \$5,334 and \$35,134, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting. Income from investments is recorded when it is earned. Expenses are recorded in the accounting period in which they are incurred.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All expenses related to the administration of the Plan, including, but not limited to, legal, accounting and Trustee fees, shall be paid by the Company or shall be paid from Plan assets. Operating expenses paid by the Company are excluded from these financial statements. The administrative expenses reflected in the financial statements include loan and withdrawal fees as well as administrative and management fees paid to the Trustee, Custodian, and third-party administrator. Investment related expenses are included in the net appreciation in fair value of the respective investment.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 7, 2025, which is the date the financial statements were available to be issued.

Note 3 - Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by the Trustee and Custodian as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
2. All investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
3. All investment-related information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.
4. Notes receivable from participants as of December 31, 2024 and 2023 and the related income on notes receivable from participant for the year ended December 31, 2024.

Note 4 - Fair Value Measurements

GAAP provides a framework for measuring fair value by providing a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Trust Mutual Funds Held in Omnibus Account: The Trustee has ownership interest in mutual funds that are held within an Omnibus Account (Trust Mutual Funds). The Plan has an ownership interest in the Trust Mutual Funds. The Trustee values the Trust Mutual Funds daily based on the quoted net asset values of the underlying mutual funds at the end of each day, adjusted for the investment option's asset fees. Due to the valuation process, Plan management believes that these investments are Level 2.

The method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Investment Contract with Insurance Company

The Plan has entered into a fully benefit-responsive investment contract with Nationwide Life Insurance Company totaling \$3,340,070 and \$2,077,211 as of December 31, 2024 and 2023, respectively. The Custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value, as reported to the Plan by the Custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract's crediting interest rate is based on a formula that takes into consideration the timing of cash flow activity, overall market interest rates, the reinvestment of maturing proceeds and the impact of credit losses and impairments. Such interest rates are reviewed and reset at least quarterly by the Custodian.

The Plan's ability to receive amounts due is dependent on the Custodian's ability to meet its financial obligations. The Custodian's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include distributions relating to Plan termination, merger, spin-offs, early retirement incentives, etc. Such events could result in payouts that differ from contract value. The Plan Administrator does not believe that an occurrence of any events that would limit the Plan's ability to transact at contract value with participants is probable.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the Trustee or Custodian; therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Fees incurred by the Plan for investment management services are included in the net appreciation or depreciation in fair value of the respective investment. These transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 - Plan Amendment and Tax Status

The Plan has adopted the Alliance Benefit Group Volume Submitter Defined Contribution Plan (the Volume Submitter Plan). On June 30, 2020, the Volume Submitter Plan received an advisory letter from the Internal Revenue Service (IRS) which stated that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the advisory letter, the Committee believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Committee believes that the Plan was qualified, and the related trust is tax-exempt.

The Plan permitted provisions of SECURE Act 2.0 during the year ended December 31, 2023 and 2024. Written amendments to the Plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities which are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
