INDEPENDENT AUDITORS' REPORT

To the Administrator and Participants of the
Systra USA, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Systra USA, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Systra USA, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following brief description of the Systra USA, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a participant-directed defined contribution plan, which was originally established on June 22, 1990, covering all eligible employees, as defined, of Systra USA, Inc. which is the common parent to Systra Consulting, Inc. and Systra Engineering, Inc. (collectively, the “Company”). The Plan was restated effective July 12, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). During 2023 John Hancock Trust Company LLC. (“John Hancock” or “Trustee”) became the Plan’s trustee. Prior to July 12, 2023, Newport Trust Company (“Newport” or “Prior Trustee” was the Plan’s trustee.

Eligibility – Any employee of the Company will be eligible to participate in the Plan on the first day of employment and attaining the age of 18.

Contributions – Each year, participants may contribute up to the maximum percentage of eligible compensation allowable under the Internal Revenue Code (“IRC”). Participants in the Plan may elect to make contributions, through payroll deductions, up to 100% of their compensation. In accordance with Internal Revenue Service (“IRS”) guidelines, participants could not make contributions exceeding \$23,000 for 2024. Eligible employees may make an additional employee contribution known as a “catch-up” contribution in accordance with the Economic Growth and Tax Reconciliation Relief Act of 2001 (“EGTRRA”). Catch-up contributions were limited to \$7,500 for 2024.

The Company contributes to the Plan, on behalf of each participant, an amount equal to 100% of the first 3% and 50% of the next 2% of base compensation that a participant contributes to the Plan (“safe harbor contributions”). The Company may also make Nonelective Employer Contributions (“NEC’s”) at its sole discretion, within the limits of the IRC. For the year ended December 31, 2024 the Company’s safe harbor contributions totaled \$533,900. The Company did not make any NEC’s in 2024.

Rollovers – Rollover contributions are permitted into the Plan in accordance with IRS regulations and Plan provisions.

Participant Accounts – A separate account is maintained for each participant. Each participant’s account is credited with his or her contribution, the Company’s contribution and an allocation of Plan earnings or losses. Allocations of earnings or losses are based upon the investment performance of the individual funds in which each participant’s account balance is invested. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. No participant may have more than two loans outstanding at any time and refinancing is only allowed once in a twelve-month period. The loans are collateralized by the balance in the participants’ account and bear interest at a rate commensurate with local prevailing rates. Loan terms generally range from one to five years. Notes receivable outstanding at December 31, 2024, have interest rates range from 4.25% to 9.50%, and mature on various dates through June 2029, as determined by the Trustee of the Plan. Principal and interest are paid ratably through payroll deductions.

1. DESCRIPTION OF THE PLAN (continued)

Investment Options – Upon enrollment in the Plan, a participant may direct contributions to a variety of investment options. Participants may change their investment options during any business day.

Vesting – Participants are fully vested in their personal contributions, safe harbor contributions, and related account earnings or losses immediately upon enrollment in the Plan. Effective January 1, 2019, non-safe harbor matching contributions ceased, and the account was frozen. Participants with balances in the account will continue to vest as follows:

Withdrawals and Benefit Payments – Participants still employed may withdraw all or part of their vested account balance upon furnishing proof of financial hardship. However, this cannot be done more than once in any Plan year. To withdraw balances from an account, a participant must provide written notice to the Company. Upon termination of employment, at the request of the participant, the entire vested amount of the participant's account will be determined and distributed as soon as administratively feasible.

Participants become fully vested in the event of disability or death. Form and time of payment and the beneficiary of such payments depend on Plan provisions.

Upon retirement, the full value of the participant's account balance is payable at the normal retirement date. The normal retirement age under this Plan is the attainment of age 65. The normal retirement date is the date the participant attains the normal retirement age.

Forfeitures – Forfeitures of nonvested employer contributions (matching and discretionary NEC) may be used to reduce subsequent employer contributions. For the year ended December 31, 2024, \$278,148 of forfeitures were utilized to reduce employer contributions. At December 31, 2024 and 2023, unallocated forfeitures totaled \$381 and \$214,778 respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Valuation of Investments and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for description of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Payment of Benefits – Benefit payments to participants are recorded when paid.

Excess Matching Contributions – During the year ended December 31, 2024, the Company made excess matching contributions to certain active participants totaling \$2,493. The payments are included in 2024 employer's contribution and will be returned to the Plan in 2025.

3. INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

The Plan administrator has elected the method of compliance by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Trustee, except for comparing such information certified by the Trustees with information included in the Plan's financial statements and supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 — Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust: The Plan invests in the T Rowe Price Stable Value Fund ("Stable Value") a stable value common collective trust fund. The Plan's interest in Stable Value is valued at the NAV practical expedient of the underlying investments reported by the issuer of the common collective trust at year-end. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from reported NAV. Securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the Plan year. Participant transactions (purchases and sales) may occur daily.

5. RISK AND UNCERTAINTIES

The Plan invests in various investment securities including mutual funds and common/collective trusts. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by the opportunity to diversify investments across multiple participant-directed fund elections including active and passively managed funds covering multiple asset classes. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

6. FEDERAL INCOME TAX STATUS

The Plan adopted a prototype non-standardized profit sharing, money purchase, cash or deferral arrangement plan, which received a favorable opinion letter from the IRS on June 30, 2020, which states that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) of disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

A party-in-interest is defined under Department of Labor ("DOL") regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 2, certain fees are paid from the Plan's assets and therefore qualify as party-in-interest transactions. For the year ended December 31, 2024 the Plan incurred administrative fees totaling \$64,050 for investment advisor and recordkeeping services provided by John Hancock and PNC Asset Management. Loans to participants are secured by the balances in the respective participant accounts. These transactions qualify as party-in-interest transaction and are exempt from the prohibited transaction rules.

8. PLAN TERMINATION

Although the Company has not expressed any intention to do so, the Company reserves the rights to modify, suspend, amend or terminate the Plan in whole or in part at any time subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the employer contribution accounts of all participants become fully vested.

9. PROHIBITED TRANSACTIONS

During the Plan year ended December 31, 2023, and 2022 the Company was delinquent in remitting to the Plan certain employee contributions totaling \$314,374 and \$606,827, respectively, within the time period prescribed by the DOL's regulations. Delays in remitting contributions to the Plan were due to administrative errors. The Company will compute lost earnings on December 31, 2023 and 2022 deposits and will make a contribution for the lost earnings to the Plan. The Plan sponsor takes full responsibility for any penalties and other potential issues associated with such untimely remittances.

10. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0. The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. The Plan administrator adopted some of the optional provisions for 2024, which did not have a material impact to the Plan's 2024 financial statements.

11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued. Based upon this evaluation, the Plan has determined that no additional subsequent events have occurred which would require disclosure in or adjustment to the financial statements.

12. RECONCILIATION TO FORM 5500

No material differences exist between the financial statements and Form 5500.
