Notes to Financial Statements

NOTE 1 - Description of the Plan

The following description of the Central Carolina Air Conditioning Co., LLC (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined-contribution plan covering all full-time employees of the Company who have two months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan sponsor determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Plan Amendments - Effective January 1, 2024, the Plan was amended and restated onto the Transamerica Retirement Solutions, LLC Preapproved 401(k) Profit Sharing Plan document, at which time substantially all Plan assets were transferred from American Trust Custody (the former custodian) to Transamerica. On January 1, 2024, the Company amended the Plan to expand the list of expenses which qualify for a hardship distribution. Hardship conditions now include residential casualty losses and expenses and losses (including loss of income) on account of a disaster if the participant’s principal residence or place of employment is located in a FEMA designated area. As of that date, eligibility conditions for participation are met once the employee reaches age 21 and has completed two months of service (previously one year or 1000 hours). Eligibility conditions for purposes of matching contributions remain attainment of age 21 and completion of one year of service.

Participant Accounts - Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the safe harbor Company-match-contribution portion of their accounts plus actual earnings thereon. Any discretionary matching or other employer contribution vests on a six-year graded schedule. A participant is 100 percent vested if while employed with Central Carolina Air Conditioning Co., LLC, the employee dies, becomes disabled or reaches early retirement age.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000. The loans are secured by the balance in the participant’s account and bear interest at a rate of prime plus 1% as determined on the first business day of the month before the loans originated by the Plan Administrator, and range from 4.25% - 9.50%. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits – Upon termination of service due to death, disability, retirement or separation, a participant may elect to receive a lump-sum payment. In-service distributions may be made to participants who have reached 59 1/2 years of age. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Forfeited Accounts – Forfeitures from non-vested participant accounts may be used to offset future Company contributions or pay administrative expenses. During the years ended December 31, 2024 and 2023, no forfeitures were used for such purposes. Forfeited non-vested accounts totaled \$337 and \$8 at December 31, 2024 and 2023, respectively.

Contributions - Each year, participants may contribute a portion of pre-tax annual compensation or after-tax annual compensation subject to a maximum amount as provided by the Secretary of the Treasury. Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered through the Plan. The Company contributes a matching deferral equal to 100% of the participant's salary deferral that does not exceed 3%, plus 50% of salary deferrals between 3% and 5%. The employer may make a discretionary profit-sharing contribution to be allocated to each eligible participant. No profit-sharing contributions were made for the years ended December 31, 2024 and 2023.

NOTE 2 - Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures. Actual results could differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable - Amounts payable to participants as of the end of the plan year for contributions in excess of amounts allowed by the IRS and not repaid by March 15 following the plan year end are recorded as a liability with a corresponding reduction to contributions. The plan distributed excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

NOTE 2 - Summary of Accounting Policies (Continued)

Investment Valuation and Income Recognition – The Plan's investments are stated at fair-value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 6 for discussion of investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan sponsor and are not included in the accompanying financial statements. Fees related to the administration of notes receivables from participants and participant withdrawals are charged directly to the participant's account and are included in administrative expenses. Expenses not paid by the Plan Sponsor are paid using the Plan's Assets and will generally be allocated among the accounts of all participants in the Plan. These expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocation depends on the nature of the expense itself.

NOTE 3 – Information Certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. The Plan's trustees, Transamerica Trust Company and American Trust Custody, have certified that the investments and related income reflected in the accompanying financial statements and supplemental schedule are complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4 - Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for the identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: Reported at fair value using net asset value per share (or its equivalent) as a practical expedient and not classified in the fair value hierarchy in accordance with ASC Subtopic 820-10. The fair values presented in the hierarchy tables are intended to permit reconciliation of the fair value hierarchy to the investments at fair value as presented in the Statements of Net Assets Available for Benefits.

The preceding methods may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - Tax Status

The Plan, which is a prototype, obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not the position would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – Stable Value Option Contract with Insurance Company

The Plan has entered into a traditional fully benefit-responsive stable value option contract with Transamerica Life Insurance Company, operating under the name Transamerica. Transamerica maintains the contributions in a general account ("Stable Fund"). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Group Annuity Contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

NOTE 6 – Stable Value Option Contract with Insurance Company (Continued)

The Stable Value Option investment choices in the Group Annuity Contract meet the criteria to be considered fully benefit-responsive and thus are reportable at contract value on the statement of net assets available for benefits. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The value of the stable value contract is guaranteed by Transamerica as a going concern. The contract value of the investment contract at December 31, 2024 was \$1,969,699. Interest is credited, based upon the daily balance at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period established January 1st and July 1st. There is no stated minimum or maximum interest rate for the Stable Value Option.

Certain events limit the Plan's ability to transact at contract value with Transamerica. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable. The Stable Value Option investment choice does not permit the insurance company to terminate the agreement prior to the scheduled maturity dates.

NOTE 7 – Administrative Expenses

Certain legal, accounting and consulting fees are paid by the Plan sponsor and are not reported as Plan contributions or expenditures.

NOTE 8 – Plan Investments

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated by \$1,148,430, as follows:

NOTE 9 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 10 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

NOTE 12 – Related-Party Transactions

Certain Plan investments are common collective trusts sponsored by Transamerica Trust Company. These common collective trusts invest a portion of their assets into a general stable value product, also sponsored by Transamerica. The Common Collective Trusts may invest in other funds managed by Transamerica Trust Company, or its affiliates, and from which revenues are received.

The Plan's previous custodian, American Trust Custody, managed certain Plan investments, including shares of mutual funds. The Plan received revenue sharing payments from mutual service providers, which were used to offset fees paid by the Plan. Fees in excess of the revenue sharing credits were allocated to participants and expensed.

Transamerica and American Trust Custody provide certain services to the Plan. All party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
