Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the K.B.C. Group, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

Note 1. Plan Description

The following description of the K.B.C. Group, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan sponsored by K.B.C. Group, Inc. and Subsidiaries (collectively, the Company). Eligible employees of the Company can make salary deferral contributions upon completion of six months of service and after attaining 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code provisions.

Contributions and investment options: Each year, participants may contribute a stated percentage of pretax annual compensation that does not exceed the maximum contribution allowed by federal law. The Plan provides an automatic enrollment at 6% of eligible compensation with an automatic increase of 1% annually up to 10% of eligible compensation for all eligible employees. Employees may elect a different percentage or elect not to make any elective deferral contributions. The Company may make discretionary matching contributions annually. During the year ended December 31, 2024, the Company matched 50% of the first 6% of the participant's eligible compensation that a participant contributed to the Plan. The Company may also make a discretionary profit-sharing contribution to the Plan. No such contribution was made during the year ended December 31, 2024. Participants also may contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants direct the investment of both their contributions and employer contributions into various investment options offered by the Plan. Participants may currently invest their contributions into a variety of mutual funds, pooled separate accounts and common collective trust funds.

Participant accounts: Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution and allocations of: (a) discretionary profit-sharing contribution, and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions plus earnings thereon is based on continuous years of service. A participant vests 20% after two years of service with at least 1,000 hours of service and continue to vest at the rate of 20% for each successive year and is 100% vested after six years of credited service.

Payment of benefits: Upon termination of service, death, disability, retirement or reaching age 59½, participants may elect to receive a lump-sum amount equal to the value of his or her account. Participants with an account balance less than \$5,000 may roll the amount into another qualified plan or receive a mandatory lump-sum distribution upon termination of service. Employees, regardless of age, who have a financial hardship, may request a lump-sum withdrawal from their 401(k) elective deferral account, subject to limitations as defined.

Forfeited accounts: Forfeited balances of terminated participants' nonvested accounts are used to pay plan expenses and to reduce future Company contributions. At December 31, 2024 and 2023, forfeitures available totaled approximately \$2,400 and \$300, respectively. During the year ended December 31, 2024, forfeitures used to reduce employer contributions totaled approximately \$38,300.

Notes to Financial Statements

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a maximum amount equal to the lesser of: (i) \$25,000, or (ii) 50% of their vested account balance, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. Notes receivable transactions are treated as a transfer to (from) the investment fund from (to) the notes receivable from participants fund. Terms range from one to five years. Only one loan is to be approved in a rolling 12-month period. The notes receivable are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Notes receivable outstanding at December 31, 2024, mature from May 2025 through April 2029, and bear interest at rates ranging from 4.25% to 9.50%. Notes receivable outstanding at December 31, 2023, bore interest at rates ranging from 4.25% to 9.50%.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Accounting estimates and assumptions: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Payment of benefits: Benefits are recorded when paid.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued. No other events requiring recognition or disclosure occurred.

Note 3. Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such employee or officer receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan. Fees paid by the Plan to the trustee totaled \$81,654 for the year ended December 31, 2024.

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company also certified to the completeness and accuracy of \$2,409,722 of net appreciation in fair value of investments (including investments bought, sold and held during the year), \$60,767 of dividend income and \$10,696 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 5. Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party Transactions

Certain Plan investments are shares of the common collective trust funds and pooled separate accounts are managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company. These transactions qualify as party-in-interest transactions.

Note 8. Risk and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) requires the use of valuation techniques that are consistent with market approach, the income approach and/or the cost approach. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. In that regard, the Topic establishes a fair value hierarchy for valuation inputs that give the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.
- Level 3:** Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

There have been no changes in valuation methodologies at December 31, 2024, compared to December 31, 2023.

Mutual funds: Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

Pooled separate accounts: The net asset value is used as a practical expedient to determine fair value for all pooled separate accounts. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Each pooled separate account provides for redemptions by the Plan at the net asset value per share, with little to no advance notice requirement.

Common collective trust funds: Common collective trust funds are composed of investment contracts that are valued at the net asset value of units of the common collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transaction (purchases and sales) may occur immediately. If the Plan initiates a full redemption of the collective trust, no notice to the issuer is required.
