Redbarn Pet Products 401(k) Profit Sharing Plan Notes to Financial Statements

1. DESCRIPTION OF PLAN

The following brief description of Redbarn Pet Products 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 2001 and most recently amended and restated January 1, 2022, is a defined contribution plan established by Redbarn Pet Products, LLC (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. Employees that have attained age 21 and completed 1,000 hours in a 12-month period are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may contribute a certain amount of their annual compensation as defined in the Plan through salary deferral payroll deductions. Participants who have attained age 50 before the Plan year end are also eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or an individual retirement account as rollover contributions. The Company makes Safe Harbor contributions equal to 100% of the amount that participants contribute up to 4% of plan compensation. For the year ended December 31, 2024, Safe Harbor contributions of \$274,834 were made to the Plan. In addition, the Company at its option, may make discretionary profit sharing contributions. For the year ended December 31, 2024, no profit-sharing contributions were contributed to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's Safe Harbor and discretionary contributions, any forfeitures of terminated participants' non-vested accounts as determined by the Company, and Plan earnings. Benefit payments and administrative expenses reduce participant's account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in their account.

Vesting

The participants are immediately vested in their voluntary contributions and the Company's Safe Harbor contributions, plus actual earnings thereon. Vesting in the employer discretionary contributions is based on the years of service wherein a participant works at least 1,000 hours during the year, with participants becoming 100% vested only after completing 6 years of service.

Payment of Benefits

On termination of service, the payment of benefits is made by a lump sum distribution. Under certain conditions, in-service withdrawals are allowed.

1. DESCRIPTION OF PLAN (Continued)

Forfeited Accounts

Forfeited nonvested accounts, if any, can be used to reduce future employer contributions or pay administrative expenses. At December 31, 2024 and 2023, there were balances of \$34,287 and \$33,755, respectively, in forfeited non-vested accounts. No forfeitures were used to pay employer contributions or administrative expenses during the year ended December 31, 2024.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company discretionary employer contribution portion of their account.

2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive stable value fund, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosures regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, which approximates when interest is received. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan are deducted from income earned on a daily basis and are not separately reflected. Consequently, such management fees and operating expenses are reflected as a reduction of investment return for such investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES (Continued)

Administrative Expenses

Administrative expenses are paid by both the Plan and the Company. Administrative expenses paid for by the Plan amounted to \$4,321 for the plan year ended December 31, 2024. In addition, certain investment related expenses have been offset with net investment income and are not readily determinable.

Payment of Benefits

Benefits are recorded when paid or upon distribution.

3. FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN

Certain information related to investments from participants disclosed in the accompanying financial statements and supplemental schedule, which includes investments at December 31, 2024 and 2023, net appreciation in fair value of investments for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Transamerica Life Insurance Company, Inc. (Transamerica), the custodian of the Plan, in accordance with Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures (ASC 820), establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under ASC 820 with the related inputs to the valuation methodology are described as follows:

Level 1 - Quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access.

Level 2 - Significant other observable (directly or indirectly) inputs, including quoted prices for similar assets in active markets or in inactive markets and other market observable inputs such as interest rate, credit risks, etc.

Level 3 - Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

4. FAIR VALUE MEASUREMENTS (Continued)

At December 31, 2024 and 2023, the Plan did not have any investments that fall under the above fair value hierarchy and required leveling.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts

The Plan's investment in pooled separate accounts measured at fair value are based on the valuation methodology that pooled separate accounts are valued at the unit net asset value as reported by the insurance company, based on the market value of the underlying investments of the accounts. The net asset value (NAV) is used as a practical expedient to estimate fair value. The pooled separate accounts have no unfunded commitments, have daily redemption frequency and the redemption notice period is daily.

5. STABLE VALUE OPTION

The Plan's investment in the stable value option with Transamerica is a fully benefit-responsive traditional investment contract that is reported at contract value. Contract value is the relevant measure for a fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The value of the option is comprised of contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The average yield and credit rates earned for the years ended December 31, 2024 and 2023 was 1.65% and 1.25%, respectively.

Transamerica is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a semi-annual basis for resetting.

The Plan's ability to receive amounts due from the fund is dependent on Transamerica's ability to meet its financial obligations. Transamerica's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Transamerica. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(k) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
- Premature termination of the contract
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Transamerica and that also would limit the ability of the Plan to transact at contract value with the fund.

6. PARTY-IN-INTEREST TRANSACTIONS

The Company, absorbs certain administrative expenses of the Plan. Certain plan investments are managed by Transamerica. Transamerica is the custodian of the Plan. These transactions qualify as allowable party-in-interest transactions for which there are statutory exemptions.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. TAX STATUS

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, stating that the written form of the underlying pre-approved plan is qualified under section 401(a) of the IRC, and that any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

GAAP requires the plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan takes an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. SUBSEQUENT EVENTS

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
