Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of New Hope Treatment Centers 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of Plan

The following description of New Hope Treatment Centers 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of New Hope Treatment Centers, LLC, Carolina Choice, LLC, New Hope Carolinas II and New Hope Carolinas, Inc. (collectively known as “the Companies”). Union employees and employees who are non-resident aliens are not permitted to participate in the Plan. The Plan Sponsor is New Hope Treatment Centers, LLC. The Plan began on December 15, 1991 and is subject to the provisions of the Employee Retirement Income Act of 1974 (“ERISA”).

The Plan was restated effective July 8, 2021 in accordance with the Cycle 3 restatement adoption period established by the Internal Revenue Service for preapproved plans. On December 7, 2022, the Plan was amended to conform to law changes governing hardship distributions. This amendment was retroactively effective to January 1, 2020 and removed the stipulation that participants had to stop making deferral contributions into the plan for six months after receiving a hardship distribution.

Eligibility

The Plan covers employees who are twenty-one or older and have completed 800 hours of service within a six-month period following date of hire or 1,000 hours of service in the plan year. Employees may enter the Plan on the first day of January or July that coincides with or next follows the date on which the eligibility requirements have been satisfied. Employees whose employment is governed by a collective bargaining agreement or who are nonresident aliens are not eligible to participate in the Plan.

Contributions

Each year, participants may contribute an elected amount of pretax annual compensation, as defined in the Plan. Additionally, participants may elect to make after-tax Roth contributions to the Plan. Participants who are age fifty or older by the end of the year are eligible to make an additional catch-up contribution to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan contains an automatic enrollment provision. Upon meeting the Plan’s eligibility requirements, participants are automatically enrolled at an initial contribution rate of 4% of pretax eligible compensation. Subsequently, there is an annual automatic increase of 1% up to a maximum of 8% implemented on the first day of the Plan year.

The Company may provide a discretionary matching contribution and an additional non-elective contribution, which may be made on a discretionary basis, dependent on the Company’s operating results at the option of the Companies' Board of Directors. The Company elected to make a discretionary matching contribution for the year ended December 31, 2024. Company contributions are invested according to the investment allocation elected by the participant. Contributions are subject to certain IRS limitations.

Investment Options

Upon enrollment in the Plan, a participant may direct the investment of contributions into various investment options offered by the Plan. Participants may change their investment options at any time. The plan currently offers various mutual funds and a money market fund as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contribution, Company contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocation of Company matching contribution is equal to a uniform percentage or dollar amount of the participant's elective deferrals each payroll period. Allocation of Company non-elective contributions are based on the participant's compensation as a percentage of total compensation of all participant's compensation eligible to share in the contribution. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company discretionary match and non-elective contributions is based on a six-year graded vesting schedule.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent of their vested account balance. Each participant is allowed one loan required to be repaid within five years. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with the prime rate published in the Wall Street Journal on the first business date of the month the loan is originated. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant (or participant's designated beneficiary in the event of death) may elect to receive a lump sum payment equal to the balance of the participant's vested account or receive installments of the participant's vested account balance over a period not to exceed the participant's life expectancy. Participants may also request hardship distributions for reasons specified in the Plan document. In-service withdrawals are also permitted for participants who have attained age 59 ½.

Notes to Financial Statements

If a participant's vested account balance does not exceed \$5,000 (including rollover contributions and earnings thereon), the Plan will automatically distribute the participant's vested account balance in a lump sum. If the participant's balance exceeds \$1,000 (including rollover contributions and earnings thereon) and the participant does not elect to receive or rollover the distribution, the Plan automatically rolls over the distribution into an IRA.

Forfeitures

Forfeiture amounts may be used to pay plan expense or to reduce the Company discretionary match/or non-elective contributions. Forfeitures generated from contributions totaled \$5,365 and \$195 in 2024 and 2023, respectively. Additionally, the forfeiture account was credited with an additional \$17,972 of fee offsets from a revenue share agreement with the plan's third-party service provider during the year ended December 31, 2024. Forfeitures were not utilized to reduce employer contributions or offset plan expenses during either plan year. Forfeitures remaining at December 31, 2024 and 2023, totaled \$53,817 and \$28,433, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

Plan management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for a discussion of fair market measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in the fair value of investments.

3. Investment Information Certified by Custodian (Unaudited)

The accompanying financial statements and supplemental schedules include the following unaudited information as of December 31, 2024 and 2023 and for the year ended December 31, 2024 that was obtained from data prepared and certified to be complete and accurate by Empower Trust Company, LLC, the custodian. Empower Trust Company, LLC holds the Plan's investment assets at year-end and executed investment transactions for the year.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Basis of Fair Value Measurement

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued at \$1 per share or cash value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes, could materially affect the amounts reported in the individual participant account statements and the statement of net assets available for benefits.

6. Related Party Transactions and Party in Interest Transactions

Empower Trust Company, LLC (“Empower”) serves as custodian of the Plan’s assets. Empower is the recordkeeper, as defined by the Plan and, therefore, the fees paid to Empower for these services qualify as party-in-interest transactions. For the plan year ended December 31, 2024, the Plan fees related to recordkeeping services and advisory services were \$40,900 and \$1,970, respectively. For the plan year ended December 31, 2023, the Plan fees related to recordkeeping services and advisory services were \$30,757 and \$1,067, respectively.

The Company pays directly any other fees related to the Plan’s operations. Additionally, the Company personnel provide certain administrative services to the Plan for which no fees are charged.

7. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

8. Income Tax Status

The Plan is a prototype plan offered by Empower Retirement, LLC. The prototype plan has received an opinion letter from the IRS dated November 14, 2022, whereby the IRS stated that the prototype plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). While the Plan cannot rely on the prototype's opinion letter, the Plan administrator believes that the Plan has been operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that it is no longer subject to income tax examinations for years prior to 2021.

9. Concentration of Credit Risk

At December 31, 2024 and 2023, respectively, 88.6% and 89.9% of the Plan’s investment holdings were in BlackRock Funds. Such investments are subject to credit and market risk associated with (1) the credit worthiness of the investment management company, (2) the credit worthiness of underlying issuers, and (3) fluctuations in market value inherent with changes in economic conditions.

10. Prohibited Transactions – Delinquent Participant Contributions

For the Plan year ended December 31, 2024, the Company failed to remit participant deferral contributions and loan repayments totaling \$23,943 to the Plan within the time limit required by the Department of Labor, representing a nonexempt loan of funds to the Company from the Plan. These untimely remittances constitute prohibited transactions between the Company and the Plan. All but \$119 of the \$23,943 were remitted to the Plan prior to December 31, 2024. The Company is currently working with the Plan’s third-party service provider to correct the 2024 delinquencies by filing a Form 5330 for the late remittances and remitting lost earnings to the Plan. Plan management does not believe that the resolution and correction of this matter will have a negative impact on the Plan’s qualified tax status.
