## 1. Description of Plan

The following brief description of the Weisser Distributing, Inc. 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, eligibility requirements, and other matters.

### **General**

The Plan is a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and the Internal Revenue Code ("IRC").

### **Eligibility**

Employees of Weisser Distributing, Inc. (the "Company", "Plan Administrator", or "Plan Sponsor") are eligible to participate in the plan. Employees are eligible to participate in the Plan and make contributions and receive employer safe harbor and profit sharing elements upon reaching age 21 and completing one year of service with the Plan Sponsor. To be credited with a year of service, the employee must have provided at least 1,000 hours of service during an eligibility computation period, which is a 12-consecutive-month measuring period. However, participants will not be able to participate in the Plan if they are part of a collective bargaining agreement or a non-resident alien with no U.S income or a resident of Puerto Rico.

Participants enter the Plan on January 1 or July 1, whichever date coincides with or next follows the date on which the participant satisfies the eligibility requirements. Upon becoming a participant, the Plan Administrator will establish an account to receive the participant's share of any employer and participant contributions and related investment earnings and losses.

### **Contributions**

Participants may contribute up to 100% percent of their annual earnings to the Plan, as defined by the Plan, and as limited by the IRC. Participants may roll over amounts representing distributions from other qualified plans into the Plan. The Plan Sponsor, at its discretion, may make a profit sharing contribution to the Plan, and is required to make an annual safe harbor contribution of 3% based on compensation as defined by the Plan document. No profit sharing contribution was made for 2024. The safe harbor contribution for 2024 totaled approximately \$110,000.

At December 31, 2024, the employer contribution receivable consists of the 2024 safe harbor contribution of approximately \$110,000. At December 31, 2023, the employer contribution receivable consists of the 2023 safe harbor contribution of \$154,000.

### **Vesting**

Participants are immediately vested in their Contributions, Rollover Contributions, Qualified Nonelective Contributions, Deferral Contributions, Safe Harbor Nonelective Employer Contributions and any earnings thereon, and vest over a period of six years for the profit sharing and safe harbor contributions.

### **Forfeited Accounts**

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance will first be used to pay administrative expenses. Any remaining amounts will be used to reduce future Employer contributions payable under the Plan. At December 31, 2024 and 2023, there was approximately \$29,500 and \$6,400, respectively, of forfeited nonvested account totals in the Plan. The Plan utilized approximately \$6,500 towards the payment of Safe harbor match during the year ended December 31, 2024.

### **Participant Accounts**

Each participant's account is credited with the participant's elective deferrals, rollover contributions, Company safe harbor contributions and allocations of profit sharing contributions, certain administrative and investment expenses, and Plan earnings, as set forth in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

## 1. Description of Plan (Continued)

### **Notes Receivable From Participants**

Participants are permitted to borrow up to 50% of their vested account balance with a minimum of \$1,000 up to a maximum loan amount of \$50,000. Only one note may be outstanding at any given time. The notes are secured by up to 50% of the participant's vested account balance. The terms require principal and interest payments to be paid with each pay period. Notes generally have a term of not more than five years, unless the note is for the purchase of a principal residence, in which case the note repayment period may not extend beyond 10 years. The interest rate on notes shall be determined by the Plan Administrator based on terms as described in the Plan document. Upon termination of employment, the outstanding balance of a note becomes immediately payable. As of December 31, 2024, outstanding notes bear interest at 9.50%.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **Payment of Benefits**

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Certain mandatory distribution provisions may apply for smaller account balances of terminated employees.

## 2. Summary of Significant Accounting Policies

### **Basis of Accounting - Accrual Method**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

### **Accounting Estimates**

Management uses estimates and assumptions in preparing these financial statements in accordance with US GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates, and those differences could be material.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation and depreciation is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments.

### **Payment of Benefits**

Benefit payments are recorded when paid.

### **Administrative Expenses**

Substantially all administrative expenses, including audit, trust and recordkeeping fees, are paid by the Plan. Certain investment transaction fees are paid by the Plan participants.

#### **Fair Value of Financial Instruments**

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

#### **Securing a Strong Retirement Act**

The plan contribution limit is set at the regulatory maximum, which increased to \$7,000 in 2024 as per updated guidance; no amendment to the plan was required for this change. The Roth contribution option was already available on the plan, so no additional updates or modifications were necessary for Roth features.

In reviewing the implementation of Secure 2.0 provisions, no new withdrawal options were added to the plan as part of recent legislative changes. Additionally, auto-portability provisions will apply starting in 2025, aligning with effective dates specified under Secure 2.0 regulations.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.

### **3. Certification of Investment Information**

At December 31, 2024, the Plan's investments were held by the Fidelity Management Trust Company (the "Trustee"). The Plan's investments were transferred to the Trustee from Capital Bank and Trust ("Prior Trustee") in September 2024. At December 31, 2023, The Plan's investments were held by the Prior Trustee. The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(c), pursuant to 29 CFR Section 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed its independent auditors not to perform, and they did not perform, any auditing procedures with respect to the following information certified by the Trustee and Prior Trustee, except for comparing the information with the related information included in the financial statements and supplemental schedule.

The Trustee and Prior Trustee certified all investments and the notes receivable from participants as shown in the Statement of Net Assets Available for Benefits at December 31, 2024 and 2023. The Trustee and Prior Trustee certified the net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

### 5. Party-In-Interest Transactions

Certain Plan investments are shares of Registered investment company mutual funds managed by the Trustee of the Plan; therefore, these are party-in-interest transactions. Fees paid by the Plan to the Trustee were approximately \$24,000 for the year ended December 31, 2024.

### 6. Tax Status

The Plan uses the Fidelity Workplace Services LLC, Non-Standardized Pre-Approved Profit Sharing Plan. The Internal Revenue Service has informed Fidelity Workplace Services LLC by letter dated June 30, 2020 that this plan document is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan's management and service provider believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the financial statements.

### 8. Plan Termination

Although the Plan has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions and the Plan assets will be distributed according to the provisions of the Plan documents.
