### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of SDI Industries, Inc. Profit Sharing and 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### **Opinion on the 2024 Financial Statements**

### **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Basis of Accounting for the 2024 Financial Statements**

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. 

### Note A

#### Description of Plan

The following description of the SDI Industries, Inc. Profit Sharing and 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan is a defined contribution plan covering substantially all employees of SDI Industries, Inc. (the "Company") who have completed thirty days of service, except for nonresident aliens and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE Act") was signed into law on December 20, 2019, and the SECURE 2.0 Act of 2022 ("SECURE 2.0") was enacted on December 29, 2022. These laws include numerous provisions impacting retirement plans, including, but not limited to, changes to the required minimum distribution age, eligibility for long-term part-time employees, automatic enrollment requirements for certain new plans, and expanded withdrawal and contribution options. The provisions of these laws become effective on various dates. The Plan is evaluating the impact of the SECURE Act and SECURE 2.0 and will implement required changes in accordance with applicable effective dates and regulatory guidance.

#### Plan Administration:

The Company is the administrator of the Plan and as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Trustee, custodial, and recordkeeping services were provided by Voya Retirement Insurance and Annuity Company (Voya).

#### Contributions:

Participants may contribute up to 100% of pretax or after tax (Roth) annual compensation, as defined in the Plan, up to the maximum allowed by law. The maximum allowed deferral amount was \$23,000 for 2024 and \$22,500 for 2023, respectively. Participants age 50 and older may also contribute an additional \$7,500 to the Plan for 2024 and 2023. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has an automatic contribution arrangement with an initial contribution of 1% of participant compensation and an annual automatic increase of 1% until such time the automatic contribution reaches 4% of participant compensation. Participants may elect out of the automatic contribution arrangement if they do not desire to participate in the Plan.

Employer matching and non-elective profit-sharing contributions are discretionary. During the year ended December 31, 2024, the employer made matching contributions equal to 25% of the participant's contribution up to 4% of compensation. No discretionary non-elective profit sharing contributions were made for the year ended December 31, 2024.

### Note A

#### Description of Plan (Continued)

##### Participant Accounts:

Each participant's account is credited with the participant's contributions, the Company's matching contributions and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary non-elective contributions, if any, are determined using a non-safe harbor allocation method, under which each participant constitutes a separate classification and allocations are made based on the ratio of the participant's compensation to total compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Notes Receivable from Participants:

Under the terms of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 and up to an amount equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have only one outstanding loan at a time. Loans made under prior Plan provisions will remain outstanding until repaid in accordance with its terms. Loans are generally required to be repaid within five years. Repayment is extended if the loan is for the purchase of the participant's primary residence. Loans are secured by the balance in the participant's accounts and accrue interest at a rate of 2% over the prime rate (7.50% at December 31, 2024) at the issuance of the loan.

##### Vesting:

Participants are immediately vested in their contributions. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. The Plan interprets a year of service as a period of continuous employment in which a participant reaches 1,000 hours of service. Hours of service for salaried employees is determined by months worked, wherein 190 hours are credited for each month.

A participant's interest attributable to the annual Company contribution plus forfeitures shall vest as follows:

1 Year	20%
2 Years	40%
3 Years	60%
4 Years	80%
5 Years or more	100%

##### Payment of Benefits:

Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum, installment or partial payments.

### Note A

#### Description of Plan (Continued)

##### Administrative Expenses:

With the exception of forfeitures that are used to pay the Plan's expenses and a quarterly fee which is paid by the Plan sponsor, the expenses of administration of the Plan are paid from and allocated among participants' accounts.

##### Forfeited Accounts:

Forfeited accounts are used, at the Company's discretion, for the payment of the Plan's administrative expenses, to the restoration of any participant's forfeited account balance upon re-employment, or to reduce the employer contributions. At December 31, 2024 and 2023, there were \$1,436 and \$0 of non-vested forfeitures, respectively. During Plan year ended December 31, 2024, \$630 of forfeitures were used to reduce employer contributions.

### Note B

#### Significant Accounting Policies

##### Basis of Accounting:

The Plan prepares its financial statements on a modified cash basis of accounting; consequently, contributions to the Plan not yet received by the trustee are not included in net assets available for benefits, and certain expenses are recognized when disbursed by the trustee rather than when the obligation is incurred.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### Use of Estimates:

The preparation of financial statements requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### Contributions:

Participant contributions and the related Company matching contributions are recognized in the period the participant contribution is withheld from compensation.

##### Investment Valuation and Income Recognition:

The Plan's investments are reported at fair value, with the exception of the investment contract, which is stated at contract value (Note H). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

#### **Significant Accounting Policies (Continued)**

Purchases and sales of investments are recorded on a trade-date basis. Interest income and dividend income are recorded on the date received. Net appreciation (depreciation) includes the Plan's gains on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

#### **Benefit Payments:**

Benefits are recorded when paid.

### **Note C**

#### **Income Tax Status**

The Plan is a pre-approved plan of Nova 401k Associates Inc which received an opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note D**

#### **Unaudited Information Certified by the Plan Trustee**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, the trustee of the Plan.

### **Note E**

#### **Party-In-Interest and Related Party Transactions**

Certain Plan investments are interests in pooled separate accounts and a fixed account managed by Voya. Voya is trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules of ERISA.

### **Note F**

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### **Note G**

#### **Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

The Plan management has adopted the provision of ASU 2015-07 which removes the requirement to categorize within the fair value hierarchy investments for which fair values are estimated using the net asset value ("NAV") as a practical expedient.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### *Pooled separate accounts:*

Valued at the NAV of shares held by the Plan at year end. Those pooled separate accounts investing in mutual funds or domestic equity securities are measured using quoted prices in active markets for identical assets. Those pooled separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

The preceding methods described above may produce a fair value calculation that might not be indicative of current or future net realizable value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are primarily held in pooled separate accounts across a diversified range of asset classes, including global/international equity, U.S. large-cap equity, mid- and small-cap equity, specialty sector funds, fixed income, and asset allocation/target date funds.

- **Equity Funds:** These include large-cap growth, large-cap value/blend, mid-cap growth and value, small-cap, and global/international equity funds. The investment objective of these funds is generally to achieve long-term capital appreciation by investing in domestic and international equities, with certain funds seeking to track the performance of specific indices (e.g., CRSP U.S. Large Cap Growth, CRSP U.S. Mid Cap Growth, CRSP U.S. Mid Cap Value, CRSP U.S. Small Cap, and MSCI U.S. Investable Market Index Information Technology 25/50).
- **Specialty Funds:** Certain pooled separate accounts invest in specific sectors or strategies, such as health sciences, information technology, real estate securities, and vector equity portfolios, with objectives focused on long-term capital appreciation.
- **Fixed Income Funds:** The Plan holds several fixed income pooled separate accounts, including inflation-protected securities, global bond strategies, short-duration bond funds, and a total bond market index. The objectives of these funds are to provide income, preserve capital, and, in some cases, maximize total return.

#### **Fair Value Measurements (Continued)**

- Asset Allocation / Target Date Funds: The Plan offers a suite of Vanguard Target Retirement Funds (2020 through 2070, as well as an Income Fund) designed to provide capital appreciation and current income consistent with their asset allocation. These funds adjust allocations over time based on the target retirement date.

Gains and losses included in changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

### Note H

#### **Guaranteed Investment Contract with Insurance Company**

The Plan invests in a fully benefit-responsive investment contract ("Voya Fixed Account") with the Voya Retirement Insurance and Annuity Company ("Voya") (the "Issuer") and, as such, is presented at contract value in the Statement of Net Assets Available for Benefits. Contract value represents participant contributions plus credited interest, reduced by participant withdrawals and administrative expenses.

The Voya Fixed Account guarantees a minimum annual interest rate of not less than 1.00%. Credited interest is compounded daily and becomes part of principal. Contract value was \$473,428 and \$476,825 as of December 31, 2024 and 2023, respectively. The Issuer maintains contributions in its general account with no stated maturity. The account is credited with earnings and charged for withdrawals and expenses. All participant-initiated transactions (e.g., withdrawals, loans, transfers) are permitted at contract value. However, certain events such as excess withdrawals, plan termination, or sponsor-initiated transactions (e.g., layoffs, mergers, offering of competing funds) may be subject to restrictions or market value adjustments, as specified in the contract.

The contract meets the fully benefit-responsive investment contract criteria and, accordingly, is reported at contract value, which represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's ability to receive amounts due is dependent on the Issuer's ability to meet its financial obligations, which could be affected by future economic or regulatory developments. Generally, there are no events that would limit the Plan's ability to transact at contract value, except (i) transfers to competing investment options are subject to a 90-day restriction and (ii) in the case of certain large surrenders, the Issuer may pay amounts over time (not to exceed 60 months). There are no events or circumstances that would allow the Issuer to terminate the contract with the Plan and settle at an amount other than contract value.

### **Note I**

#### **Risk and Uncertainties**

The Plan invests in various investment options that are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits (modified cash basis).

### **Note J**

#### **Subsequent Events**

Effective June 1, 2025, the Plan was amended to (i) change the Company's name to Element Logic US, Inc., (ii) change the Plan's name to Element Logic US, Inc. Profit Sharing and 401(k) Plan, (iii) add ABCO Systems, LLC as a participating employer, and (iv) provide that service with ABCO Systems, LLC will be recognized for all purposes under the Plan. In addition, effective May 15, 2025, the ABCO Systems, LLC 401(k) Plan was merged into the Plan as part of this amendment and restatement.

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
