Notes to Financial Statements

**1. Description of Plan**

The following description of the 403(b) Thrift Plan of Hospice of Orange and Sullivan Counties, Inc. (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of Hospice of Orange and Sullivan Counties, Inc. (the "Sponsor" or "Employer"). An employee is eligible for participation in the Plan upon their date of hire. An employee is eligible to receive Employer contributions upon attainment of 21 years of age and completion of one year of service (twelve consecutive months and at least 1,000 hours of service). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions***

Each year, eligible employees may elect to contribute a portion of their eligible compensation to the Plan on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Employer. There is an annual dollar limit as to the amount that can be contributed on a pre-tax basis into the Plan which is determined by the Internal Revenue Code ("IRC"). Participants direct the investment of their contributions into various investment options offered by the Plan.

At the Employer's sole discretion, the Employer will make a contribution equal to 2% of eligible compensation on behalf of each eligible participant. The Employer's contribution will be made without regard to whether an employee is making participant contributions. The plan has been amended as of January 1, 2025 to eliminate this contribution for any new employees hired on or after January 1, 2025. The Plan also includes a non-discretionary employer match contribution. The Employer will match participant contributions dollar for dollar up to 3% of eligible salary.

***Vesting***

At all times, a participant is 100% vested in their contributions plus allocated earnings thereon. Vesting in any Employer contributions is as follows:

**1. Description of Plan (*continued*)**

***Forfeitures***

If a participant terminates their employment with the Employer, the non-vested contributions plus allocated earnings thereon may be used to reduce aggregate future Employer contributions or administrative expenses.

At December 31, 2024 and 2023, there were \$3,890 and \$5 in forfeitures held in non-participant directed accounts. During 2024, \$2,253 of forfeitures were used to reduce Employer contributions and none were used to reduce administrative expenses.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and an allocation of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Payment of Benefits***

Benefits are paid upon retirement, age 59 ½, death, or other termination of employment. Upon termination of service, a participant's balance will be paid in a lump-sum amount equal to the participant's account balance. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Upon termination if a participant's vested account is \$5,000 or less, the participant will receive the value of his or her account in a single lump-sum distribution.

***Expenses***

Expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

***Loans to Participants/Collateralized Assets***

A participant may elect to take out a loan subject to the rules and limitations of the Plan and the terms of the applicable contract. Defaults in loans are treated as a distribution at the time of default against the participant's account.

***Loans to Participants/Collateralized Assets (continued)***

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum of 50% of his/her vested balance or \$50,000 (whichever is less). Loans to the participant are made directly from Mutual of America Life Insurance Company ("Mutual of America"). The participant's account is not reduced by the loan amount, but serves as security for the loan; the loan amount is moved into a fixed income collateral account within the borrower's account. The loan must be repaid directly to Mutual of America within a five-year period in substantially equal payments (not less frequently than quarterly). The five-year repayment period will not apply to a loan that is used to acquire a principal residence of the borrower.

If the borrower does not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, their loan will be deemed in default.

At December 31, 2024 and 2023, total principal balances due amounted to \$99,393 and \$67,684, which also represents a collateralization of participant accounts. At December 31, 2024, these loans had an interest rate of 5.85% with maturity dates through 2029. At December 31, 2023, these loans had an interest rate of 3.25% to 4.60% with maturity dates through 2028. At December 31, 2024 and 2023, there were no defaulted loans.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2024 and 2023, the Plan's investments, that were valued at fair value, were valued using level 2 inputs.

**2. Summary of Significant Accounting Policies (continued)**

***Investment Valuation and Income Recognition***

Investments in separate accounts are reported at fair value as reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The insurance company general account is reported at contract value, which represents contributions made under the contract, plus interest credited, less benefits paid and expenses.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 9, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in value of investments and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, a qualified institution.

**4. Insurance Company General Account**

The Plan has an investment contract with Mutual of America. Amounts placed in the Mutual of America Interest Accumulation Account are credited with interest at a rate determined by Mutual of America. Mutual of America guarantees to credit interest for the life of the contract to amounts in the Interest Accumulation Account of their general account at a rate of at least equal to the greater of: (1) any contractual minimum guarantee provided by the contract; or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners ("NAIC") standard non-forfeiture law. The NAIC minimum rate is determined in accordance with a formula, and cannot be less than 1.00% or more than 3.00%. Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year.

**4. Insurance Company General Account (*continued*)**

The interest rate under that contract will not go below the contractual guaranteed minimum rate regardless of the minimum rate that is set for a calendar year. In Mutual of America's sole discretion, they may credit a higher rate of interest to a participant's contract in the general account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Mutual of America compounds interest daily on the contract amounts in the general account to produce an effective annual yield that is equal to the stated interest rate. There are no restrictions on withdrawals, and participants may withdraw their funds at any time.

The principal and previously credited interest is guaranteed by Mutual of America. This guarantee is subject to Mutual of America's financial strength and claims-paying ability. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A- as of April 2025), S&P Global Ratings (A as of June 2025), and Fitch Ratings (BBB+ as of April 2025).

The Mutual of America Interest Accumulation Account represents approximately 15% and 16% of the net assets available for benefits as of December 31, 2024 and 2023.

**5. Separate Accounts**

The Plan offers various separate accounts as investment options under the Plan. The separate accounts have different investment objectives, investment policies, and risks. The name of each separate account corresponds to the name of the underlying fund in which it invests. When contributions or transfers are made to a separate account, the separate account purchases shares in the appropriate underlying fund. The Plan's separate accounts include various asset classes which are: equity funds, fixed income funds, real estate funds, balanced funds, asset allocation funds, and retirement funds.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

**7. Tax Status**

The Plan's prototype plan document preparer has obtained an opinion letter dated March 31, 2017 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has since been amended, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**8. Party-in-Interest Transactions**

All investments of the Plan are managed by Mutual of America. Mutual of America is the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

**9. Prohibited Transactions**

During 2023, the Employer was notified that they failed to remit to the Plan certain participants' contributions totaling \$261,446, within the period prescribed by the Department of Labor regulations. During 2025, pursuant to the guidance issued by the Department of Labor, lost earnings were calculated and allocated to affected participants by the Employer.

During 2024, the Employer was notified that they failed to remit to the Plan certain participants' contributions totaling \$146, within the period prescribed by the Department of Labor regulations.

**10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
