Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rottler Pest Control Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of *Rottler Pest Control Company 401(k) Plan* (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

Created on January 1, 1996, and as amended and restated, the Plan is a defined contribution plan covering all eligible employees of Rottler Pest Control Company (the “Company”). Employees are eligible to participate in the Plan on the first day of the first month of the Plan year or the first day of the seventh month of the Plan year upon reaching the age of 21 and completion of one year of service or 1,000 hours. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and effectively adopted on January 1, 2022 to be in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The amendment had no impact to operations of the Plan.

Contributions

The Plan provides for voluntary employee contributions to the Plan up to 85% of annual eligible compensation, subject to Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows for participants to make Roth contributions on an after-tax basis. The Roth contributions act as additional voluntary employee contributions.

The Company contributes an amount equal to 100% of employee deferrals (including any catch-up deferrals) up to 3% of compensation, plus 50% of the next 2% of compensation (including any catch-up deferrals) deferred by the employee. This Company match is considered a safe-harbor contribution under IRC Section 414(s). The Company can also make non-safe harbor matches during the year. The Company’s matching contributions to the Plan were \$407,434 for the year ended December 31, 2024.

Discretionary profit-sharing contributions are determined annually by the Company. Profit sharing contributions are allocated to each participant based on a point system. Each eligible participant is awarded a point for the number of service years in the Company. There were no profit-sharing contributions for the year ended December 31, 2024.

Participants may also transfer funds to the Plan from other qualified retirement plans in the form of a rollover. Rollover contributions were \$72,958 for the year ended December 31, 2024.

Contributions are subject to certain limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, allocations of the Company’s contributions, net Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

All participants are immediately vested in their voluntary contributions and in the Company's safe-harbor matches, but have a vesting schedule for any of the Company's non-safe harbor and profit-sharing contributions as follows:

- <2 Years of service – 0%
- 2 Years of Service – 20%
- 3 Years of Service – 40%
- 4 Years of Service – 60%
- 5 Years of Service – 80%
- 6+ Year of Service – 100%

Forfeitures

Participants who terminate their employment and are less than 100% vested in their employer account will forfeit the non-vested portion. Forfeitures are retained in the Plan and used to offset administrative expenses and employer contributions.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investments with Voya Retirement Insurance and Annuity Company. The investment options comprise various degrees of risk and return. Participants may change their investment options at any time.

Payment of Benefits

Upon termination of employment, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump-sum amount or a rollover, depending on the size of the participant's account balance at the time of the termination. Participants with a vested account balance of less than \$5,000 must take a lump-sum distribution.

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are subject to specific statutory and regulatory requirements.

Normal retirement age is 65. Distributions are required starting April 1st of the calendar year after a participant reaches the age of 70-1/2 or retires.

Participant Notes Receivable

Participants who are also employees are allowed to borrow a minimum of \$1,000 up to the lesser of 50% of their vested account balances or \$50,000. The notes are secured by the balance in the participant's account and bear interest at one percentage point below the prevailing prime rate in the month the loan is processed. Notes must be repaid within 60 months unless the note is used for the purchase of a primary residence. The number of loans a participant may have outstanding at one time is one. Principal and interest are paid ratably through payroll deductions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are in units of pooled separate accounts of the Voya Retirement Insurance and Annuity Company, a party-in-interest to the Plan. The investments are valued at fair value based on the unit values of the pooled separate accounts based on the fair value of the underlying investments as reported by the Voya Retirement Insurance and Annuity Company. The investment accounts include an unallocated general insurance fund and the remainder in pooled separate accounts containing mutual funds. Unrealized gains or losses as a result of changes in fair value are recorded in income of the current period. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Some administrative and advisory costs of the Plan are paid by the Plan. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated all subsequent events through October 10, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the pooled separate accounts and the unallocated insurance company general account (both at Level 2) measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value ("NAV") of units held by the Plan at year end and are directly related to the net asset value of shares of the underlying investments.

Unallocated General Account Fund: Valued at an approximate contract value which includes a market value adjustment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value at the reporting date.

4. INVESTMENT CONTRACT WITH INSURANCE COMPANY GENERAL ACCOUNT

The Plan has entered a traditional, fully benefit-responsive insurance contract with the VOYA Retirement Insurance and Annuity Company ("VRAIC") totaling \$259,474 and \$171,669 for the years ended December 31, 2024 and 2023. VRAIC maintains the contributions in a general account. The account is credited with declared rates of interest and are subject to a minimum rate described in the contract. Amounts allocated to the Fixed Account are held in VRIAC's general account which supports insurance and annuity obligations. VRIAC's general account is managed on an aggregate basis and supports all of VRIAC's financial commitments. No portion of the general account is attributable to a particular plan nor do plans have any undivided ownership interest in general account assets.

The contract meets the fully benefit-responsive insurance contract criteria and therefore is reported at its approximate contract value which includes a market value adjustment. Approximate contract value is the relevant measure for fully benefit-responsive insurance contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Approximate contract value, as reported to the Plan by VRAIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at approximate contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at approximate contract value with the contract issuers and that also would limit the ability of the plan to transact at approximate contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from approximate contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

5. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Company has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Company has obtained certifications from Voya Retirement Insurance and Annuity Company that all the information provided by the Trustee and included in the accompanying financial statements and supplemental schedule are complete and accurate, excluding notes receivable from participants and related interest income. Information as to the investments in the accounts of the Voya Retirement Insurance and Annuity Company, related investment income, and all information appearing in the accompanying financial statements and supplemental Schedule H, are presented in reliance solely upon these certifications except for participant notes receivable and its related interest income are not certified by the Voya Retirement Insurance and Annuity Company.

6. TAX STATUS

In the Plan's latest determination letter dated June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to terminate, discontinue making contributions to amend or modify the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their total account balances.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company and Voya Financial Advisors, Inc., the Trustees of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

The Plan also receives third-party administrator services from Benefit Plans Plus, LLC, and therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants are deemed related party transactions. As of December 31, 2024 and 2023, notes receivable from participants totaled \$139,344 and \$151,927, respectively. Note receivable interest rates ranged from 2.25% to 7.50% with maturities through October 2029. Note receivable interest for the year ended December 31, 2024 was \$7,447.
