## Independent Auditor's Report

To the Plan Administrator

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Marmon Employees' Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Note 1 - Plan Description

The following description of Marmon Employees' Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering eligible employees designated by the participating employers (the "Companies"), as defined in the adoption and merger agreement. Participants are eligible to make 401(k) contributions and to receive employer safe harbor matching contributions on their employment commencement date. Participants are eligible for employer retirement contributions after six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions in whole percentages of eligible compensation, not to exceed, individually or in the aggregate, 30 percent of compensation up to the maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

There were delinquent contributions of \$358,474 and \$448,277 during the plan years ended December 31, 2024 and 2023, respectively. The Companies corrected the 2024 late contributions and remitted lost earnings during 2024. The Companies corrected the remaining 2023 late contributions and remitted all lost earnings not previously corrected in 2023 during 2024.

The participating employers' safe harbor allows for matching contributions of 100 percent of the participant's deferral contribution not in excess of the first 3 percent of participant's eligible compensation and 50 percent of the participant's deferral contribution not in excess of the following 2 percent of the participant's eligible compensation during the plan year. The Plan also provides for employer retirement contributions. The retirement contribution, if any, is discretionary as to amount and allocated based on the participant's compensation received while covered by a participating employer. The retirement contributions were approximately \$34,500,000 for 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation, deferrals transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$500 up to a maximum of 50 percent of their account balances, not to exceed \$50,000, reduced by the highest outstanding balance of notes receivable during the one-year period prior to the date the note receivable is made from the Plan, at interest rates determined in accordance with the Plan. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### **Benefit Payments**

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. The Plan also allows for age 59½ and after-tax withdrawals.

### Note 1 - Plan Description (Continued)

Participants may request that a portion of their accounts, as permitted by the Plan, be distributed in the case of severe financial hardship, as defined in the plan document.

#### ***Vesting***

Participants are immediately 100 percent vested in employee, rollover, and employer safe harbor matching contributions and any income or loss thereon. Vesting in the employer retirement contribution portion of participants' accounts, plus actual earnings thereon, is based on years of service, as defined by the plan document. Participants vest at 20 percent for each full year of service and are 100 percent vested upon completion of five years of service.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of his or her account is forfeited. Forfeitures related to employer contributions are first used to restore the accounts of eligible participants who had breaks in service of less than five years. The remaining forfeitures are used to reduce the employer contributions or to pay administrative expenses of the Plan. Unallocated forfeited account balances were approximately \$1,066,000 and 1,034,000 at December 31, 2024 and 2023, respectively. During 2024, approximately \$894,000 was used to fund employer contributions.

#### ***Plan Termination***

While the plan sponsor has not expressed any intent to terminate the Plan or to discontinue its contributions to the Plan, it may do so subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are stated at fair value.

The fair value of the Plan's interest in the Marmon Defined Contribution Master Trust (the "Master Trust") is based on the beginning of the year value of the Plan's interest in the trust plus actual contributions and allocated investment income (loss) less actual distributions and allocated administrative expenses.

The common collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. The money market fund is valued based on quoted market prices reported in active markets. See Note 5 for additional information.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Companies, by the plan sponsor, or as a plan expense.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including October 8, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Empower Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year, including master trust information included in Note 5, are based solely on information certified by the Trustee.

### Note 4 - Tax Status

The Plan has received a determination letter dated February 21, 2017 from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

### Note 5 - Interest in Master Trust

The Plan's investments are in the Master Trust, which was established for the investment of assets of the Plan and Marmon Consolidated Retirement Plan. Each participating plan has a divided interest in the Master Trust, which is based on account balances of the participants and their elected investment options. The assets of the Master Trust are held by Empower Trust Company. Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based upon their pro rata share of the investments of the Master Trust.

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### *Level 1*

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Master Trust has the ability to access.

**Note 5 - Interest in Master Trust (Continued)**

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Master Trust's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
