**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of The Delta Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year December 31, 2024 then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Delta Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

**Basis for Opinion**

We are required to be independent of The Delta Pension Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. **Responsibilities of Management for the Financial Statements**

**Note 1: Description of Plan**

The following brief description of Delta Pension Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution profit sharing plan covering substantially all employees of Delta Community Supports, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Pension Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Contributions**

Each year, participants may contribute up to 50% of annual compensation, as defined in the Plan. Participants may contribute either pre-tax or Roth deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (rollovers). Participants direct their contributions into various investment options offered by the Plan. Employees of the Company become eligible to contribute to the Plan after the completion of three months of eligible service and attainment of age 18. Participants become eligible for employer matching and profit sharing contributions after the completion of one year of eligible service (first full year in which a participant is credited with at least 1,000 hours of service) and the attainment of age 18.

The Plan includes an auto-enrollment provision whereby all newly eligible employees for the employer are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company matches the employee contributions to the Plan on a dollar-for-dollar basis up to 3% of compensation. On an annual basis, the Company will determine if a discretionary profit sharing contribution will be made to the Plan. A participant's share is based on the ratio that each participant's eligible compensation bears to the eligible compensation paid to all participants. The Company made a discretionary profit sharing contribution of \$0 for the year ended December 31, 2024. Discretionary employer matching contributions and employer profit sharing contributions are invested as directed by the participant.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's profit sharing contribution and plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Note 1: Description of Plan (Continued)**

**Normal Retirement Age**

Normal retirement age means the latter of age 65 or the 5th anniversary of the first day of the first plan year in which a participant commenced participation in the Plan.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Upon termination of employment for any reason other than retirement, disability or death, years of active participation in the Plan will determine the percent vesting of the Company's contributions based on the following:

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. A participant may not have more than one outstanding loan from the Plan at any one time. The loan bears a fixed rate of interest based on current market rates. Payments are made through automatic payroll deductions. The loan must be repaid within five years, with the exception that a loan to acquire a principal residence may be repaid over a longer period of time. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Termination of Employment or Death**

A participant terminated for any reason will be entitled to receive the vested amounts credited to the participant's account under the Plan. In the event of death, the participant becomes fully vested and the designated beneficiary under the Plan will be entitled to receive all undistributed amounts credited to the participant's account.

**In-Service Withdrawals**

The following in-service withdrawals are permitted under the Plan while employed by the Company:

*On or After Age 59 ½* - Any vested amounts credited to the participant's account may be withdrawn.

*Financial Hardship* - Employee contributions and rollover contributions may be withdrawn. Employer matching and profit sharing contributions may only be withdrawn for a hardship for participants who have participated in the Plan for six or more years and have attained age 59 ½.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$38,696 and \$16,657, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses. In 2024, employer contributions were reduced by \$38,340 and \$208,491 was used to reduce administrative expenses from forfeited nonvested accounts.

**Investment Options**

The Plan is entirely participant-directed and, as such, upon enrollment in the Plan, a participant may direct employee and employer contributions in any investment option offered in the Plan. Participants may change their investment options at any time. The Plan currently offers various investment options.

**Secure Act and Secure Act 2.0**

The Plan is currently working with their third party administrator to ensure compliance and any required plan changes are made to comply with the Secure Act and the Secure Act 2.0.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent loans are treated as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

**Note 3: Certified Information Supplied by Trustee of Plan Assets**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Matrix Trust Company, the trustee, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule. The trustee has certified the following as complete and accurate:

- Investments, at fair value, at December 31, 2024 and 2023.
- Interest and dividends for the year ended December 31, 2024.
- Net appreciation in fair value of investments for the year ended December 31, 2024.
- Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) at December 31, 2024.

**Note 4: Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

**Level 1**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2**

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Money Market Fund:* The objective of the money market fund is to earn interest while preserving the value of \$1 per share. The fund consists of short-term securities representing high quality, liquid debt, and monetary instruments.

**Note 5: Related Party Transactions and Party-in-Interest Transactions**

The Plan holds an investment in a common/collective trust account and, therefore, is considered a party-in-interest transaction. Certain investment advisory services are provided by BLB & B Advisors, LLC. Certain administrative services are provided by CPI Qualified Plan Consultants, Inc. BLB & B Advisors, LLC and CPI Qualified Plan Consultants, Inc. receive compensation for these services and, therefore, qualifies as a party-in-interest. Fees paid by the Plan amounted to \$120,561 for the year ended December 31, 2024.

**Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 7: Tax Status**

The IRS advised the trustee by a letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
