The cash balance interest crediting rate is equal to the rate of return on plan assets, subject to a cumulative minimum interest crediting rate. Accordingly, the assets needed to provide future cash balance benefits are independent of interest rates and only dependent on the plan's asset allocation to the extent that the cumulative minimum interest crediting rate affects the cash balance accounts. This plan provision is difficult to measure using traditional deterministic valuation procedures. To account for this plan provision, the interest crediting rate was selected from a reasonable range based on the plan's asset allocation that, when combined with the segment interest rates, produced a funding target that was as close as possible to the economic value of the cash balance accounts.

The amount of a participant's benefit payable in the plan year in which benefits commence shall be the Actuarial Equivalent of a variable annuity commencing on the Normal Retirement Date and continuing for the participant's life with monthly payment in an amount equal to one-twelfth of the product of:

- (i) the participant's number of accumulated Retirement Units as of the Annuity Starting Date, times
- (ii) the applicable Unit Value as of the Annuity Starting Date.

A participant who is credited with at least 1,000 Hours of Service during a plan year shall, for such plan year, earn a Benefit Credit equal to \$4,500, multiplied by a fraction where the numerator is the number of months during such plan year during which the participant is credited with at least one Hour of Service as a participant and the denominator is twelve. A participant shall be credited with 190 Hours of Service for each month during such plan year during which the participant is credited with at least one Hour or Service as a participant.

The amount of Benefit Credits earned by a participant for any given plan year shall be converted into Retirement Units as of the last day of such plan year by dividing such Benefit Credits by the Unit Value determined as of the last day of such plan year.

The Unit Value of Retirement Units as of December 31, 2017 shall be \$100. The Unit Value shall be redetermined as of any subsequent date by multiplying the Unit Value as of the preceding Accounting Date times the ratio of (1) divided by (2) where:

- (1) is equal to 1 plus the actual rate of investment return earned by the Trust since the end of the immediately preceding plan year
- (2) is equal to 1 plus a rate that would equal 5% if annualized.
