Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Peter Boulware Toyota 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Peter Boulware Toyota 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Peter Boulware Toyota 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Peter Boulware Toyota 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial

NOTE 1: <i>Plan Description</i>
--

The following description of the Peter Boulware Toyota 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established and made effective October 1, 1994 covering all full-time employees of Peter Boulware Toyota (the “Company”), previously known as Legacy Toyota. The Plan and the Trust of which it is a part of are intended to satisfy the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan’s sponsor and administrator. The Plan’s directed Custodian is Empower Retirement (“Empower”). Massachusetts Mutual Life Insurance Company (“MassMutual”) was the previous custodian but sold their retirement plan segment of business to Empower during 2022.

Eligibility

The Plan covers all employees of the Company who have met the eligibility requirements described below. Eligible employees may begin to defer into the Plan on the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or following the date the eligibility requirements are satisfied. Participants who have completed one year of service and have reached age 21 are eligible to participate in the Plan.

Auto Enrollment

The Plan enacted an auto enrollment provision as of January 1, 2015, applicable only to employees who become participants on or after the effective date. Participants who are automatically enrolled will have 1% deferred from their compensation unless they elect an alternative deferral amount or elect not to defer under the Plan. Additionally, participants subject to the automatic deferral amount will have their deferral percentage automatically increased by 1% of compensation each year up to a maximum of 6%.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan, limited by the provisions of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make “catch up” contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered

by the Plan. The Plan currently offers various mutual funds and a guaranteed interest account as investment options for participants. Effective April 1, 2021, the Company began a match of 1/3 of the employees' deferral up to 6% with a maximum annual contribution of \$2,000 per employee. Employer discretionary contributions may be contributed at the discretion of the Company's management and are also invested directly into the investment options selected by the participants. Contributions are subject to certain Internal Revenue Service (IRS) limitations. No employer discretionary contributions were made for the years ended December 31, 2024 or 2023.

Participant Accounts

Each participant's account is credited with a participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings and administrative expenses, and (c) forfeitures of terminated participants' nonvested account balances. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants can allocate their contributions among various funds available through the Plan's custodian, Empower.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the employer contributions plus earnings is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

The Plan does not allow for participant loans.

Payment of Benefits

On termination of service due to death or disability, a participant (or beneficiary) may elect to receive the entire amount of his/her account in a lump sum. If employment is terminated due to retirement or other reasons, participants are entitled only to their vested balance. A lump-sum distribution will be made to terminated participants who vested balance is less than \$5,000 without the participant's consent.

NOTE 2: <i>Summary of Significant Accounting Policies</i>
--

Basis of Accounting

The Plan's policy is to prepare its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Revenues are recognized in the period in which they are earned. Expenses are recognized in the period in which they are incurred.

NOTE 2: <i>Summary of Significant Accounting Policies (Continued)</i>
--

Use of Estimates

The presentation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions to participants, if applicable, are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through September 23, 2025 which is the date the financial statements were available to be issued. As of this date, there were no events that required disclosure.

NOTE 3: *Income Tax Status*

The Internal Revenue Service has ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, the related trust is exempt from tax pursuant to Section 501(a) of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods.

NOTE 4: *Fair Value Measurements*

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4: Fair Value Measurements (Continued)
--

Below is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for the years ended December 31, 2024, and 2023.

- *Pooled separate accounts:* Valued at quoted end of day prices of similar securities in active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: Investments – Group Annuity Contract

The Plan maintains a Guaranteed Interest Account (GIA) provided through a group annuity contract. Under the terms of the Contract, a credit rate is established for funds invested in the GIA and participants may withdraw or transfer funds in their account invested in the GIA at contract value. Contract value represents contributions plus credit interest less participant withdrawals and fees. Empower Retirement considers the GIA to be fully benefit-responsive notwithstanding the contract provisions that limit the ability of the plan to transact at contract value when a market value event occurs, which is a fully benefit-responsive guaranteed investment contract with the Trustee.

NOTE 5: Investments – Group Annuity Contract (Continued)

Because the GIA is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIA. The balance at year end provided for the GIA in the statement of net assets available for benefits is at contract value. Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from Plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the plan sponsor's business. Such events also include removal from the Plan of one or more groups or classifications of participants, partial or complete Plan termination, or Plan disqualification. Consult the Plan's contract for further information.

NOTE 6: Investments – Participant Directed

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Empower and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments reported in the accompanying statements of net assets available for benefits of \$3,614,313 as of December 31, 2024, and \$3,098,745 as of December 31, 2023.
- b. Net investment Income(Loss) as reported in the accompanying statement of changes in net assets available for benefits is \$309,266.
- c. All investment-related information in the accompanying supplemental Schedule H, Line 4i- Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 7: Plan Termination

Although it has not expressed any interest in doing so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 8: Transactions with Parties-in-Interest

The Plan investments are held in pooled separate accounts managed by Empower. Empower is the Custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$6,935 and \$15,942 for the years ended December 31, 2024 and 2023, respectively. Fees paid during the year for legal, accounting, and other services rendered by parties-in-interest were based on customary and reasonable rates for such services.

NOTE 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 11: <i>Corrections Payable</i>
--

A plan must pass certain nondiscrimination tests under IRC Sections 401 (k) and 401 (m). If a plan fails the annual testing, corrective action must be taken to protect the qualified status of the plan. The law and related regulations provide various methods for correcting mistakes during certain correction periods. For this purpose, the statutory correction period is the 12-month period following the close of the plan year in which the mistake occurs. If corrective distributions are made to HCEs after the first 2½ months after the plan year-end, the employer (not the HCE) is liable for an excise tax. If correction is not made within the 12-month correction period, the plan is considered to have lost its tax qualified status. Therefore, any excess deferrals should be returned to plan participants within 2½ months after the plan year-end in order to avoid a 10-percent excise tax on the amount not timely refunded under IRC Section 4979.

The plan failed the discrimination test for the years ended December 31, 2024 and 2023. Aggregate excess annual deferral refunds of \$36,234 and \$36,951 are recorded as a liability in the accompanying statements of net assets available for benefits and as a reduction of contributions for the years ended December 31, 2024 and 2023, respectively.
