### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements*

We have performed audits of the financial statements of VBM Acquisition 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion on the Financial Statements*

### NOTE 1 – DESCRIPTION OF PLAN

The following description of the VBM Acquisition 401(K) Plan (the Plan) provides only general information. Therefore, participants should refer to the plan agreement or summary plan description for a more complete description of the Plan's provisions.

#### **General**

The Plan is sponsored by VBM Acquisition, LLC dba Toyota of Boerne (the Company) for its employees. The Plan is designed to comply with the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), and the Internal Revenue Code (IRC).

#### **Contributions**

Participants may elect to contribute up to 100% of their annual compensation as defined in the Plan, subject to the maximum dollar amount allowable under the IRC. Participant contributions may be designed as pre-tax or after-tax Roth contributions, subject to IRC limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to IRC limits. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans. The Company may make a discretionary matching contribution. The Company did not make discretionary contributions during the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, rollover contributions, and allocations of (a) the Company's contribution, if applicable, and (b) plan earnings less expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Administrative fees, except loan fees and certain investment fees, are allocated based on participant earnings or account balances.

#### **Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a menu of options, including mutual funds and a guaranteed fund.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings or losses thereon. Vesting in the Company's discretionary matching contributions plus actual earnings or losses thereon is based on continuous years of service as follows:

2	20%
3	40%
4	60%
5	80%
6 or more	100%

Upon death or disability, the participant (or his/her beneficiary in the case of his/her death) becomes 100% vested in the Plan. Upon reaching normal retirement age or after six years in the Plan, the participant becomes 100% vested in the Plan.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a rate set by the plan administrator, ranging from 4.25% - 9.50%. Any loan must be repaid within five years unless otherwise approved. Principal and interest are paid ratably through deductions from each payroll.

#### Payment of Benefits

The benefit to which a participant is entitled equals the value of the participant's vested interest in his or her account. Upon termination of service including death, disability, or retirement, a participant may elect to receive a lump-sum payment equal to the vested portion of his or her account. Upon termination of employment, vested account balances of less than \$5,000 will be rolled over to an individual retirement account if withdrawal of the funds is not initiated by the participant. Account balances less than \$1,000 are distributed to participants as a lump sum distribution.

#### Forfeited Accounts

Forfeitures of terminated participants' non-vested account balances are retained in the Plan and may first be used to pay administrative expenses. Remaining amounts will be used to reduce future company contributions of the Plan. At December 31, 2024 and 2023 forfeited non-invested accounts totaled \$4 and \$17, respectively. For the year ended December 31, 2024, there were \$17 of forfeited balances applied to offset plan expenses.

#### **Administrative Expenses**

All administrative fees charged to the Plan are paid by the participants and are presented as administrative expenses in the statement of changes in net assets available for benefits.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting and Use of Estimates**

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP), which requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Financial Accounting Standards Board (FASB) has adopted the Accounting Standards Codification (ASC) as the sole source of authoritative GAAP. The FASB will issue Accounting Standards Updates (ASU) from time to time to make adjustments to GAAP.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's investments are valued daily.

Net appreciation or depreciation of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the year. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the year or the cost of the investment if purchased during the year.

Investment contracts held by a defined-contribution plan are reported at contract value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The insurance company general account determines its fair value using the net asset value (NAV) of the fund. The NAV is determined by the trustee of the fund using the fair value of the underlying securities within the fund at year end.

#### Investment Valuation and Income Recognition (Continued)

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual method. Dividends are recorded on the ex-dividend date.

#### Payment of Benefits

Benefits paid to participants are recorded when paid.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

**Level 1** - consists of unadjusted quoted prices in active markets for identical assets or liabilities and has the highest priority.

**Level 2** - consists of inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly.

**Level 3** - consists of significant unobservable inputs for the asset or liability and has the lowest priority.

The following are descriptions of the valuation methods and assumptions used by the Plan to estimate the fair value of its investments:

**Mutual funds:** The fair value of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

**Stable Value Fund:** The contract value of the stable value fund is based on the NAV reported by the fund managers as of the financial statement dates and recent transaction prices.

As of December 31, 2024 and 2023, the Plan maintained a guaranteed investment contract related investment, the Guaranteed Fund issued by Sentry Life Insurance Company (a party-in-interest). The contracts underlying this investment option are considered to be fully benefit responsive in accordance with ASC Topic 962. As of December 31, 2024 and 2023, the contract value of the investments in this accounts totaled \$133,708 and \$130,616, respectively.

Sentry Life Insurance Company establishes a guaranteed rate of return at contract issuance and is guaranteed for the life of the contract. Any changes in the credited interest rate will apply to all amounts in the fixed account. The credited interest rate of return was 1.75% for the year ended December 31, 2024.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan) (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event which would limit the Plan's ability to transact at contract value with participants is probable.

Sentry Life Insurance Company offers five payout options for investments in the contract. They are as follows: 1) Single Sum, 2) Life Annuity, 3) Qualified Joint and Survivor Annuity, 4) Contingent Annuitant Option and 5) Ten Year Certain and Life Annuity.

### NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Company, and certain others. As such, transactions conducted by Sentry Life Insurance Company and its affiliates qualify as party-in-interest transactions.

### NOTE 7 – TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the plan administrator is not aware of any events that have occurred that might adversely affect the Plan's qualified status.

The Plan follows the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC Topic 740, *Income Taxes*. Using that guidance, tax positions initially need to be recognized in the financial statements when it is more likely than not the position will be sustained upon examination by the tax authorities.

The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits. The Plan's evaluation was performed for tax years ended December 31, 2021 through December 31, 2024, the years that remain subject to examination by major tax jurisdictions as of December 31, 2024.


