Notes to Financial Statements

Note 1: Description of Plan

The following description of the Beloit Health System Matching and Employer Contribution Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

General

The Plan is a defined contribution plan sponsored by Beloit Health System, Inc. (the "Sponsor"). Fidelity Management Trust Company is the Plan Trustee and holds the Plan's investment assets and executes investment transactions.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Eligibility

Participants are eligible to receive matching contributions, based on the participant's contribution to the Beloit Health System 403(b) Plan, upon attaining the age of 18, provided they are not covered under a collective bargaining agreement. Employees who are unable to earn benefits in the Beloit Health System, Inc. Retirement Plan are eligible to receive an additional non-matching contribution, at the discretion of the board of directors. Sponsor non-matching contributions begin on the first day of each quarter coincident with or immediately upon attaining the age of 21 and completing 1,000 hours of service within the 12-month period following employment.

Contributions

Participants may not make either pre-tax or after-tax contributions to the Plan. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollovers"). In 2024 and 2023, the Sponsor approved and contributed a matching contribution equal to 50% of the participant's contribution to the Beloit Health System 403(b) Plan, up to a maximum of 4% and 2.5%, respectively, of a participant's eligible wages. In 2024 and 2023, eligible employees under the Plan received an employer contribution of 0% and 2%, respectively, of eligible employee's eligible wages, regardless of employee contributions. The matching and non-matching contributions are included in Sponsor contributions receivable at December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the Sponsor's contributions and allocations of Plan earnings (losses) and charged with an allocation of investment management expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Sponsor matching contribution portion of each participant's account occurs over a four-year period shown by the following:

The Plan provides for 100% vesting upon death, disability, as defined, or normal retirement age of 65.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or a designated beneficiary will receive a single lump-sum distribution or installment payments equal to the value of the participant's account. For termination of service due to other reasons, a participant may elect to receive a lump-sum payment or installment payments equaling their vested portion in the Plan or may elect to defer payment. If a participant's vested account balance is \$7,000 or less, the participant will automatically receive a lump-sum distribution to another qualified retirement plan or an individual retirement account. In addition, hardship distributions out of the participant's vested account balance are permitted if certain criteria are met.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Sponsor before becoming 100% vested in the Sponsor's contributions, and for excess contributions related to the nondiscrimination provisions of the Plan. Forfeitures are used to reduce future Sponsor contributions. There were no unallocated forfeitures from nonvested accounts at December 31, 2024 and 2023. Forfeitures of \$137,096 were used to offset Sponsor contributions for the year ended December 31, 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative costs (excluding investment and transaction fees) of the Plan are paid by, and at the discretion of, the Sponsor. Expenses paid by the Sponsor are excluded from the accompanying financial statements. The administrative costs paid by the Plan were the recordkeeping and account maintenance fees for third-party administration.

Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Note 3: Fair Value Measurements (Continued)

Stable value fund: Fair value is estimated using the NAV per unit provided by the issuer of such fund after adjustments to reflect all fund investments at fair value, including direct and indirect interests in fully benefit-responsive contracts. The objective of the fund is to maintain the safety of principal while generating a level of current income generally exceeding that of many money market funds. Investments in the stable value fund can be purchased or sold continuously. A notice of redemption is not required, and the Plan has no obligation to buy additional units.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Information Prepared and Certified by Trustee

The Sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan. This information includes investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their Sponsor contributions.

Note 6: Tax Status

The Plan adopted the Fidelity Management Trust Company nonstandard Profit Sharing Plan with an Internal Revenue Service notification letter dated June 30, 2020, which states the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (the "Code"). Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Party-In- Interest Transactions

Certain Plan investments were managed by affiliates of Fidelity Management Trust Company, the Trustee of the Plan, therefore, these transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.
