Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Verisma Systems, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Supplemental Schedules Required by ERISA

The supplemental schedules of Delinquent Participant Contributions For the Year Ended December 31, 2024 and Assets Held at End of Year as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or are derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or are derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or are derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

Summary Plan Description — The following brief description of the Verisma Systems, Inc. 401(k) Plan (the Plan) provides general information only. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

General — The Plan is a defined contribution plan covering eligible employees of Verisma Systems, Inc. and, beginning May 2, 2023, ScanSTAT Technologies, LLC (collectively, the Company). Employees who are at least 21 years old, have completed at least 30 days of service and are not independent contractors, leased employees or nonresident aliens are eligible to participate in the Plan beginning the first day of the month following the completion of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions — The Plan provides for an automatic election to have elective deferral contributions after an employee meets the eligibility requirements. The automatic elective deferral contribution is 4% of the employee's compensation. The participant may affirmatively elect a different percentage or elect not to make deferral contributions. Participants may contribute any percentage of their annual compensation to the Plan subject to annual limitations in accordance with the provisions of the Internal Revenue Code (IRC). Employee rollover and catch-up contributions are permitted.

The Company may make discretionary matching contributions equal to a percentage of each participant's elected salary deferral. The Company may also make discretionary profit sharing contributions to the Plan which are allocated to participant accounts in the same ratio as each participant's compensation bears to the total of such compensation of all participants.

Participant Accounts — Each participant's account will be credited with the participant's contributions and an allocation of the Plan's earnings and losses. The Plan's earnings or losses, excluding that related to participants' loans, are allocated to the participant's account based upon the proportion that each participant's account bears to the total participants' account balances. Earnings resulting from loans to participants are credited to the respective participants' accounts. Participants direct the investment of their contributions into various investment options offered by the plan.

Notes Receivable from Participants — Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through regular payroll deductions.

Vesting — Participants are 100% vested in the amounts they contribute plus the earnings or losses thereon.

Participants vest in the Company's profit sharing and matching contributions and the earnings or losses thereon as follows:

Years of Service	Vested Percentage
Less than two years	0%
Two years	20%
Three years	40%
Four years	60%
Five years	80%
Six or more years	100%

If a participant dies, attains the normal retirement age or becomes totally disabled, the participant becomes 100% vested.

Payment of Benefits — Upon death, disability, retirement or termination of service, a participant may elect to receive either a lump-sum amount or installment payments totaling the value of the participant's interest in his or her account. A participant may also elect to receive an account distribution if the participant has attained the age of 59½ or incurred a hardship in accordance with the Plan provisions.

Forfeitures — Forfeitures are applied to reduce employer contributions or pay administrative expenses. As of December 31, 2024 and 2023, there were no forfeited, non-vested accounts.

Administrative Expenses — Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

Plan Termination — Although the Company has not expressed any intent to do so, it retains the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates — Preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Plan's administrator determines the Plan's valuation policies using information provided by the asset custodian. See Note 3 for information on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation or depreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investment income from common collective trusts is included within net appreciation or depreciation in fair value of investments consistent with the presentation provided by the custodian.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments — Benefits are recorded when paid.

Plan Tax Status — The Plan is a non-standardized prototype plan of Principal Life Insurance Company. Principal Life Insurance Company obtained its latest prototype determination letter dated June 30, 2020, stating that the non-standardized plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has concluded that as of December 31, 2024, the Plan has no material uncertain tax positions.

Subsequent Events — The Plan has evaluated subsequent events for recognition or disclosure through the date of the Independent Auditors' Report, which is the date the financial statements were available for issuance.

3. FAIR VALUE MEASUREMENTS

Generally accepted accounting principles require the Plan to use a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2: Prices determined using significant other observable inputs. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Prices determined using significant unobservable inputs.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the quoted prices of shares held by the Plan at year end. The shares are actively traded.

Common Collective Trusts: Valued at the net asset value of shares held by the Plan at year-end. The net asset value is used as a practical expedient for fair value and is not quoted in an active market; however, the net asset value is based on the market value of the underlying investments which are traded on an active market or have observable inputs. There are no significant redemption restrictions on the accounts.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments for which fair value is measured using the net asset value per share practical expedient are not categorized within the fair value hierarchy.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. NON-EXEMPT PROHIBITED TRANSACTIONS – DELIQUENT PARTICIPANT CONTRIBUTIONS

Defined contribution plans are required to remit employee contributions and loan payments to the Plan as soon as they can be reasonably segregated from the employer's general assets. During 2020 and 2022, contributions and loan payments of \$958 were not remitted to the Plan on a timely basis. The contributions and loan payments were remitted in 2020 and 2022 and lost earnings are expected to be remitted in 2025.

During 2023, loan payments of \$257 were not timely remitted. The loan payments were fully remitted in 2023, and lost earnings are expected to be remitted in 2025. During 2024, contributions of \$6,806 were not timely remitted. The contributions were fully remitted in 2025, and lost earnings are expected to be remitted in 2025.
