### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Northwest Aerospace Technologies, Inc. 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from T. Rowe Price Trust Company as of December 31, 2024 and for the period from October 3, 2024 to December 31, 2024, and Empower Annuity Insurance Company of America and Empower Trust Company, LLC as of December 31, 2023 and for the period from January 1, 2024 to October 2, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. **NOTE 1. Description of the Plan**

The following description of the Northwest Aerospace Technologies, Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended and restated on Oct 3, 2024 as part of changing platforms from Empower to T. Rowe Price. Significant amendments were changes to age of eligibility, Plan entrance dates, and interest rates being charged on notes receivable from participants, which are reflected in the below disclosures.

General:

The Plan is a contributory defined contribution plan covering all eligible employees of the Sponsor who are eighteen years of age and have completed 30 days of service. All employees covered by a collective bargaining agreement, non-resident alien, leased employees, and interns are not eligible to participate in the Plan. Eligible employees may enter the Plan on the first day of each calendar month coinciding with or after eligibility requirements are met.

On December 29, 2022, the SECURE 2.0 Act of 2022 was signed into law, which provides both required and optional future enhancements to tax qualified retirement plans and their participants. The provisions of the SECURE 2.0 Act may be effective and operationalized prior to formally amending the Plan document. The Plan has until December 31, 2026 to formally amend the Plan documents. The Plan is implementing required provisions in accordance with the applicable effective dates and is continually evaluating the optional provisions.

Contributions:

Upon meeting eligibility requirements, participants are automatically enrolled in the Plan with salary deferrals of 5 percent of eligible compensation. Participants may elect to opt-out of the automatic enrollment program.

Each year participants may contribute up to the maximum amount allowed by the Internal Revenue Code of annual compensation as defined in the Plan. Participant contributions may be made as pre-tax or Roth elective deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Sponsor will contribute a matching contribution equal to 100 percent of each participant's deferral contributions each payroll period, not exceeding 5 percent of the participant's compensation. Deferrals in excess of 5 percent of pay are disregarded in computing a participant's match.

The Sponsor may also contribute a discretionary nonelective contribution at the discretion of the Sponsor's Board of Directors. For the year ended December 31, 2024, the Sponsor made no nonelective contribution.

Participant Accounts and Investment Options:

Contributions from Plan participants and the related Plan Sponsor's matching contribution are recorded in the year in which the employee contributions are withheld from compensation.

Contributions to participant accounts are deposited into participant-directed funds at Empower Annuity Insurance Company of America and Empower Trust Company, LLC through October 2, 2024 and T. Rowe Price Trust Company thereafter. Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor periodically reviews the investment fund options available to participants and drops or adds investment funds as warranted.

Each participant's account is credited with the participant's contribution and allocation of the Sponsor's contribution and Plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the USA Today Prime Rate plus 1 percent. The prime rate was 7.50 and 8.50 percent at December 31, 2024 and 2023, respectively. Principal and interest is paid ratably through payroll deductions. Loan transactions are treated as a transfer between investment funds and the Participant Loan fund. Loan terms range from one to five years, or more if for the purchase of a primary residence.

Vesting:

Participants are 100 percent vested in 401(k) salary deferral contributions, rollovers, nonelective contributions and the related earnings on these sources at all times. Vesting in the matching contributions, plus earnings, is based on years of credited service. Generally, a participant is 100 percent vested after five years of credited service, upon retirement, death or total disability or termination of the Plan.

Forfeitures:

Nonvested account balances forfeited into the Plan for the years ended December 31, 2024 and 2023 were \$54,587 and \$28,723, respectively.

Forfeitures of terminated participants' nonvested account balances are used to pay Plan expenses and to reduce the Sponsor's contribution. During the year ended December 31, 2024, forfeitures of \$22,090 were used to reduce the Sponsor match.

Payment of Benefits:

Upon termination of service, a participant whose vested account exceeds \$5,000 may elect to leave their vested account balance invested in the Plan or receive a lump-sum payment equal to the value of their account. Terminated participants with a vested account balance less than \$5,000 will automatically be paid as defined in the Plan Document.

Upon death or disability, a beneficiary or participant will receive 100 percent of their account balance paid as if retired. A lump-sum distribution will be paid at the earliest administratively feasible date. Pre-retirement and hardship distributions are allowed in accordance with the terms of the Plan.

**NOTE 2. Summary of Significant Accounting Policies**

Basis of Presentation:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America and present the net assets available for Plan benefits and the changes in those net assets.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions of net assets available for benefits during the reporting period. Actual results may differ from those estimates.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Investment Valuation and Income Recognition:

At December 31, 2024 and 2023, the Plan's investments are held in participant directed accounts at Empower Annuity Insurance Company of America and Empower Trust Company, LLC through October 2, 2024 and T. Rowe Price Trust Company thereafter.

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Notes 5 and 6 for discussion of fair value measurements and contract value investments, respectively.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits:

Benefits are recorded when paid.

Administrative and Investment Management Expenses:

The Plan's expenses are paid either by the Plan or Plan Sponsor, as determined by the trustees, plan document, or service provider agreements. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements and are not intended to be reimbursed by the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**NOTE 3. Risk and Uncertainties**

The Plan is exposed to market and credit risk due to the various foreign and domestic investment securities that may be selected by the participant in any combination. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 4. Information Certified by the Custodian**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company as of December 31, 2024 and for the period from October 3, 2024 to December 31, 2024, and Empower Annuity Insurance Company of America and Empower Trust Company, LLC as of December 31, 2023 and for the period from January 1, 2024 to October 2, 2024 as follows:

**NOTE 5. Fair Value Measurements**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that are accessible at the measurement date for identical assets or liabilities that the Plan has the ability to access.
Level 2	Inputs to valuation methodology other than Level 1 inputs that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of assets or liabilities.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the techniques and inputs used at December 31, 2024 and 2023.

*Registered Investment Company's (Mutual Funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and transact at that price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation techniques and inputs are appropriate and consistent with other market participants, the use of different techniques and inputs or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6. Fully Benefit-Responsive Investment Contract**

The Plan invested in a traditional, fully benefit-responsive investment contract (FBRIC) with Empower Annuity Insurance Company of America through October 2, 2024, at which point the Plan transferred all assets to T. Rowe Price Trust Company. The Plan then entered into another FBRIC with the Standard Insurance Company. Contributions are maintained in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00 percent. The crediting rate is reviewed on a quarterly basis for resetting.

The contract meets the FBRIC criteria, and therefore is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by T. Rowe Price Trust Company represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

The contract value of the investment contracts at December 31, 2024 and 2023, was \$1,940,599 and \$1,343,251, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

1. Amendments to the Plan documents (including complete or partial plan termination or merger with another plan).
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions.
3. Bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary).
4. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
5. Premature termination of the contract.

No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from the contract value. Examples of such events include the following:

1. The contract owner's failure to abide by state or federal law.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreement without the consent of the contract issuer.

**NOTE 7. Party-in-Interest Transactions and Administration of Plan Assets**

A party-in-interest is defined as a fiduciary or employee of the plan, any person who provides service to the Plan, an employer whose employees are covered by the plan, an employee organization whose members are covered by the plan, a person who owns 50 percent or more of such an employer or employee organization, or a relative of such persons mentioned.

The Plan's investment options are held in participant directed accounts at Empower Annuity Insurance Company of America and Empower Trust Company, LLC, through October 2, 2024 and T. Rowe Price Trust Company thereafter as the custodian of the Plan; therefore, any transaction executed with the custodian qualifies as a party-in-interest transaction.

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activities to various service providers. These transactions are party-in-interest transactions.

The Plan Sponsor, Northwest Aerospace Technologies, Inc., is a party-in-interest. Certain administrative functions are performed by employees of the Sponsor. No such employee receives compensation from the Plan. The Sponsor has the discretion to appoint or remove any trustee or agent of the Plan. The Trustees have the full power to administer the Plan and apply all of its provisions on behalf of the Sponsor.

**NOTE 8. Tax Status**

The Plan has adopted a non-standardized pre-approved profit sharing plan with CODA sponsored by T. Rowe Price Retirement Plan Services, Inc. which received a favorable opinion letter from the Internal Revenue Service (IRS) dated August 19, 2020. Although the opinion letter is not specific to the Plan, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code; therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no material uncertain tax positions that require adjustments to the financial statements; therefore, no provision or liability for income taxes has been included in the financial statements.

**NOTE 9. Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**NOTE 10. Subsequent Events**

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustments to the financial statements or disclosure is October 8, 2025, which is the date on which the financial statements were available to be issued.

Effective January 1, 2025 the Plan was amended and restated to increase the auto-enroll deferral percent from 5 to 6 percent as well as eliminate regular matching contributions and instead utilize a QACA safe harbor matching formula that equates to 100 percent match up to 5 percent of eligible compensation. Participants also have an option to opt into an automatic increase of 1 percent annually to a maximum of 20 percent.
