Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Contractors Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Contractors Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-12 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any asset information related to the investment in The Contractors Retirement Plan Master Trust, a trust meeting the requirements of 29 CFR 2520.103-12 (b) and (c) as a Direct Filing Entity (DFE) or 103-12 Investment Entity (103-12 IE) described in the instructions to Form 5500 Annual Return/Report.

Management has informed us that the 103-12 IE qualifies as a DFE under the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Act of 1974 for the years ended December 31, 2024 and 2023.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the Plan's investment in the 103-12 IE, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by 103-12 IE meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Contractors Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Contractors Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

NOTES TO FINANCIAL STATEMENTS

NOTE A – DESCRIPTION OF PLAN

The following description of the Robertson Construction Services, Inc. (Company) The Contractors Retirement Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees performing services subject to the Services Contract Act, Davis-Bacon Act or similar federal, state, or municipal prevailing wage statutes who are not covered under any collective bargaining agreement and who are not a nonresident alien. There are no age or service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Company contributes an amount equal to the hourly rate designated for each participant's employment classification for the project at which the work was performed. Additional non-elective contributions may be contributed at the option of the Company's managing body. Employees are also able to contribute rollover amounts to the plan. Contributions are subject to certain limitations.

Investment Options

Participants direct the investment of the prevailing wage contributions, employer non-elective contributions, and rollover contributions into investment options offered by the Plan. For those participants that do not direct their investments, the prevailing wage and non-elective contributions will be invested in accordance with the default investment alternatives established under the Plan. Participants may change their investment options upon notice to Fringe Benefit Group, Inc.

Participant Accounts

Each participant's account is credited with the Company's prevailing wage contribution, non-elective contribution, if applicable, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their rollover contributions and Company prevailing wage contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their account is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

NOTE A – DESCRIPTION OF PLAN – CONTINUED

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested interest. The loans are secured by the vested interest in the participant's account and bear an interest at prime, as defined. The interest rate on loan balances was 3.25%-9.50% for the year ended December 31, 2024. Loan terms may not exceed five years. Principal and interest are paid ratably through payment plans set up by the participant separately from payroll.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, in installment payments not to exceed the life expectancy of the participant, applied to the purchase of an annuity contract, or a joint and 50% or 75% survivor annuity for those that are married. A participant who has reached age 59-1/2 may request an in-service distribution. Participants who have reached age 62 may withdraw all or a portion of their account balance attributable to pension contributions prior to termination of employment.

Forfeited Accounts

At December 31, 2024 and 2023, there were no forfeited nonvested accounts. Forfeited nonvested accounts are used to offset Plan expenses and then may be used to reduce future employer contributions.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting; consequently, contributions and investment income are recorded as received and disbursements are recognized when made. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits in conformity with accounting principles generally accepted in the United States of America.

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of the Plan's interest in the Trust (as defined in Note D) is based on the beginning of the year value of the Plan's interest in the Trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and expenses charged to the Plan for some investment accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the notes when paid. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability, and;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the assets or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024.

103-12 Investment Entity (Group Trust)

The investment is valued based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The Net Asset Value (NAV) is based on the market value of the underlying investments. The NAV is not a publicly quoted price in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflected of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE C – FAIR VALUE MEASUREMENTS - CONTINUED

Investments, at fair value, that are valued using NAV as a practical expedient totaled \$3,842,800 and \$3,629,230 at December 31, 2024 and 2023, respectively. There are no unfunded commitments at December 31, 2024 or 2023. The fund has a daily redemption frequency and redemption notice period.

NOTE D – INTEREST IN 103-12 INVESTMENT ENTITY (GROUP TRUST)

The Plan invests in a group trust, The Contractors Retirement Plan Master Trust (Trust), sponsored by Fringe Benefit Group, Inc. Under the terms of the plan document, all assets of the Plan are maintained in the Trust.

The Trust files a Form 5500 as a 103-12 Investment Entity.

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-12 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was not subjected to any auditing procedures performed by the Plan's independent auditor other than comparing such information provided by the Trust to information included in the Plan's financial statements and supplemental schedule:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Total investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024

The Contractors Retirement Plan Master Trust does not meet the definition of a master trust as that term is most commonly used. The Plan's investment in the Trust represents the allocated net portion of the Trust that is attributable to The Contractors Retirement Plan and includes all the Plan's investments.

The Plan's share of the net assets of the Trust is based on the underlying participant account values including the effects of contributions, allocated net investment income, withdrawals, and allocated administrative expenses. Net investment income, gains, and losses are allocated to participating plans on a daily basis based on participants' investment choices. At December 31, 2024 and 2023, the Plan's interest in the net assets of the Trust was approximately 0.27% and 0.24%, respectively.

The investments held in the Trust are stated at fair value. Investment values based on unit values are reported to the Trust by the insurance company (Transamerica Life Insurance Company) holding assets for the Trust. Certain agreements with the insurance company holding the Trust's assets include provisions for withdrawal/surrender fees up to 5% for participants with less than three years of participation in the Trust. These fees normally are charged against the participant's account immediately prior to withdrawal.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE F – TAX STATUS

The Master Plan Sponsor obtained its latest opinion letter, dated August 24, 2020, in which the Internal Revenue Service stated that the Master Plan was in compliance with the applicable requirements of the Code. Such an opinion is not a determination as to whether The Contractors Retirement Plan itself qualifies under IRC Section 401(a); however the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe the Plan was qualified as of the financial statement date.

The preparation of financial statements in conformity with the modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress.

NOTE G – PLAN ADMINISTRATION

Employees of the Company perform certain administrative functions. No such employee receives compensation from the Plan.

NOTE H – TRANSACTIONS WITH PARTIES IN INTEREST

The Plan is part of the Trust whose recordkeeper and sponsor is Fringe Benefit Group, Inc. Various administrative expenses and asset charges of the Trust are paid to Fringe Benefit Group, Inc. and are allocated to the Plan reducing the net investment income. The Plan Administrator for the Plan is the employer, or any other individual, committee, or group appointed by the employer to serve in that capacity.

ERISA Smart, Inc. is the directed trustee and is a named fiduciary under the Plan. All of the above named services providers for the Plan are considered parties in interest under the Employee Retirement Security Act of 1974 (ERISA) and are subject to ERISA rules concerning transactions with the Plan. Fees incurred by the Plan amounted to \$65,025 for the year ended December 31, 2024.

NOTE I – RISKS AND UNCERTAINTIES

The Plan, through the 103-12 IE, invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J – SUBSEQUENT EVENTS

Date of Management Evaluation

The Plan has evaluated subsequent events through October 12, 2025, the date the financial statements were available to be issued.
