1. Description of the Plan

The Putnam Precision Products, Inc. Profit Sharing / 401(k) Plan (the “Plan”) was established October 1, 1972. The Plan is a defined contribution plan covering all eligible employees of Putnam Precision Products, Inc. (the “Company” or “Employer”). The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

The Plan is administered by Company management who is responsible for the administrative and investment decisions of the Plan. Management has appointed Fidelity Management Trust Company (“Fidelity” or the “trustee”) as trustee and to assist in the administration of the Plan. Fidelity safeguards the Plan’s assets and records employee contributions to the fund options available through the Plan.

Eligibility

There is a minimum six-month period of service required to participate in the Plan, and employees are eligible to begin participation on designated monthly enrollment dates provided that they have reached 18 years of age. Employees are eligible to receive Employer discretionary profit-sharing contributions after one year of service (or 1,000 hours) and must be employed on the last day of the contribution period.

Contributions

Plan participants may contribute up to 60% of their eligible compensation to their employee deferral accounts, on a tax deferred basis or Roth. Participant contributions may not exceed the Federal statutory limit as specified by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Each year the Company may make discretionary profit-sharing contributions, which are contributed to participant accounts for all eligible employees. No discretionary contributions were made during the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) Employer contributions and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The vesting of the Company's discretionary profit-sharing contribution plus actual earnings thereon is based on years of continuous service. A participant is fully vested in employer contributions upon the completion of six years of service as detailed in the following table:

Less than 2 years	0%

At least 4 years, but less than 5	60%

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans bear interest determined by the Plan Administrator and are secured by the participant's account. The loans plus interest are repaid through payroll deduction in equal payments over the term of the loan (up to five years, if for purchase of home then no more than 10 years). A participant may have no more than one outstanding loan from the Plan at any time. Loans are collateralized by the participant's account balance. Upon termination of service, the principal and accrued interest shall be immediately due and payable.

Payment of Benefits and Withdrawals

The Plan is designed to provide benefits at the time of retirement. However, if employment with the Company is terminated because of death, disability, or for any other reason, a request for distribution of a participant's account balance is also allowed. If a participant dies while classified as an active member of the Plan, the participant's beneficiary or beneficiaries are entitled to receive the participant's vested account balance. Should a participant become totally and permanently disabled while employed by the Company, the full value of the participant's account balance may be distributed upon request.

Payment of Benefits and Withdrawals (continued)

Upon termination of employment, the vested amount of the participant's account will be distributed to the participant in a lump-sum cash payment if the participant's vested account balance is less than \$5,000. If the account balance is greater than \$5,000, the participant's written consent will be required for any distribution including the election of a rollover distribution to a new qualified plan. Otherwise, the Plan Administrator will direct the Trustee to begin distribution no later than April 1 of the calendar year after the participant attains the age of 73. Upon reaching age 59½, pursuant to the Internal Revenue Code ("IRC"), participants may elect distributions from their accounts without any tax penalty.

Subject to certain limitations prescribed by the Plan and the IRC, participants may elect hardship withdrawals.

Forfeited Accounts

Forfeited accounts are amounts forfeited by participants who have terminated their employment and who have withdrawn from the Plan. Forfeitures may be used to reduce administrative expenses or employer contributions. At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$273 and \$1,801. During 2024, \$1,713 forfeitures funds were used to reduce administrative expenses with the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2024 and 2023, the Plan's investments were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value. The mutual funds and money market fund are valued at the daily closing price as reported by the fund. The mutual funds and money market fund held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The funds are deemed to be actively traded.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. This can only occur when a distributable event occurs, otherwise, the loan continues to accrue interest.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative fees incurred in connection with loans and participant activity charges are borne by the individual and deducted from their respective Plan assets. All other costs not allocable to the account of a particular participant will be charged against the accounts of all participants on a pro rata basis or in such other reasonable manner as may be directed by the Employer and accepted by the trustee. Investment related expenses are included in net appreciation in fair value of investments. Certain expenses related to maintaining the Plan are paid by the Employer and are excluded from these financial statements. Any expenses not paid by the Employer are paid by the Plan.

Accounting for Uncertainty in Income Taxes

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is August 11, 2025.

3. Investments Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

4. Party-in-Interest

Certain Plan investments are managed by the trustee. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Tax Status

The Company has adopted an approved volume submitter plan which received an IRS advisory opinion letter dated June 30, 2020 which indicated the form of the Plan satisfied the qualification requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and tax-exempt as of the financial statement date.
