### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Total Equipment 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, described in Note E to the financial statements, is complete and accurate.

### **Opinion**

## NOTES TO FINANCIAL STATEMENTS

#### NOTE A--DESCRIPTION OF THE PLAN

The following description of Total Equipment 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan with a cash or deferred arrangement covering all employees of Total Equipment Management Services LLC, GET Supplied LLC, and TTH Holding Companies, LLC (collectively the "Company") who have completed two months of service and are age eighteen or older, as defined in the Plan agreement. Employees may enter the Plan on the first day of the plan year quarter following the date on which the employee satisfies the applicable eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may elect to contribute a percentage of their eligible compensation up to the lesser of the participant's eligible compensation or the maximum amount allowed by the Internal Revenue Service (IRS). The IRS' limit was \$23,000 for 2024. Plan participants age 50 and older were eligible to make catch-up contributions of an additional \$7,500 during 2024. The Plan also permits participants to make rollover contributions from other qualified plans. The participants eligible to make the catch-up contributions may do so only after making the total elective deferral contributions allowed by the IRS.

The Company matches contributions on pre-tax elective deferrals equal to 100% of a participant's salary reduction up to 5% of the participant's compensation. In addition, the Company may make a discretionary profit-sharing contribution which is determined annually by management. A participant must be employed on the last day of the plan year to share in any profit-sharing contribution. There was no profit-sharing contribution during 2024.

Participant Accounts and Investment Options: Each participant's account is credited with the participant's contribution, the Company's contribution, and the income and appreciation or depreciation of the investments attributable to each type of investment. Allocations are based on a participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS--Continued

NOTE A--DESCRIPTION OF THE PLAN--Continued

Vesting: Participants are immediately vested in their contributions and the Company's safe harbor contributions and any earnings thereon. Profit sharing contributions are vested 100% upon reaching three years of service.

Forfeitures: Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees and are used to offset administrative costs and future contributions of the Company. The Plan did not incur any forfeitures during 2024.

Payment of Benefits: Upon termination of employment for reasons other than death, disability, or retirement, the participant is entitled to receive a lump sum payment equal to his or her vested interest.

Upon retirement at age 65, retirement due to disability or the death of the participant, the participant or participant's designated beneficiary is entitled to receive the participant's entire account balance.

If the participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it can be made. Participants that have a vested benefit that does not exceed \$5,000 will have funds rolled to IRALogix, if no other alternative has been made, as soon as practicable following the event entitling the participant to a distribution. Certain early distributions made upon termination of employment may be subject to a penalty. At December 31, 2024, net assets available for benefits included approximately \$3,537,000 relating to former participants who have elected, for the present time, to leave their balances intact with the Plan.

Hardship withdrawals are permitted up to the amount of the participant's account balance attributable to their contributions made to the Plan. Hardship withdrawals are only permitted for certain specific uses as defined in the Plan agreement.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Use of Estimates -- Continued: As described in FASB ASC 962-325-50-3, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The guaranteed investment contract (GIC) held by the Plan (the Minnesota Life Insurance Company Guaranteed Return Fund) has no stated maturity dates, has a contract value that is payable on demand, and has a variable interest rate which is reset on a monthly basis, during which a new interest rate is applied to the total outstanding balance of the investment. Based on this, the contract value of the GIC is considered to approximate its fair value and therefore the GIC is presented at its contract value in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Essentially all of the administrative expenses of the Plan are paid by the Plan Sponsor.

Income Tax Status: The Internal Revenue Service has determined and informed the Company in a letter dated March 31, 2014, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events: Subsequent events have been evaluated through August 26, 2025, which is the date the financial statements were available to be issued. There were no subsequent events requiring recognition or disclosure.

NOTE C--INVESTMENT CONCENTRATIONS, RISKS AND UNCERTAINTIES

As of December 31, 2024, approximately 76% of Plan assets consist of three mutual fund investments.

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE D--FAIR VALUE MEASUREMENTS

FASB ASC 820-10-35-39 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-35-39 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs consist of unobservable inputs which are used when observable inputs are unavailable and reflect an entity's own assumptions about the assumptions that market participants would use in pricing the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE D--FAIR VALUE MEASUREMENTS--Continued

The following is a description of the valuation methodologies used for assets measured at fair value:

*Pooled Separate Accounts - Mutual Funds:* Investments represented by a unit of account whose per unit value is the result of the accumulated values of the underlying investments. They underlying investment are public investment vehicles valued using net asset value (NAV) per share. The NAV is based upon the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAVs of the underlying investments are quoted in an active market.

*Stable Value Fund:* Valued at contract value (see Note F).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy.

NOTE E--INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, The Standard Insurance Company ("The Standard"), the Plan's trustee, has certified that the following data included in the accompanying financial statements and supplementary schedule of assets (held at end of year) is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i--schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform audit procedures with respect to this information, except for comparing such information per The Standard's certified statements to the related information included in the financial statements and supplementary schedule.

#### NOTE F--INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a benefit-responsive investment contract with Minnesota Life. Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Minnesota Life. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract's issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the Plan documents (including complete or partial termination of the Plan or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan or 4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The contract does not permit Minnesota Life to terminate the agreement prior to the scheduled maturity date.

#### NOTE G--TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are managed by The Standard or its subsidiaries, which also serve as the Plan's trustee and, therefore, these transactions qualify as party-in-interest transactions under ERISA.

#### NOTE H--VOLUNTARY CORRECTION PROGRAM

The Plan had untimely participant contributions during 2024 of \$23,311. Lost earnings were calculated and remitted in 2025. These remittances constitute prohibited transactions as defined by ERISA. Management does not believe the amount of any lost earnings, interest, or penalties required to be paid is significant.


