Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Museum of Science Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1 - Description of the Plan

The following description of the Museum of Science Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established by the Museum of Science (the “Museum”) for the benefit of its employees (the “Participants”). The Plan is a defined contribution plan consisting of a basic retirement component and a matching component based on an eligible employee’s contributions to a separate Museum-sponsored defined contribution plan, the Museum of Science Savings Plan (the “Savings Plan”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). In accordance with the trust agreement, the Museum administers the Plan. Substantially all investments are participant-directed.

Full-time employees and those who are scheduled to work at least 17.5 hours per week, unless the employee has completed at least 1,000 hours of service in any 12-month period beginning on the employee’s employment date or an anniversary thereof, are automatically enrolled in the basic retirement component of the Plan immediately after they have completed one year of service and have reached age 21.

Employees are eligible for a Museum match of their Savings Plan contributions immediately following completion of three months of service, provided they are at least 21 years old and are scheduled to work at least 17.5 hours per week. Part-time employees who have completed 1,000 hours of service during a 12-month period and are at least 21 years old are also eligible for the matching contribution immediately following the completion of the 12-month service period.

Participant Rollover Contributions

Subject to approval by the Plan administrator, Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans (“Participant Rollovers”).

Employer Basic Retirement Contributions

The Museum contributes to employees’ basic retirement accounts as follows:

Employee’s Age	Museum Contribution
Under 35	2.25% of compensation
35-49	3.00% of compensation
50 and over	4.50% of compensation

The Museum, by action of its Board of Directors, may determine to raise, suspend or reduce its contributions for any Plan year.

Employer Matching Contributions

The Museum matches Participant contributions to the Savings Plan according to the following schedule:

3 months - 5 years	25% of the first 6% of employee Savings Plan contributions	1.5% of compensation
5 or more years	50% of the first 6% of employee Savings Plan contributions	3% of compensation

Participant Accounts

The Plan offers investment choices to allow Participants to create a diversified portfolio of assets based on a Participant's risk tolerance. Participants may invest among a combination of mutual funds sponsored by the Plan's trustee, Fidelity Management Trust Company ("Fidelity").

Each Participant's account is credited with the Museum's basic retirement, matching contributions and Plan investment earnings/losses thereon and charged with direct administration fees. Allocations are based on Participant earnings, account balances or specific participant contributions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

Vesting

Participants are immediately vested in their rollover contributions plus actual earnings thereon. Vesting in the Museum's contributions is based on years of continuous service according to the following table:

Less than 2 years	0%
2 but less than 3	25%
3 but less than 4	50%
4 but less than 5	75%
5 or more	100%

Upon death, disability or attainment of the normal retirement age of 65, a Participant is fully vested in all of their accounts.

Forfeitures

A Participant who leaves the employ of the Museum forfeits any non-vested balance upon the earlier of five consecutive one-year breaks in service or distribution of the entire vested portion of the Participant's account. Forfeited account balances are retained in the Plan and are used to pay administrative expenses or to reduce Museum contributions. Unused forfeited amounts at December 31, 2024 and 2023 amounted to \$289,692 and \$181,808, respectively. During 2024 and 2023, \$45,363 and \$48,238 were used to pay administrative expenses, respectively.

Payment of Benefits

Upon termination of service as a result of normal retirement (age 65), disability, death or termination, a Participant whose account balance is greater than \$5,000 may elect to: (1) receive a lump-sum amount equal to the value of his or her account, (2) receive installment payments, (3) roll the vested balance into an IRA or an employer-sponsored retirement plan or (4) leave the amount in the Plan. If a Participant's vested account balance is between \$1,000 and \$5,000, the Plan administrator, after notification, may rollover his or her entire vested account balance to the Participant in the form of an IRA rollover account on behalf of the former Participant. If a Participant's vested account is less than \$1,000, the Plan administrator automatically distributes the account balance to the Participant.

In-Service Withdrawals and Hardship Withdrawals

Upon reaching age 59½, Participants may elect to withdraw all or a portion of their vested account balances while still employed by the Museum. In addition, upon approval by the Plan administrator, participants may withdraw from their vested accounts in order to satisfy certain immediate and heavy financial needs provided that the hardship distribution is necessary to satisfy such financial need.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. Terms range from one to five years (or up to 10 years for the purchase of a principal residence). Participants may only have one note receivable outstanding at a time. The interest rate for the notes receivable is prime plus one percentage point or such other reasonable rate. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

Individual Participant accounts are charged directly for loan recordkeeping and benefit disbursement processing fees, if applicable. The Plan pays administrative expenses charged by Fidelity, the Plan's trustee, as well as other professional fees for the annual audit. All other operating expenses incurred in the administration of the Plan are paid by the Museum.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are based on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

Subsequent Events

The Museum has evaluated subsequent events through July 24, 2025, the date that the financial statements were available to be issued. No matters of significance were identified for disclosure during this evaluation.

Note 3 - Information Certified by Trustee and Custodian

Plan investments are by Fidelity Management Trust Company (“Fidelity”). The fair value of all investments as of December 31, 2024 and 2023, and all investment transactions for the years then ended, including interest and dividend income and net appreciation in fair values are certified as complete and accurate and reported to the Plan by Fidelity. Information contained in the supplemental schedule and notes receivable from participants are also certified by Fidelity.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level II – Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets and liabilities in inactive markets;
- Inputs other than quoted market prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events such as an international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 6 - Related-Party and Exempt Party-In-Interest Transactions

Plan investments are managed by Fidelity Investments. Fidelity Management Trust Company is the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, as defined by ERISA. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Fees paid to Fidelity and other service providers amounted to \$36,150 and \$38,949 for the years ended December 31, 2024 and 2023, respectively. Notes receivable from participants are also considered exempt party-in-interest transactions. During the Plan year ended December 31, 2024, the Plan received revenue credits of \$10,000 from Fidelity and used the entire amount to pay Plan expenses. The revenue credits are reported net of administrative expenses on the Statement of Changes in Net Assets Available for Benefits.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Museum has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become fully vested in their accounts. Any unallocated assets of the Plan shall be allocated to Participant accounts and distributed in such a manner as the Museum may determine.

Note 8 - Tax Status

The Plan has adopted the Angel Pension Group, Inc. Volume Submitter Profit Sharing Plan with CODA that received a favorable opinion letter, dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Museum believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan continues to qualify under Section 401(a), and the related trust continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
