### Notes to Financial Statements

#### NOTE 1 SUMMARY OF ACCOUNTING POLICIES

##### ***Basis of Accounting***

The financial statements of Danis & Affiliates Retirement Plan (the "Plan") are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

##### ***Benefit Payments to Participants***

Benefit payments to participants are recorded when paid.

##### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### ***Related Party Transactions / Plan Expenses***

Certain administrative functions are performed by the officers or employees of the plan sponsor. The Plan is not charged by the plan sponsor for the services of such officers or employees. Plan expenses for the custodian and certain other fees are paid in part by the plan sponsor. Expenses charged to the Plan totaled \$153,837 for 2024.

#### NOTE 1 SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

##### *Subsequent Event Evaluation*

The plan sponsor has evaluated events subsequent to the balance sheet date through October 13, 2025, which is the date the financial statements were available to be issued.

#### NOTE 2 DESCRIPTION OF PLAN

The following description of the Plan is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution plan covering all employees of Danis Building Construction Company, Danis Industrial Construction Company, Danis Construction, LLC, and Danis Construction Company, LLC (formerly RN Rouse Construction, LLC), collectively, the "Plan Sponsor". There are no age or service requirements to be eligible for employee contributions. With respect to profit sharing contributions and employer match contributions, employees must have completed one year of service with at least 1,000 hours. Prevailing wage employees become eligible to participate in the Plan immediately, without any applicable age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### *Contributions*

With respect to profit sharing contributions, regular contributions made to the accounts of salaried and field employees will be limited to profits as determined by the Profit Sharing Committee. The amount contributed will be solely discretionary by each employer during each Plan year. For 2024 the Plan Sponsor elected to contribute 3% and 8% of compensation for field and office employees, respectively, in each of the companies. Total contributions recorded in 2024 and contributed in 2025 by the Plan Sponsor under this provision were \$2,981,970.

Prevailing wage contributions will be made by the employer at the hourly rate designated for each prevailing wage employee's employment classification for the construction project at which the work was performed. Total contributions made by the Plan Sponsor under this provision in 2024 were \$45,095.

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

##### *Contributions (Continued)*

With respect to employee contributions, each year participants may contribute up to 90% of pre-tax or post-tax annual compensation, as defined by the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 for 2024). The Plan permits catch-up elective deferrals for participants over 50 years of age subject to Internal Revenue Code limitations. Effective June 2, 2014, the Plan added an auto enrollment feature for participants who become eligible on or after the effective date. The automatic enrollment is 4% with an automatic escalation of 1% annually until they have reached 10%. The Plan Sponsor may, at its discretion, make matching contributions for its field and office employees for the various companies. During 2024 the Plan Sponsor made matching contributions for field employees of 100% of the first 3% compensation contributed as elective deferral contributions. No matching contribution was made for office employees. Total contributions recorded in 2024 and contributed in 2025 by the Plan Sponsor under this provision were \$429,902.

Employee contributions and employer matching contributions are participant-directed. Prevailing wage and employer profit sharing contributions are nonparticipant-directed.

##### *Rollover Contributions*

Participants can contribute amounts representing distributions from other qualified defined benefit or contribution plans.

##### *Participant's Account*

Each participant's account is credited with allocations of (a) the participant's contribution, (b) the Plan Sponsor's contribution and (c) Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are immediately 100% vested in their elective contributions as well as prevailing wage and rollover contributions, and the actual earnings thereon.

Vesting in the Plan Sponsor's discretionary profit sharing and employer matching contributions, as well as the actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service as illustrated below:

If the participant terminated before January 1, 2007, vesting in the Plan Sponsor's discretionary profit sharing contributions as well as the actual earnings thereon is based on years of continuous service, as illustrated below:

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

##### *Payment of Benefits*

On termination of service due to death, disability or retirement after age 55, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments.

In-service distributions are permissible for participants that have attained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their vested account balance.

In conditions of "financial hardship", a participant may apply to the plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

##### *Forfeited Accounts*

For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$294,214 and \$208,983, respectively. Forfeitures can be used to pay for Plan fees or to reduce employer contributions. For 2024, \$214,216 was used to pay for Plan fees and \$-0- was used to reduce employer contributions.

#### NOTE 3 PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

#### NOTE 5 TAX STATUS

The Plan Sponsor has adopted a prototype plan which has received an opinion letter from the IRS dated June 30, 2020, which states that the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Furthermore, the Plan has been amended since receiving the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, therefore, no provision for income taxes has been included in the Plan's financial statements.

#### NOTE 6 NONPARTICIPANT-DIRECTED INVESTMENTS

#### NOTE 7 FAIR VALUE MEASUREMENTS

GAAP provisions for Fair Value Measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP provisions for Fair Value Measurements are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

*Mutual Funds:* Value at the net asset value ("NAV") of shares held by the Plan at year end.

*Common-Collective Trust:* Investment fund formed by the pooling of investments by institutional investors, such as a group of not necessarily affiliated pension or retirement plans, typically with the intention of achieving cost savings over similar investment options such as mutual funds. Common/collective trusts are similar to mutual funds, with a named investment manager and documented investment objective. These investments, however, are not registered with the SEC (unlike mutual funds, which are registered) and participation is not open to the public. The NAV is measured by the custodian or investment manager as of the close of regular daily trading. When measuring the fair value of such funds, the NAV, as provided by the fund sponsor, is corroborated with observable inputs provided by pricing services for the securities. In certain instances, NAVs may require adjustments to more appropriately reflect the fair value. No adjustments to NAVs were required.

*Life Insurance Policies:* Valued at cash surrender value of each policy held by participants.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
