Notes to Financial Statements

1. DESCRIPTION OF PLAN

The following description of the Collins & Collins, LLP 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Collins & Collins, LLP (the Firm). The Plan covers employees who are at least 21 years old and have completed six months of service. Nonresident aliens and employees covered by a collective bargaining agreement are excluded from the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants will be eligible for nonelective employer contributions and matching employer contributions after completing eligibility requirements as defined by the Plan.

Contributions

Participants may contribute a portion of their annual compensation, as defined in the Plan. Participants who have attained age 50 before the Plan year-end are also eligible to make additional catch-up contributions. Participants may roll over eligible amounts from other qualified plans to the Plan. After-tax and roth contributions are accepted by the Plan. All employer contributions allocated to the participant are invested as directed by the participant. The Firm matches 25% of the total employee contributions, with a maximum matching contribution of 6% of the employee's compensation, subject to certain limitations. In addition, the Firm may elect to make additional discretionary profit sharing contributions. The Firm did not make any profit sharing contributions during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Firm's contribution and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on the participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

Forfeited accounts include the non-vested portion of the Firm's contributions, including any realized earnings thereon, previously allocated to former participants in the Plan. Forfeited balances may be used to reduce future Firm contributions or to pay administrative expenses based on plan sponsor's discretion. At December 31, 2024 and 2023, there were forfeited balances of \$3,355 and \$3,263, respectively. In 2024, no forfeiture balances were used to pay employer contributions or administrative expenses.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Firm's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service.

Distribution of Benefits to Participants

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or have the amount rollover to an individual retirement account or to another employer's tax qualified plan.

Individual vested balances less than \$5,000 for terminated participants will be rolled over to an individual retirement plan designated by the Plan Administrator. Individual balances less than \$1,000 for terminated participants will be distributed in a single lump-sum directly to the participant without the participant's consent.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are limited to two outstanding loans at any one time. Loan transactions are treated as a transfer to (from) the investment fund to (from) the participant loan fund. Under no circumstances shall the repayment terms of loan be more than 5 years; provided, however, in the event the loan proceeds are used to acquire the principal residence of the borrower, the 5 year repayment rule may be extended to 10 years. The loans are secured by the vested balance in the participants' account and bear interest at prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. In the event of the participant's termination from employment, the remaining payments on the loan will be due immediately.

2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investment fees charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The Firm has agreed to bear some expenses related to the plan administration, at its option and are excluded from these financial statements. Fees related to specific participant transactions, such as for participant loans and distributions, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The Plan's administrator has made a number of estimates and assumptions relating to the reporting of assets, liabilities, additions and deductions and disclosure of contingent assets and liabilities to prepare these financial statements in accordance with accounting principles generally accepted in the United States of America. Accordingly, actual results may differ from those estimates.

3. CERTIFICATION BY TRUSTEE

Ascensus, LLC, the trustee of the Plan, has certified that the following information included in the financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024, is complete and accurate:

- a. Investments and notes receivable from participants as included in the Statements of Net Assets Available for Benefits.
- b. All information pertaining to investment income and expenses in the Statement of Changes in Net Assets Available for Benefits.
- c. Schedule of Assets (Held at End of Year).
- d. Party-in-interest transactions.

4. PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by The Vanguard Group, Inc. Vanguard engages Ascensus, LLC to provide recordkeeping and administrative services for the Plan. As a result, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as allowable party-in-interest transactions. For the year ended December 31, 2024, fees paid by the Plan for administrative services amounted to \$32,081.

5. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under ASC 820 with the related inputs to the valuation methodology are described as follows:

Level 1 - Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments in Level 1 include listed equities and other securities held in the name of the Plan, and exclude listed equities and other securities held indirectly through commingled funds.

Level 2 - Pricing inputs, including broker quotes, are generally those other than exchange quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value is determined through the use of models or other valuation methodologies.

5. INVESTMENTS AND FAIR VALUE MEASUREMENTS (Continued)

Level 3 - Pricing inputs are unobservable for the investment and include situations where there is little, if any market activity for the investment. The inputs into the determination of fair value require significant management judgment or estimation. Investments that are included in this category generally include privately held investments and partnership interests.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds (Registered Investment Companies)

Mutual funds are valued at their quoted market prices.

Money Market Account

The money market account is valued at the daily closing net asset value of the respective fund.

Common/Collective Trust Funds

Valued at the net asset value of units of the common/collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. The common/collective trust funds have no unfunded commitments, have daily redemption frequency, and no redemption notice period, except for the Fidelity Advisor Stable Value II, which requires a 12 month written notice and therefore reserves the right to temporarily delay withdrawal from the trust in order to ensure that the liquidations will be carried out in an orderly business manner.

6. CONCENTRATION OF MARKET AND CREDIT RISK

The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such instruments. The Plan's concentration of credit risk and market risk is dictated by the Plan's provisions as well as those of ERISA and the participants' investment preferences. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in risks in the near term could materially affect participant account balances and the amounts reported in the financial statements.

7. TAX STATUS

The underlying Volume Submitter plan has received an opinion letter from the Internal Revenue Service on June 30, 2020 stating that the written form of the underlying volume submitter is qualified under section 401(a) of the Internal Revenue Code (the Code), and that any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of the Code. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan takes an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
