Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pala 401(k) Retirement Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Pala 401(k) Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule of Assets (Acquired and Disposed of Within Year) for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1. DESCRIPTION OF PLAN

The following description of the Pala 401(k) Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General Plan Description and Eligibility

The Plan is a qualified salary reduction plan under Section 401(k) of the Internal Revenue Code (IRC), which covers all employees of the Pala Band of Mission Indians (Sponsor) who are at least 18 years of age and have completed at least one year of continuous service and worked 1,000 hours during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Coronavirus Aid, Relief, and Economic Security Act (CARES Act) Provisions

The Plan implemented certain requirements by the CARES Act, which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspense required minimum distributions, and delay the commencement date for required minimum distributions. The optional features within this act were implemented during the year ended December 31, 2020. On July 7, 2022, the Plan was formally amended to adopt the applicable provisions of the CARES Act.

Setting Every Community Up for Retirement Act 2.0 of 2022 (SECURE Act) Provisions

The Plan has implemented certain directives, where applicable, of the SECURE Act, which contain several provisions affecting retirement plans in the areas of distributions and loans. On July 7, 2022, the Plan was amended to adopt initial applicable provisions of the Setting Every Community Up for Retirement Act of 2019. Additional written amendments to the Plan to reflect operational changes for the provisions that were passed into law in 2022 will be adopted at a later date in accordance with applicable Internal Revenue Service (IRS) guidance.

Contributions

Participants may voluntarily contribute to the Plan a percentage of their wages subject to IRS limitations. The Sponsor matches 50% of the first 7% that the employee contributes. The Sponsor may make additional matching contributions at its discretion. Roth contributions are allowed under the Plan. Participants may also roll over amounts representing distributions from other qualified defined contribution plans.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contribution and, (b) Plan earnings, and charged with administrative expenses directly related to the participant's account. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon retirement, death, or disability, the balance in the participant's separate account is paid to the participant or their beneficiary in a lump sum or an annuity.

In the event of the termination of a participant's employment for reasons other than those cited above, a participant is entitled to receive all respective voluntary contributions and vested Sponsor matching contributions.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions among investment choices in increments of one percent.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Loan terms are limited to 5 years unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate based on the prime rate of interest. Principal and interest is paid ratably through payroll deductions. The loan policy allows for one loan refinance excluding those loans for purchase of a primary residence.

Forfeited Accounts

Forfeitures remain in the Plan and may be used for several purposes, such as the payment of Plan expenses. Any forfeiture not used by the Plan will be used to reduce the Sponsor's contributions to the Plan. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$20,430 and \$46,387, respectively. During the year ended December 31, 2024, forfeitures of \$61,575 were used to pay Plan expenses.

Vesting

Participants are always fully vested in their own contributions plus actual earnings thereon. Vesting of Sponsor matching contributions begins at 25% after one year of service and increases 25% each year thereafter until fully vested.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments is reported in the statement of changes in net assets available for benefits and consists of the realized gains and losses and the unrealized appreciation and depreciation of these investments.

Employer Contributions

The Sponsor's elective matching contributions are accrued in the period to which they relate.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

NOTE 3. INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Alerus Financial, N.A.

NOTE 4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. In addition, forced liquidation due to the complete or partial termination of the Plan, although not expected at this time, may affect the estimated value of the collective investment trust.

NOTE 5. NET ASSETS AVAILABLE FOR PLAN BENEFITS

As of December 31, 2024, there were no outstanding amounts to be paid from net assets available for plan benefits to withdrawing participants.

NOTE 6. TAX STATUS

Effective January 1, 2022, the Plan adopted an amended and restated prototype plan document sponsored by Alerus Financial, N.A. The prototype plan received an opinion letter from the Internal Revenue Service, dated June 30, 2020, which states that the plan document satisfies the applicable provisions of the IRC. The Plan has been amended since receiving this opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

NOTE 7. FAIR VALUE MEASUREMENTS

The Plan follows a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

NOTE 7. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds are deemed to be actively traded.

Collective investment trust: The collective investment trust consists of investments in the Morley Stable Value Fund. It is valued at the NAV as calculated by the funds daily. The NAV is based upon the market value of the underlying investments and the contract value which is based on the provisions of the underlying guaranteed investment contract.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 8. PLAN TERMINATION

While the Sponsor has not expressed any intent to terminate the Plan, it is free to do so at any time subject to the provisions set forth by ERISA. In the event the Sponsor terminates the Plan, each participant automatically becomes fully vested in his or her separate account balances.

NOTE 9. ADMINISTRATIVE AND TRANSACTION EXPENSES

Certain expenses of the Plan are paid by the Sponsor and therefore excluded from these financial statements. Fees for the administration of notes receivable from participants and maintenance of participant accounts are included in administrative expenses and charged directly to the participant's account.

NOTE 10. DUE FROM/TO BROKER

Due from and due to broker balances represent the amounts receivable or payable for securities that have not yet settled. The amount due from broker was \$0 and \$366 at December 31, 2024 and 2023, respectively. The amount due to broker for securities purchased was \$1,315,298 and \$19,775 at December 31, 2024 and 2023, respectively.

NOTE 11. PARTY-IN-INTEREST

For the year ended December 31, 2024, the Plan paid administrative fees to Alerus Financial, N.A., the custodian of the Plan, and these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, fees paid to Alerus Financial, N.A. for administrative expenses amounted to \$152,371.

NOTE 12. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2025 the date the financial statements were available to be issued.
