As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan

The following description of the InterHealth Medical Staffing Solutions 401(k) Plan (f/k/a Iminary Healthcare Staffing 401(k) Plan) (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

(a) General

The Plan is a defined contribution plan sponsored by TGH Staffing, LLC dba InterHealth Medical Staffing Solutions (the “Organization”) for the benefit of its employees. There are no age or service requirements to enroll in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). TGNP M1, LLC and TGNP M2, LLC were added as participating employers of the Plan effective January 21, 2024.

Effective March 1, 2024, the name of the Organization was changed from TGH Staffing, LLC dba Iminary Healthcare Staffing to TGH Health Care Staffing Solutions, LLC dba InterHealth Medical Staffing Solutions, and the name of the Plan was changed from Iminary Healthcare Staffing 401(k) Plan to InterHealth Medical Staffing Solutions 401(k) Plan.

The Plan operates under an agreement with VALIC Trust Company Inc. (“VTC”) to serve as trustee of the Plan. The Variable Annuity Life Insurance Company (“VALIC”) is the custodian of the fully benefit-responsive investment contract. VALIC Retirement Services Company is the recordkeeper for the Plan.

(b) Contributions

Each year, participants may contribute up to the maximum amount of annual compensation allowable by law as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. In addition, an automatically enrolled participant may elect to withdraw his or her contributions, including earnings thereon, within 90 days of the first automatic contribution. Effective January 21, 2024, the Organization amended the Plan to add a fixed tiered employer matching contribution of 100% up to 3% of plan compensation and 50% from 3% to 5% of plan compensation. Participants must attain age 21 and complete one year of service to be eligible for employer matching contributions. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

(1) Description of Plan - Continued

(c) Participant Investment Account Options

The Plan currently offers various mutual funds, a self-directed brokerage account and a guaranteed investment contract as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

(d) Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(e) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Prior to January 1, 2023, the Organization made safe harbor matching contributions, which were also immediately vested. Vesting in the Organization's contributions other than safe harbor matching contributions is based on years of continuous service. A participant is 100% vested after 3 years of credited service. Regardless of the vesting schedule, a participant becomes 100% vested in the event of death, disability or attainment of normal retirement age (defined as age 62).

(f) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

(g) Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or a partial lump sum. If a terminated participant's vested balance is between \$1,000 and \$5,000 and the participant does not consent to a distribution, the participant's vested balance will be automatically rolled over to an IRA selected by the plan administrator. If a terminated participant's vested balance is \$1,000 or less, the participant's vested balance will be automatically distributed to the participant in a lump sum, even if the participant does not consent to a distribution. The Plan also provides for in-service withdrawals for those age 59 ½ or older and for hardship withdrawals in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

(h) Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,437 and \$3,126, respectively. These accounts will be used to reduce future employer contributions or to pay plan expenses. For the year ended December 31, 2024, no forfeited nonvested accounts were used for any purpose.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(d) Contributions

Contributions from Plan participants and the matching contributions from the Organization are recorded in the year in which participant contributions are withheld from compensation.

(e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

(f) Payment of Benefits

Benefits are recorded when paid.

(g) Administrative Expenses

Certain expenses of the Plan are paid by the Organization and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(3) Information Prepared and Certified by the Trustee and Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, VTC and VALIC, the trustee and custodian of the Plan, respectively, have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Mutual funds, at fair value
- Self-directed brokerage accounts, at fair value
- Guaranteed investment contract, at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividends
- Interest income on guaranteed investment contract
- Interest income on notes receivable from participants
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: Valued based on the underlying investments held in the brokerage accounts.

(5) Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract with VALIC. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. The crediting interest rate is reviewed at least annually for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

(5) Fully Benefit-Responsive Investment Contract - Continued

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

(6) Related Party Transactions and Party-in-Interest Transactions

VALIC holds the fully benefit-responsive guaranteed investment contract in a general account. VALIC is the custodian and recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions.

VALIC provides certain administrative services to the Plan pursuant to a Service Provider Agreement. VALIC receives revenue from mutual fund service providers for services VALIC provides to the funds. This revenue is used to offset certain amounts owed to VALIC for its administrative services to the Plan. The Plan or Plan Sponsor may make payment to VALIC for administrative expenses not covered by revenue sharing. The Plan made direct payments to VALIC of \$892 for the year ended December 31, 2024, which was not covered by revenue sharing. Fees paid by revenue sharing are included in net appreciation in fair value of investments. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

(7) Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(9) Tax Status

The Organization has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(10) Risks, Uncertainties and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(11) Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued, and noted the following items for disclosure:

Effective January 1, 2025, the Plan was amended to remove the employer fixed matching contribution provision and add a discretionary matching contribution provision. In addition, the Plan was amended to add a provision for safe harbor matching contributions of 100% of participants' deferrals up to the first 3% of plan compensation, plus 50% of participants' deferrals up to the next 2% of plan compensation.

Also effective January 1, 2025, the Board of Directors of the Organization approved the following operations amendments to the Plan which are available under the SECURE Act 2.0: (a) permitting withdrawals for emergency expenses, (b) increasing the dollar limit for mandatory distributions from \$5,000 to \$7,000, (c) permitting for qualified birth or adoption distributions, (d) permitting a surviving spouse to elect to be treated as the employee for purposes of the required minimum distribution rules, and (e) permitting for qualified disaster recovery distributions. The Board of Directors intends to formally adopt these provisions by the requisite deadline.

Effective September 8, 2025, all plan assets were transferred from VTC and VALIC to Fidelity Management Trust Company, who began serving as trustee of the Plan. In conjunction with this transfer, Fidelity Workplace Services LLC began serving as the Plan's recordkeeper.
