Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – PLAN DESCRIPTION

The following description of the Kureha America, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

A. GENERAL

The Kureha America, Inc. 401(k) Plan is a qualified defined contribution plan covering the eligible employees of Kureha America, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Participation in the Plan is voluntary.

B. ELIGIBILITY

All Employees of the Company are eligible to participate in the Plan on the entry date subsequent to the employee's 3 month period of their initial date of employment, The Plan has an automatic enrollment feature whereby employees who do not make a positive election to waive participation will be automatically enrolled at a 3% deferral rate 90 days from their initial date of hire.

C. CONTRIBUTIONS

Participants may contribute up to 100 percent of their compensation, as defined in the Plan, subject to certain Internal Revenue Service (IRS) limitations. Those participants who are aged 50 or over by the end of the calendar year are eligible to make catch-up contributions up to the IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan also allows for Roth (after tax) contributions.

The Plan has an automatic increase feature in which those participants enrolled using automatic enrollment will have an automatic increase by 1% of compensation per year up to a maximum of 5% of compensation as of June 1st of each calendar year.

The firm provides a match to all eligible participants. The employer match will equal 100% of salary deferrals that do not exceed 3% of compensation, plus 50% of deferrals between 3-5% of compensation.

D. PARTICIPANT ACCOUNTS

Each participant account is credited with the participant's elective contributions, employer contributions, and allocations of plan earnings and administrative expenses. Allocations are based on the participant earnings or account balances, as defined. Forfeited balances of terminated participants' non-vested accounts are used to reduce future employer contributions. The benefit to which a participant is entitled is the participant's vested account balance.

E. NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest principal amount of any other loan outstanding within the past 12-months, or 50 percent of their vested account balance less the total amount of all loans outstanding during the year. Loan terms range from one to five years and thirty years for the purchase of a primary residence. Participant loans are secured by the balance in the participant's account and bear interest at a rate 1.0 percentage point above the prime rate as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions and are recorded when received.

NOTE 1 – PLAN DESCRIPTION – (CONTINUED) –

F. PAYMENT OF BENEFITS

At retirement (normally age 65) or upon termination of service, death or disability, a participant may receive a lump-sum amount equal to the value of his or her vested account. Participants should refer to the Summary Plan Description for more complete information regarding payment of benefits. The Company also offers hardship distributions for eligible participants.

G. VESTING

Participants are immediately vested in their salary deferrals, rollover contributions, employer match safe harbor contributions, and profit sharing contributions.

H. PLAN EXPENSES

Expenses relating to the administration of the Plan are to be paid out of the Plan's assets and allocated among participant accounts proportionately. Certain other expenses may be charged to specific participant accounts (loan or distribution fees).

I. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination or partial termination, each participant would become immediately 100 percent vested in their account balance.

NOTE 2 – ACCOUNTING POLICIES

A. FINANCIAL REPORTING FRAMEWORK

The accompanying financial statements are prepared according to accounting principles generally accepted in the United States of America ("GAAP"), as promulgated by the Financial Accounting Standards Board ("FASB") in the Accounting Standards Codification ("ASC").

B. BASIS OF ACCOUNTING

The financial statements of the plan are prepared on the accrual basis of accounting.

C. ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

D. INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

NOTE 2 – ACCOUNTING POLICIES – (CONTINUED) –

D. INVESTMENT VALUATION AND INCOME RECOGNITION – (CONTINUED) –

Investment income (loss) is recorded when earned, on the accrual basis, and allocated to each participant's account daily based on the number of shares held in each participant account. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

E. NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

F. PAYMENT OF BENEFITS

Benefits are recorded when paid.

G. RISKS AND UNCERTAINTIES

The Plan provides for various investment options. Investment securities are exposed to various risks including but not limited to, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

H. SUBSEQUENT EVENTS

The Plan evaluated subsequent events through October 3, 2025, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financial statements and notes thereto.

NOTE 3 – FORFEITED ACCOUNTS

As all contributions are immediately 100% vested, there are no forfeitures included in the plan.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan's investments are held in a trust fund administered by Principal Life Insurance Company, the trustee of the Plan. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the trustee:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – PARTY-IN-INTEREST

Certain Plan investments are shares in investments managed by the Trustee and, therefore, these transactions qualify as party-in-interest transactions. The Plan also has notes receivable from participants that qualify as party-in-interest transactions. The total party-in-interest balances were the following as of December 31:

NOTE 7 – GUARANTEED INVESTMENT CONTRACT

The Plan has a fully benefit-responsive investment contract with Principal, whose balance was \$403,896 and \$468,196 as of December 31, 2024 and 2023, respectively. Principal maintains the contributions in an unallocated fund within its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Since this contract meets the fully benefit-responsive contract criteria, the contract is included in the financial statements at contract value as reported to the Plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the insurance company. Such events include, but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from Plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with participating employers; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business. Such events also include: (1) removal from the Plan of one or more groups of classifications of participants; (2) partial or complete Plan termination; or (3) Plan disqualification. The Plan Sponsor does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at less than contract value, is probable.

NOTE 8 – FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded, and the reliability of the assumptions used to determine fair value. These levels are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 8 – FAIR VALUE MEASUREMENTS – (CONTINUED) –

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used between December 31, 2024 and December 31, 2023.

- *Collective Trust Fund* — The Collective Trust Fund is valued on a unit value basis by the fund manager or general Employee and is reviewed by the Plan's fiduciaries for reasonableness. The unit value is used as a practical expedient for fair value.
- *Mutual Funds* — Mutual Funds are investment vehicles stated at fair value based on quoted market prices reported by the Trustee.
- *Pooled Separate Accounts* — Pooled Separate Accounts: separate accounts are valued at the market value of the underlying assets of the separate account plus income accrued but not yet received less operating expenses accrued but not deducted, if any. If there is no readily available market for a particular asset, then the fair value is determined by Principal Life using generally accepted accounting practices and applicable law.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
