### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan of San Antonio Lighthouse for the Blind, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE A – DESCRIPTION OF THE PLAN**

The following description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan, adopted on October 1, 2003, covering virtually all employees of San Antonio Lighthouse for the Blind dba Vibrant Works ("Sponsor"), exclusive of non-resident aliens with no U.S. source income and employees who are eligible to make salary reduction contribution to another plan of the Sponsor. There are no minimum age or service requirements to make salary reduction contributions. The Plan is for the exclusive benefit of its participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Plan Amendment:* The Plan was amended and restated effective January 1, 2015, and operationally adopted certain provisions allowed by the Bipartisan Budget Act of 2018. Effective January 1, 2019, participants receiving hardship withdrawals were no longer required to cease their elective deferral contributions to the Plan. The Plan was formally amended for this change July 21, 2020.

The Plan is in the process of being amended to implement certain changes permitted by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which changes the Plan to allow certain eligible individuals to receive coronavirus-related distributions, suspend required minimum distributions, and delay the commencement date for required minimum distributions.

*Secure 2.0 Act:* The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2024 and later.

*Contributions:* Participants may contribute up to 100% of their compensation either on a pretax or after-tax Roth basis, subject to the limitations of IRC section 402(g). Participants may also contribute amounts representing distributions ("rollovers") from other qualified defined benefit or contribution plans. The Sponsor makes a safe harbor matching contribution of 100% of the participant's elective deferral up to 6% of the participant's contributions, not to exceed IRS limits.

*Participant Accounts:* Each participant's account is credited with their contribution and allocations of a) the Plan Sponsor contributions, b) Plan earnings, and c) charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are immediately 100% vested in their voluntary contributions and any earnings thereon, as well as the Sponsor's safe harbor matching contributions and earnings thereon.

*Payment of Benefits:* On termination of service due to death, disability or retirement, a participant may elect to receive payment of the vested account balance. If the total vested account balance is less than \$5,000, the vested account will be rolled over to an Individual Retirement Account if withdrawal of the funds is not initiated by the participant. Account balances less than \$1,000 are distributed to participant as a lump-sum distribution. Hardship withdrawals are available subject to certain limitations. In service distributions are available once the participant attains age 59.5.

*Plan Termination:* Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

*Participants' Notes Receivable:* Participants may borrow from their account a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Participants may have only one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a range set by the Plan administrator, which currently ranges from 3.25% to 5.850%. Loans must be repaid within 5 years unless otherwise approved.

**NOTE B – SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Presentation:* The financial statements of 403(b) Thrift Plan of San Antonio Lighthouse for the Blind ("Plan") are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

*Investment Valuation and Income Recognition:* Investments in mutual funds, held in pooled separate accounts, are reported at fair value of the underlying investment. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisers and the custodian.

Investments in the guaranteed interest account are held in the general accounts of Mutual of America and are carried at contract value. The contracts are fully benefit-responsive.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Participants' Notes Receivable:* Participants' notes receivable are stated at their unpaid principal balance plus any accrued interest. Interest is recognized as accrued. An allowance was not required at either year end. If a participant ceases to make a note repayment and Plan administrator deems the participant note to be in default, the note balance is reduced and a benefit payment to the participant is recorded.

*Benefit Payments:* Benefits are recorded when paid.

*Subsequent Events:* Subsequent events have been evaluated by management through the date of the independent auditor's report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

*Use of Estimates:* The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**NOTE C – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)**

As permitted by Department of Labor CFR 2520.103–8, investments and participant notes receivable at December 31, 2024 and 2023 and the net appreciation and other income thereon for the years then ended, were certified and held by Mutual of America, the Custodian of the Plan, and were not audited by the independent auditor.

**NOTE D – TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan’s administrative expenses are paid either by the Plan or the Plan Sponsor as allowed by the Plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments.

**NOTE E – GUARANTEED INTEREST ACCOUNTS**

The Plan has a fully benefit–responsive guaranteed interest contract with Mutual of America (M of A). M of A maintains the contributions in a general account. The investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The contract value is \$4,520,674 at December 31, 2024 and \$4,506,417 at December 31, 2023. There are no reserves against contract value for credit risk or the contract issuer or otherwise.

Because the guaranteed interest contract is fully benefit–responsive, it is stated at contract value, the amount the participant would receive if they were to initiate permitted transactions under the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan’s ability to transact at contract value with participants are probable of not occurring. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE F – FAIR VALUE MEASUREMENTS**

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
  - quoted prices for identical or similar assets or liabilities in inactive markets
  - inputs other than quoted prices that are observable for the asset or liability
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means
  - if the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following table sets forth by level, within the fair value hierarchy, investments measured at fair value:

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE G – INCOME TAX STATUS**

Management adopted a preapproved specimen plan document sponsored by Mutual of America, which has been accepted under section 403(b) of the Internal Revenue Code under an opinion letter from the IRS dated March 31, 2017. Management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Accordingly, no provision for Federal income taxes has been included in these financial statements. The Plan Administrator is not aware of any tax positions that would have a significant impact on the Plan's financial position. Its federal tax returns for the last five years remain subject to examination.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
