Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of Loth Holdings, LLC Profit Sharing and 401(k) (the "Plan") have been prepared on an accrual basis of accounting using accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

Notes Receivable

Notes receivable from participants shall be measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Single Employer Plan

Loth Holdings, LLC Profit Sharing and 401(k) is classified as a single employer plan covering related employers. The related employers covered by the Plan are Loth Holdings, LLC, Loth, Inc., and OptiVia Solutions, LLC, collectively the Company.

Related Party Transactions

Plan investments are held in a Trust exclusively managed by Empower Trust Company. Empower Trust Company is the trustee and record keeper as defined by the Plan, and therefore these transactions qualify as party-in-interest.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

Notes to Financial Statements (Continued)

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Management believes that the estimates utilized in preparing its financial statements are reasonable and prudent.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

In preparing its financial statements, the Plan Sponsor has evaluated subsequent events through October 8, 2025 which is the date the financial statements were available to be issued.

NOTE 2 PLAN DESCRIPTION

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The original effective date of the Plan was January 1, 1984. The Plan is a defined contribution plan. The Plan is available to all full-time employees of the Company, who are not covered by collective bargaining agreements and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective June 1, 2024 the Plan changed its name from Loth, Inc. Profit Sharing and 401(k) Plan to Loth Holdings, LLC Profit Sharing and 401(k) Plan.

Contributions

A participant may contribute up to 50 percent of pretax annual compensation, as defined in the Plan. Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. Contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended, IRC, (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500.

The Plan also includes a Roth feature whereby participants are able to make qualifying after-tax contributions.

The Plan has adopted provisions to allow for automatic enrollment into the Plan. When new participants become eligible to participate in the Plan, deferrals will be made on their behalf at 6%, unless the participant elects a different deferral percentage or not to participate in the Plan. The Plan has also adopted provisions to allow for automatic deferral escalation. When participants become eligible to participate in the Plan, deferrals made on their behalf will increase by 1% each Plan Year until the amount withheld from their paycheck reaches 10% of their compensation, unless the participant elects a different deferral percentage or not to participate in the Plan.

Notes to Financial Statements (Continued)

NOTE 2 PLAN DESCRIPTION (CONTINUED)

The Plan allows for the Company to make discretionary employer matching contributions throughout the Plan year and discretionary profit sharing contributions at the end of each Plan year. The Company made discretionary matching contributions of 25% of each participant's elective deferrals, up to a maximum of 6% of eligible annual contributions subject to certain limits required by the IRC for the Plan years ending December 31, 2024 and 2023. The Company did not make a discretionary profit sharing contribution in 2024.

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Participants vest in the Company's matching and discretionary contributions based on years of continuous service. Participants become partially vested in Company contributions after two years with 100% vesting being attained after six years.

Forfeitures

Forfeitures of the Plan are to be used to reduce administrative fees of the Plan or to reduce employer contributions. For the years ended December 31, 2024 and 2023, the balance of unallocated forfeitures was \$139,529 and \$89,992, respectively. In 2024, \$8,062 of forfeitures were used to pay Plan expenses.

Payment of Benefits

Upon a participant's termination of service, participants may receive benefits in accordance with the Plan's provisions and existing laws and regulations.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2.

In conditions of "financial hardship" a participant may apply to the Plan Administrator for approval to withdraw that portion of his 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

Notes Receivable from Participants

Notes receivable from participants are available on amounts in the participant's account. The minimum note receivable amount is \$1,000 and the maximum is the lesser of one-half of the participant's vested account balance or \$50,000. A participant is permitted to have up to two outstanding notes at any given time. All notes bear interest at a fixed rate as determined by the Plan Administrator. Note receivable terms range from one to five years or beyond five years, as agreed upon by the Participant and Loan Administrator, for the purchase of a primary residence. Outstanding note receivable balances are \$208,508 and \$66,225 at December 31, 2024 and 2023, respectively.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 TAX STATUS

The Plan Sponsor has adopted a prototype plan. The IRS has determined and informed the prototype plan by letter dated on November 14, 2022, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the prototype provider received the advisory opinion, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

- (c) The Schedule H, Line 4i – Schedule of Assets (Held at End of Year) for the year ended December 31, 2024.

NOTE 5 FAIR VALUE MEASUREMENTS

GAAP provisions for Fair Value Measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP provisions for Fair Value Measurements are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

Mutual funds: Value at the net asset value ("NAV") of shares held by the Plan at year end.

Collective investment trust: Valued based on the NAV of units of a collective trust as published by the trustee. The existence of certain conditions can limit the trust's ability of the Plan to transact with participants at fair value of the collective trust. Specifically, any event outside the normal operation of the trust which causes a withdrawal from the investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to, layoffs, bankruptcy, plant closings, plan termination, mergers, early retirement incentives, communications designed to induce participants to transfer from the fund, competing fund transfer or violation of equity wash or equivalent rules in the plan, and changes in qualification status of employer or plan. As of December 31, 2024, the occurrence of an event outside the normal operation of the trust which would cause a withdrawal from the investment contract is not considered probable.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
