Note 1 - Description of Plan

The following description of the RedViking 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all non-excluded employees of Superior Controls, Inc., dba RedViking (the Company) and its affiliated companies as described by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Trustee of the Plan is Ascensus Trust Company. The recordkeeper of the Plan is Vanguard Group, Inc. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective December 31, 2024, the Plan merged into the Lincoln Electric Company Employee Savings Plan. The net assets of the Plan totaling \$35,126,998 were transferred, which included \$239,639 of outstanding loans.

Contributions

Participants may contribute annual compensation as defined in the Plan up to a maximum allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan provides for a non-discretionary matching contribution from the Company. The Company match is 50% of the first 6% of compensation that a participant contributes to the Plan. The Company contributed \$580,839 and \$545,267 during the Plan years-ended December 31, 2024 and 2023, respectively, for matching contributions. The matching Company contribution is invested using the same allocations as participant contributions. Additionally, discretionary nonelective contributions may be made by the Company at the option of the Company's Board of Trustees and are invested using the same allocations as participant contributions. The discretionary nonelective contributions made to the Plan, if any, will be allocated to each participant's account in the ratio that each participant's eligible compensation bears to the total eligible compensation paid to all eligible participants. The Company did not make any discretionary nonelective contributions for the Plan years ended December 31, 2024 and 2023. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers 37 mutual funds and two money market fund as investment options for participants. Contributions are subject to certain limitations.

Participant's Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution, (b) the Company's profit sharing contributions (when made) and (c) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from one to five years or a term determined by the Plan Administrator for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their 401(k) voluntary contributions plus actual earnings thereon. Vesting in the employer matching and profit sharing contributions are based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$21,063 and \$22,336, respectively. These accounts will be used to reduce future employer contributions and plan expenses. Employer contributions were reduced by \$0 and \$0 from forfeited nonvested accounts during the Plan years ended December 31, 2024 and 2023, respectively. Plan expenses in the amount of \$22,331 and \$22,189 were paid from forfeited nonvested accounts during the Plan years ended December 31, 2024 and 2023, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investment. Fees for the administration of notes receivable from participants and benefit payments are included in administrative expenses and charged directly to the participant's account. Fees related to the overall operation of the Plan are deducted from the Plan's forfeiture account.

Subsequent Events

The plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

Note 3 – Certified Investments

Certain information disclosed in the accompanying financial statements, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company (the trustee of the Plan).

Note 4 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurement

A mutual fund's net asset value ("NAV") is normally calculated as of the close of business of the New York Stock Exchange. The fund's assets are valued as of this time for the purpose of computing the fund's NAV. Money market instruments are stated at fair value, which approximates cost plus accumulated interest earnings less distributions to date.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were not significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

Note 5 – Related Party and Party-In-Interest Transactions

Certain Plan investments are mutual funds managed by The Vanguard Group, Inc., the recordkeeper of the Plan and therefore, corresponding transactions qualify as party-in-interest. Fees paid to The Vanguard Group, Inc. amounted to \$26,051 and \$25,399 for the years ended December 31, 2024 and 2023, respectively.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 7 – Income Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

Note 8 – Risks and Uncertainties

The Plan provides for various investment options in a money market fund and mutual funds with underlying assets consisting of any combination of stocks, bonds, fixed income securities, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
