Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Yellowjacket Oilfield Services 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Yellowjacket Oilfield Services 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Yellowjacket Oilfield Services 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering all employees of Yellowjacket Oilfield Services, LLC (the “Company”). The Company is the Plan Sponsor. Employees of the Company are eligible to participate in the Plan on the next entry date after attainment of age eighteen (18) and completion of three (3) months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

CONTRIBUTIONS

Participants may elect to make pre-tax contributions and after-tax contributions (Roth) from eligible compensation not to exceed the limits of the Internal Revenue Service (“IRS”) Code Section 401(k). In addition, participants that reach age 50 before the close of the Plan year may make catch-up contributions. Participants may contribute amounts representing distributions from other qualified plans (“rollovers”). The Company may make discretionary matching contributions to the Plan as determined annually by the Company. In 2024, discretionary matching contributions were made equal to 100% of participant elective deferrals up to 4% of participant compensation. Matching contributions made for the year ended December 31, 2024 were \$537,859. The Company may also make a non-elective, profit-sharing contribution. The Company did not make any profit-sharing contributions to the Plan in 2024.

PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s contribution and the Company matching and profit-sharing contributions. Allocations of Plan earnings and administrative expenses are based on participant account balances as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

VESTING

Participants are immediately vested in participant and rollover contributions and actual earnings thereon. For participants hired before January 1, 2023, employer matching contributions are 100% vested. For participants hired on or after January 1, 2023, employer matching contributions cliff vest fully after one year. Vesting of employer nonelective contributions is as follows:

Full vesting also occurs at normal retirement age (65), total and permanent disability, death, or plan termination.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans bear a reasonable rate of interest as determined by the Plan Administrator through a nondiscriminatory manner. As of December 31, 2024 and 2023, notes were secured by the balance in the participant’s account and interest rates on such loans ranged from 4.25% - 10.50%. Principal and interest are paid ratably through payroll deductions.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement, a participant may elect to receive their vested benefit in a lump-sum cash payment, a direct rollover to a qualified IRA or another tax-qualified plan, partial withdrawals, or equal installments. A participant must be age 59 ½ or have incurred a financial hardship, as defined in the Plan provisions, to qualify for an in-service distribution.

FORFEITURES

Forfeitures may be used to pay Plan expenses and reduce employer contributions. During the year ended December 31, 2024, \$420 of Plan forfeiture amounts were used to pay Plan expenses and \$583 were used to reduce employer contributions. During the year ended December 31, 2024, forfeitures that were determined to be incorrectly forfeited in prior years were reinstated, and the Company funded any amounts not available in the forfeiture account as needed. At December 31, 2024 and 2023, unallocated forfeitures totaled \$-0- and \$10,176, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

USE OF ESTIMATES

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors, the custodian, and the insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

CONTRIBUTIONS

Contributions from the Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

OTHER RECEIVABLES

Amounts receivable to the Plan due to current and prior year corrective contributions not yet made are recorded as receivables in the accompanying financial statements. At January 1, 2023, prior year corrective contributions not yet made amounted to \$144,945. During the year ended December 31, 2023, additional corrective contributions and lost earnings were identified, resulting in a receivable at December 31, 2023 of \$161,564.

During the year ended December 31, 2024, \$161,564 of corrective contributions deposited into the Plan reduced the receivables account. During the year ended December 31, 2024, additional corrective contributions and lost earnings were identified, and the remaining unfunded corrective contributions as of December 31, 2024 amounted to \$488 and is recorded as other receivables in the accompanying financial statements.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurement and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts invest its assets in the shares or units of an underlying mutual fund, and the investment objective of each subaccount corresponds to the investment objective of the underlying fund. Certain underlying investment funds are considered open-end mutual funds, meaning the that the fund is ready to redeem its shares at any time and offers its shares for sale to the public, either through retail outlets or through institutional investors continuously. These investments have a readily determinable fair value and are classified within Level 2 of the valuation hierarchy.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Investment securities held by the Plan are managed by The Standard, which is a related entity of the Custodian. Accordingly, transactions with both of these entities qualify as party-in-interest transactions. The Plan also has notes receivable from participants outstanding, which are secured solely by a portion of the participant's vested account balance, in accordance with the Plan document.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - TAX STATUS

The Plan Sponsor has adopted a prototype plan which received a favorable tax determination letter dated June 30, 2020 from the IRS that it qualifies under Section 401(a) of the Internal Revenue Code ("IRC") and is, therefore, not subject to tax under present income tax law. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

NOTE 7 - TAX STATUS - CONTINUED

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment funds. Investment securities are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - CORRECTION OF OPERATIONAL ERRORS AND ERISA VIOLATIONS

During the year ended December 31, 2024, participant contributions and employer match contributions amounting to \$398, as well as lost earnings of \$90, were not remitted to the Plan. These amounts were not paid by the end of 2024 and are included within other receivables on the accompanying financial statements. Of this amount, participant contributions of \$152 and associated lost earnings of \$90 were not deposited timely by DOL guidelines. This will be included on the Schedule of Delinquent Contributions.

In addition to the errors noted above, the Plan has in prior years had participant deferrals which were not deposited into the Plan within the timeline required by the IRS and DOL guidelines, which constitutes nonexempt prohibited transactions. These late remittances are summarized in the Schedule of Delinquent Contributions by year. Lost earnings have been calculated on the late remittances. As of the date these financial statements were available to be issued, lost earnings had not yet been deposited therefore the delinquent contribution amounts remain on the schedule until they are fully corrected.

NOTE 10 - SUBSEQUENT EVENTS

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
