**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Avow Hospice, Inc. Tax Deferred Annuity Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is sponsored by Avow Hospice, Inc. (the “Organization”).

General: The Plan is a defined contribution plan originally effective June 1, 1987 and covering all full-time employees of the Organization who have completed an hour of service. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective September 1, 2019. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: The Plan includes a salary deferral arrangement allowed under Section 403(b) of the Internal Revenue Code. Eligible participants are permitted to elect to have a percentage of their compensation contributed as pre-tax or Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Organization may, at its discretion, elect to make a qualified matching contribution and profit sharing contribution to the Plan. There were no Organization profit sharing contributions for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit IRA’s. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers various variable annuity contracts and fixed interest accounts as investment options for participants. All qualified employees may make special 403(b) catch-up contributions.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, an allocation of the Organization’s matching contribution, and an allocation of Plan earnings or losses, and is charged with the participant’s withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant’s account. The benefit to which a participant is entitled is the benefit that can be provided by the participant’s account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization matching and profit-sharing contribution portion of participant accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100 percent vested after six years of credited service. A participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Principal and interest are paid ratably through the term of the loan. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years. The notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined quarterly prior to the notes application is accepted by the Plan Administrator.

Benefit Payments: Upon termination of service, death, disability, or retirement (age 65), the participant will receive the value of the interest in his or her account in the form of a lump sum distribution, installments, or annuities. The Plan allows for in-service distributions if a participant reaches age 59 ½, hardship distributions subject to Plan provisions, and early distribution for disability. If a participant terminates employment and the participant’s account balance does not exceed \$5,000, the Plan Administrator will authorize the benefit payment without the participant’s consent.

Forfeited Accounts: Participant forfeitures of employer profit sharing contributions are reallocated to the remaining participants, based upon their relative account balances. Forfeitures of employer matching contributions are used to offset future employer matching contributions or administrative expenses of the Plan. During 2024, approximately \$67,528 of forfeited employer contributions were used to offset employer contributions reflected in the financial statements. The remaining balance of forfeitures available to offset future matching contributions and administrative expenses was approximately \$2,156 and \$3 as of December 31, 2024 and 2023, respectively.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and custodian fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Organization.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contract, are reported at fair value as further described in Note 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **NOTE 3 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

### **NOTE 4 – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company (AULIC) and Voya Retirement Insurance and Annuity Company (VY).

### **NOTE 5 – FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Inputs other than quoted prices included within the Level 1 that are observable for the asset or liability, either directly or indirectly.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Variable Annuity Contracts:* The fair values of purchase units held in variable annuity contract subaccounts of AULIC and VY separate accounts are based on the net asset values reported by the AULIC and VY as of the financial statement dates and recent transaction prices. AULIC and VY variable annuity contracts, which are structured as a unit investment trust, are comprised of numerous subaccounts which each invest in a single mutual fund managed either by an affiliate of AULIC and VY or a by an independent third party. Participants direct their investments to certain of the underlying "subaccounts" of AULIC and VY separate account available to them under the Plan. Each subaccount provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

*Group Annuity Contracts:* Voya Fixed Account (FA) and Voya Fixed Plus Account (FPA) are group annuity investment contracts issued by the respective Issuers. These contracts are reported at contract value, as the Issuers and Plan management have determined contract value (level 3 inputs) to be the most reasonable estimate of fair value. Contract value equals the contributions deposited into the contracts, plus interest credited to the contracts, less contract withdrawals, and it reflects the value at which participant transactions are executed under the contracts. The contract values are guaranteed by the respective Issuers. Based upon recent credit ratings for the Issuers, management believes no adjustment to contract value is required related to credit quality.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 – INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

*Stable Value Fund:* The Plan holds a fully benefit-responsive investment contract with AULIC. The stable value fund contract is a guaranteed fund. AULIC maintains the contributions in its general account. AULIC guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than 0%. AULIC's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the issuer may terminate the contract. Examples of circumstances which would allow the issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

**NOTE 7 – INCOME TAX STATUS**

The Internal Revenue Service issued an opinion letter dated November 22, 2017 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is designed and is being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan invests in investment contracts, fixed accounts and certain variable annuity contract sub-accounts of AULIC and VY separate accounts. AULIC and VY are service providers of the Plan and, therefore, these transactions and the Plan's payment of fees to AULIC and VY qualify as party-in-interest transactions. Some administrative expenses of the Plan are paid directly by the Organization. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 9 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through October 14, 2025, which is the date the accompanying financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to add America Home Health Services, LLC, Avow Foundation, Inc., Avow Care Services, Inc., Avow, Inc., and Avow Real Estate, Inc. as participating employers in the Plan.

Revenue Sharing Formula:

The investment options of the Plan include various portfolios within an AUL separate account. The separate account in turn invests in investment portfolios of certain open-end management investment companies. AUL receives indirect compensation from these investment companies for the services provided by AUL.

The compensation received by AUL is computed by each investment company by multiplying the daily account balance of the AUL separate account's interest in a particular portfolio by a predetermined percentage rate negotiated with the investment company. This indirect compensation is not charged to the plan or participants accounts but is paid directly by the investment company.
