Notes to Financial Statements

Note 1: Description of Plan

The following description of the Madison One Holdings, LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Madison One Holdings, LLC and Affiliates (collectively the "Employer") including Bou-Matic, LLC; Dairy Xpress, LLC; and J.P. Kotts & Co. not covered by a collective bargaining agreement. Participants may enter the Plan on the first day of the month following the completion of 30 days of service. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA), as amended.

Transfers

The Employer also sponsors a 401k plan for Union employees. If participants change their employment status, their account balances are transferred to or from the corresponding plan. During the year ended December 31, 2024, participant balances of \$10,520 were transferred to the Plan from the Union 401k plan. There were no amounts transferred to the Union 401k plan from the Plan.

Contributions

Each year, participants may contribute 2% to 100% of their pretax or after-tax annual compensation, as defined in the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 4% of compensation on a pretax basis, unless they affirmatively elect not to participate in the Plan or elect a higher or lower deferral rate. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows participants to contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer may make discretionary matching contributions, qualified non-elective contributions and discretionary contributions. In 2024, the Company made discretionary matching contributions equal to 50% of participants deferrals, up to 8% of the participant's total eligible compensation. Employer discretionary matching contributions totaled \$302,475, for the year ended December 31, 2024. No Employer qualified non-elective or discretionary contributions were made during 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer discretionary matching contributions, and allocations of (a) the Employer's qualified non-elective and discretionary contributions, if any, (b) plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

A participant is fully and immediately vested in their contributions, plus actual earnings thereon. A participant is vested in Employer qualified non-elective contributions, discretionary matching and discretionary contributions and earnings thereon according to the following schedule:

Prior to July 1, 2022, participants were fully and immediately vested in Employer qualified non-elective contributions.

Participants who terminate for reasons other than death, disability, or retirement, and are less than fully vested, forfeit the nonvested portion of their account. Forfeitures of non-vested participant balances may be used to pay any administrative expenses, can be used to reduce Employer contributions, or are reallocated to remaining participants. Forfeitures amounting to \$52,084 were used to offset Employer contributions during 2024. The amount of unallocated forfeitures at December 31, 2024 and 2023, was \$1,396 and \$20,185, respectively.

Notes Receivable From Participants

Participants may borrow from their accounts up to the lesser of \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made, or, 50% of the participant's vested balance. The minimum amount of any loan is \$1,000 and loan terms range from one to five years except loans used to acquire a principal residence may extend up to 15 years. Loans are secured by the participant's investment accounts and bear an interest rate at 5.00-10.25%, which is commensurate with local prevailing rates as determined by the plan administrator at the time of loan origination. Principal and interest generally is paid ratably through payroll deductions.

Note 1: Description of Plan (Continued)

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or monthly installments over various periods. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or leave the account under the Plan, except participants with balances below \$5,000 will be paid only a lump sum amount. The Plan also permits in-service distributions to participants over the age of 59 ½ or in the case of financial hardship.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to benefit payments and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 1 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: Investments in pooled separate accounts are valued using a readily available fair value based on the fair value of the underlying securities in which the account is invested. The readily determinable fair value is used if the fair value per share is determined and published and is the basis for current transactions. There are currently no redemption restrictions or unfunded commitments on these transactions.

Collective trust funds: Investments in common trust funds are valued using a readily determinable fair value based on the fair value of the underlying securities in which the account is invested. The readily determinable fair value is used if the fair value per share is determined and published and is the basis for current transactions. There are currently no redemption restrictions of unfunded commitments on these investments.

Note 4: Information Prepared and Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income on notes receivables from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the Custodian of the Plan.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

Fees paid during the year for administrative services rendered by parties-in-interest were based on customary and reasonable rates for such services. Fees incurred and paid by the Plan for plan administration and recordkeeping services were \$4,080 for the year ended December 31, 2024. Certain legal, accounting, and administrative expenses relating to the maintenance of the Plan are paid by the Employer. Certain plan investments are pooled separate accounts and collective trust funds managed by affiliates of Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the Custodian. Transactions involving these investments are considered transactions with parties-in-interest.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

Note 7: Tax Status

The Employer adopted a nonstandard pre-approved document with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
