Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The Inland Empire IBEW-NECA Health Plan (the "Plan") is a multi-employer health benefit plan created in 1993 for the purpose of providing life, accidental death and dismemberment, hospital, medical, dental, vision and prescription drug benefits to eligible employees, beneficiaries, and dependents of participating employers who are signatory to a collective bargaining agreement between Local 477 of the International Brotherhood of Electrical Workers (IBEW) and the National Electrical Contractors Association (NECA). The Plan also provides certain medical, dental, vision and prescription drug benefits for retirees.

The Plan provides eligible employees, beneficiaries and dependents with hospital and medical benefits under an indemnity plan and an HMO plan. Benefits are provided through Kaiser Foundation Health Plan, Inc., a health maintenance organization (HMO), and Elevance Health preferred provider organization. Life insurance and accidental death and dismemberment coverage are provided through contracts with Symetra. Anthem Blue Cross also provides an Employee Assistance Program. Stop-loss medical coverage is provided through a contract with Berkshire Hathaway. Retirees' supplemental Medicare coverage is provided through Anthem Blue Cross or Kaiser Foundation Health Plans, Inc.

The Plan also provides prescription drug benefits. Vision benefits are provided through Vision Service Plan (VSP). Dental benefits are through United Concordia.

Dental and vision coverage for all retirees is provided on a self-pay basis.

The agreement and declaration of trust creating the Plan provides that the Plan will be administered by representatives from the Southern Sierras Chapter, NECA and representatives from Local 477 of IBEW. The Board of Trustees is the plan sponsor and the named fiduciary. The Board of Trustees establish (and amend from time to time) the Plan and its operating and eligibility rules and plan benefits. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting periods. Actual results may differ from those estimates.

C. Postretirement Benefits

In accordance with the plan document, certain benefits of the Plan are provided for retirees who meet the eligibility requirements established by the Board of Trustees. Self-payments are required for the program of benefits. Self-payment rates are set by the Board of Trustees.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

C. Postretirement Benefits (Continued)

Resources to fund these benefits (other than the self-payments made by retirees) have not been provided for as these benefits are funded on an ongoing basis and are included in the current contribution rates. Retiree benefits are offered to eligible retirees on a month to month basis only. The Board of Trustees reserve the right to change, modify or terminate retiree benefits, in whole or in part, at any time.

The Board of Trustees wish to reaffirm that this Plan does not have a lifetime obligation to provide postretirement welfare benefits. Postretirement benefit obligations are reported for compliance reasons only.

Postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31, 2024 and 2023. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of expected postretirement benefit obligations is determined by an actuary and is the amount that results from applying actuarial assumptions to historical benefit cost data to estimate future annual incurred benefit costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 5% annual rate increase in the medical, dental and vision per capita cost of covered benefits was assumed for 2024 and 2023.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by 1% in each year, it would increase the net obligation as of December 31, 2024 and 2023 by \$6,504,110 and \$7,338,688, respectively. However, as noted above, the net obligation (and any increases in the net obligations) are reported for compliance purposes only as there is no obligation for the Plan to provide lifetime postretirement welfare benefits and benefits may be modified or terminated at any time. Participants paid approximately 34% and 36% in 2024 and 2023, respectively, of the total cost of benefits provided by the Plan.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

In its measurement of the accumulated postretirement benefit obligation and changes in benefit obligations, the Plan has included the effects of the Medicare subsidy in prescription drug benefits in compliance with the Medicare Prescription Drug, Improvement and Modernization Act of 2003. For 2024 and 2023, the Plan's Medicare Part D subsidies were \$25,102 and \$27,860, respectively.

D. Employer Contributions

Under the terms of the Collective Bargaining Agreement employers contribute to the Plan at a fixed rate per hour of work. Employer contributions as reported are contributions made by employers on behalf of employees for months worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year for hours worked during the year. Known and uncontested delinquencies are included. No allowance is provided for uncollectible accounts.

E. Employer Payroll Compliance Program

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' payroll records under a separate payroll compliance program.

F. Benefits

The obligation for "Total Obligations Other Than Postretirement Benefit Obligations" represents an estimate, as of the end of the year, of the future benefit costs to be incurred based on participants' accumulated eligibility credits. Estimated claims incurred but not reported represents claims incurred during the year but not reported, nor paid. Premiums payable, if any, is calculated from the premiums paid subsequent to the end of the year to each provider, on behalf of active participants. The claims payable is estimated based upon the claims paid during the year on behalf of participants.

G. Claims Examinations

A program of testing benefit payments, on a sample basis, is conducted by the Plan's independent auditors under a separate continuing claims examination engagement. Periodic claims reports are submitted to the Board of Trustees.

H. Tax-Exempt Status

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

H. Tax-Exempt Status (Continued)

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Administration Expenses

The Plan has engaged Delta Fund Administrators for administrative services. Delta's monthly fees are as follows:

United Administrative Services ("UAS") provides certain administrative services. Total fees paid for the years ended December 31, 2024 and 2023, were \$22,490 and \$21,577, respectively.

J. Investment Valuation and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are based on quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds valued at their quoted market prices.

Form 5500 requires realized gains and losses to be reported as the difference between proceeds from the sale or redemption of investments and the market value of the investment at the beginning of the year, for those investments on hand at the beginning of the year, or the purchase price of investments acquired during the year. The different methods of computing realized gain or loss and the appreciation of investments results in differences in reporting on the financial statements and Form 5500.

NOTE 3 - PLAN TERMINATION

Although there has been no expressed intent to do so, the Plan may be terminated in accordance with the provisions of ERISA (as amended) and related regulations. In the event of termination, the balance in the Plan, if any, shall be exhausted by continuing the benefits so long as the cash in the Plan will permit after the payment of all expenses of operating and/or winding up the Plan.

NOTE 4 - CONTINUATION OF BENEFITS (BANK HOURS PROVISION)

The plan of benefits requires 120 hours of covered employment for regular benefit eligibility. Any hours worked in excess of 120 hours per month are accumulated in an hour bank, subject to a maximum accumulation of 720 hours. Based upon a 120 hours per month eligibility requirement, a maximum accumulation of 720 bank hours would provide six months of continuous benefit eligibility.

The continuation of benefits under the bank hours provision is available to members when current employment is less than the 120 hours per month required for regular benefit eligibility. The actual liability for continuation of benefits under this provision is for any month in which current employment is not sufficient to provide regular benefit eligibility.

Bank hours shall terminate for working members (owners or corporate officers) who, after forty-five days from the receipt of a notice of delinquency from the Plan, remain delinquent in their contributions to the Plan.

At December 31, 2024 and 2023, the maximum liability for benefit continuation under the bank hours provision amounted to \$4,100,705 and \$3,647,626, respectively. The bank hours liability is calculated from the participants' banked eligibility using estimated claim rates and current premiums.

Amounts currently payable to or for participants, dependents, and beneficiaries are recorded on the Form 5500 for benefit claims that have been processed and approved for payment prior to December 31, but not yet paid as of that date.

NOTE 7 - CONCENTRATION OF CREDIT RISK

At December 31, 2024, the Plan had \$2,439,066 on deposit with US Bank, which exceeded the Federal Deposit Insurance Corporation insurance limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

NOTE 8 - RISKS AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Postretirement benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, employee demographics and other factors, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

NOTE 9 - PLAN AMENDMENTS

On March 9, 2023, the Plan adopted Amendment No. 10, effective May 12, 2023, to continue telehealth visits following the end of the COVID-19 public health emergency.

On October 26, 2023, the Plan adopted Amendment No. 11, effective May 12, 2023, to continue coverage for the over-the-counter at-home test kits after the end of the COVID-19 emergency periods.

On December 7, 2023, the Plan adopted Amendment No. 12, effective January 1, 2023, to provide certain additional benefits and to transition from a fully-insured vision plan to a self-insured vision plan.

On December 7, 2023, the Plan adopted Amendment No. 13, effective January 1, 2024, to provide separate out-of-pocket maximums for medical and prescription drug benefits.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 2, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
