INDEPENDENT AUDITORS' REPORT

To the Plan Trustees of
Mile Hi Corporate Services LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mile Hi Corporate Services LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mile Hi Corporate Services LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1 – Description of the Plan and Contributions

The following description of the Mile Hi Corporate Services LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan available to all eligible employees who have completed three months of service and are age twenty-one or older, as defined by the Plan agreement. The participating employers of the Plan are all under common control and include Mile Hi Foods Co., Mile Hi Bakery, Inc., Mile Hi Specialty Foods, Mile Hi Corporate Services, LLC, TMT Trucking, Co., Mile Hi Shop, Inc., KYTI, LLC, New PST Intermediary, LLC and Mile Hi Warehousing & Logistics (collectively the “Employer” or “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Securities Act (“ERISA”), as amended. The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Board of Directors.

Contributions: Each year, eligible participants may elect to have a portion of their pretax and after-tax eligible compensation, as defined in the Plan, deferred and contributed to the Plan. Participants who are age 50 before the end of a Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral set at 4% of eligible compensation and their contributions are invested in a designated fund until changed by the participant.

The Employer may make a discretionary matching contribution equal to a uniform percentage of participant’s eligible compensation each payroll period. During the year ended December 31, 2024, the Employer elected to make matching contributions equal to 50% of the first 4% of each participant’s eligible compensation.

In addition, the Employer may also make a discretionary non-elective profit sharing contribution to the Plan. For the year ended December 31, 2024, the Employer did not make a discretionary non-elective profit sharing contribution to the Plan. Contributions are subject to certain limitations.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Employer’s discretionary contributions; if any, (b) Plan earnings (losses), and (c) is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

See independent auditors’ report.

Note 1 – Description of the Plan: (Continued)

Vesting: Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Vesting in the discretionary matching and non-elective profit sharing contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in the discretionary matching and non-elective profit sharing contributions after six years of credited service.

Payment of Benefits: Upon termination of service due to death or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments if their account balance exceeds \$5,000. In addition, a participant's account may be distributed upon attaining age 59 1/2, for financial hardship, as defined, as well as for a participant's disability. On termination of service due to disability or termination of employment, mandatory distributions are processed for participant's vested account balances less than \$5,000. If participants do not elect to either receive or rollover a mandatory distribution and the distribution exceeds \$1,000, the distribution will be directly rolled over to an IRA. Participants may withdraw amounts contributed representing distributions from other qualified plans at any time and at any age.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's vested account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and must be repaid to the Plan within a period specified by the Plan agreement, generally not exceeding five years. The Employer establishes the specific terms and conditions of each loan. Principal and interest is paid ratably through payroll deductions.

Forfeitures: Forfeitures represent the portion of the Employer's discretionary contributions that are lost by a participant who terminates employment prior to becoming fully vested under the Plan's vesting schedule. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$264,842 and \$173,456, respectively.

Forfeitures may be used to offset Plan administrative expenses or future Employer contributions. For the year ended December 31, 2024, Plan administrative expenses were offset by \$110,353.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation in fair value of investments reported by the Plan.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date in the Plan's principal or most advantageous market for the asset or liability. The plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Note 3 – Income Tax Status

The IRS has determined and the Plan trustee has been informed by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Instances of operational error and non-compliance with the terms of the Plan were discovered. These errors consisted of participant elective deferral not being updated in a timely manner per participant's election. Management is in the process of taking corrective actions. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, except for the non-compliance noted above. Although there is a risk that these errors may have an adverse impact on the tax status of the Plan, management believes the corrective actions will allow the Plan to keep its tax qualification.

Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination would receive distributions of their account balances. Net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan.

Note 5 – Information Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the Plan, and accordingly, are unaudited as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations.

Note 6 – Fair Value Measurements

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Note 6 – Fair Value Measurements:(Continued)

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments. There were no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit.

Mutual Funds: The fair values of mutual fund investments are based upon the closing net asset value per share of the mutual fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

Stable Value Collective Trust Fund: The stable value collective trust fund is composed primarily of fully benefit-responsive investment contracts. The fund invests in conventional guaranteed investment contracts (“GICs”) issued by insurance companies and synthetic investment contracts or wrap contracts issued by insurance companies or banks through a collective trust fund sponsored by Principal Life Insurance Company (“PLIC”). The fair values of participation units held in the stable value collective trust fund is based on the net asset values per unit as reported by the fund managers. The stable value collective trust fund provides for daily redemption by the Plan at reported net asset value per share, with no advance notice requirement. However, redemptions by Plan participants to reinvest in options that compete with the stable value collective trust fund may be delayed for up to 90 days. Currently, the Plan does not provide for any competing stable value funds or benefit responsive investment contracts.

Target Date Collective Investment Funds: The fair values of units held in target date collective investment funds are based on the net asset values per unit as reported by the fund managers. The target date collective investment funds provide for daily redemption by the Plan at reported net asset value per share, with no advance notice requirement.

Note 7 – Exempt Party-In-Interest and Related Party Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Employer. Certain Plan investments, including collective investment funds, a stable value fund and pooled separate accounts are issued by Principal Global Investors Trust Company (“PGITC”) or Principal Life Insurance Company (“Principal”), affiliates of Principal Trust Company (PTC), the trustee of the Plan. PTC, PGITC and Principal are service providers to the Plan, and therefore, these transactions and the payment of any fees, as applicable, to PTC, PGITC and Principal qualify as party-in-interest transactions. In addition, Raymond James & Associates, Inc. is an investment advisor to the Plan and Nova 401(k) Associates, Inc., who performs certain administrative services for the Plan. Therefore, the payment of fees to these service providers qualify as party-in-interest transactions. For the year ended December 31, 2024, total fees paid for investment advisory and administrative services were \$33,034 and \$10,182, respectively. Notes receivable from participants also qualify as party-in-interest transactions. For the year ended December 31, 2024, total principal amounts of \$456,567 of loans were issued to participants.

Note 8 – Notes Receivable from Participants

Notes receivable from participants bear interests ranging from 5.25% to 10.50% and are receivable in monthly installments over a period of one to nine years. Loan balances range from \$47 to \$48,627 at December 31, 2024.

Note 9 – Risk and Uncertainties

The Plan provides for various investment options in funds which participants can invest in a combination of investment securities. Investments are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Note 10 – Subsequent Events

The Plan has evaluated events occurring after the date of the accompanying statement of net assets available for benefits through October 8, 2025 the date the financial statements are available for issuance. The Plan did not identify any material subsequent events requiring adjustment to or disclosure in the accompanying financial statements.
