Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of St. Luke's Cornwall Hospital 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

1. Plan Description:

The following description of the St. Luke's Cornwall Hospital 403(b) Retirement Plan (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the plan's provisions.

General

The Plan is a defined contribution plan covering all employees of St. Luke's Cornwall Hospital (the "Hospital") who are age 21 or older and have completed one year of service. Union employees and employees of Hudson Vista Medical PC are excluded from participating in the Hospital contribution features of the Plan. Effective January 1, 2024, the Plan was amended to allow staff employees of Hudson Vista Medical, P.C. to be included in the employee group that is eligible to receive Hospital matching and core contributions. Montefiore Health System is the active parent of the Hospital. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has implemented certain requirements of the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions.

Contributions

Each year, participants may contribute up to 85% of pre-tax annual compensation, not to exceed the Internal Revenue Service ("IRS") limit, as defined in the Plan agreement. The Plan provides for Hospital matching contributions of 100% of the first 3% of compensation a participant contributed to the Plan, plus a 50% match on the next 3% of compensation contributed. In total, the Hospital will contribute a maximum of 4.5% of compensation annually if the participant contributes 6% of compensation to the Plan. The Plan also provides for Hospital core contributions; the contribution percentage is at the discretion of the Hospital. For the years ended December 31, 2024 and 2023, the Hospital contributed 2% and 2%, respectively, of the participant's compensation. The participant contributions and the Hospital matching and core contributions may be allocated to various investment options offered by the Plan as the participant directs.

Participant Accounts

Participant accounts are credited with the participant's contributions and an allocation of the Hospital's contributions and Plan earnings/(losses). Allocations are based on each participant's earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Notes Receivable from Participants

The Plan allows traditional loans which are secured by the balance in the participant's account and carry interest rates equal to that charged by a bank or other professional lender. Once the rate is established, it remains fixed over the life of the loan. These transactions are treated as a transfer to/(from) the investment fund and from/(to) the Participant Notes fund. Principal and interest may be paid through payroll deductions or directly to Transamerica Financial Life Insurance Company Inc. ("TFLIC").

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer matching contributions is based on years of continuous service. A participant is 100% vested after 1 year of service. A year of service for vesting purposes is any Plan year in which the participant completed at least 975 hours of service.

Distributions

Upon retirement, a participant receives either a lump-sum amount or monthly, quarterly, or annual installments equal to the value of his or her account. A participant may also withdraw his account balance upon termination. However, any non-vested portion of the account balance is forfeited.

Forfeitures

Forfeitures in the amount of \$349 and \$4,870 were used to pay Plan expenses during 2024 and 2023, respectively. Forfeiture balances amounted to \$1,716 and \$1,936 as of December 31, 2024 and 2023, respectively.

1. Plan Description (continued):

Plan Termination

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their account balances.

Administration

The Plan is administered by St. Luke's Cornwall Hospital. State Street Bank and Trust Company is the custodian of the Plan. The recordkeeper of the Plan is TFLIC.

2. Summary of Significant Accounting Policies:

Basis of Accounting

The Plan uses the accrual method of accounting which recognizes income when it is earned and expenses as they are incurred.

Pervasiveness of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on those investments bought and sold during the year as well as held at year-end.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All general administrative expenses of maintaining the Plan are paid by the Hospital. Participant loan setup fees and distribution fees are deducted from the proceeds paid to the initiating participants. Investment management fees are charged to participant accounts.

Risks and Uncertainties

The Plan utilizes various investment instruments which are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements. The Plan's investments are not insured or protected by the Plan's Custodian. Accordingly, the Plan is subject to the normal investment risks associated with money market funds, mutual funds, stocks, bonds and other similar types of investments.

Income Taxes

The Plan has adopted a volume submitter plan sponsored by Transamerica Retirement Solutions LLC. The volume submitter plan provider has received an advisory letter from the IRS as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and being operated in compliance with the applicable provisions of the IRC.

2. Summary of Significant Accounting Policies (continued):

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and concluded that, as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Subsequent Events

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustment to the financial statements or disclosure is October 13, 2025, which is the date on which the financial statements were available to be issued.

3. Information Certified by Custodian:

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and the supplemental schedule, that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and the supplemental schedule.

The custodian also certified to the completeness and accuracy of \$9,976,801 and \$11,884,855 of net appreciation in fair value of investments and \$2,249,198 and \$1,935,386 of interest and dividends related to the aforementioned Plan Assets for the years ended December 31, 2024 and 2023, respectively.

4. Fair Value Measurements:

Accounting principles generally accepted in the United States of America provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs other than quoted prices that are observable for the asset or liability;
- d. Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair Value Measurements (continued):

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at a daily calculated net asset value ("NAV") and traded at a quoted price through the National Securities Clearing Corporation.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of the future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract:

The Plan has a fully benefit-responsive group annuity contract with TFLIC, the recordkeeper. The recordkeeper maintains the contributions in a fixed income contract. The contract guarantees principal and provides a stated rate of return backed by the recordkeeper.

The investment contract is fully benefit-responsive and contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed income contract. Contract value, as reported to the Plan by the recordkeeper, represents deposits made under the contract, plus interest credited under the terms of the contract, less any withdrawals. Participants may originally direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting rate is determined by TFLIC, but may not be less than the minimum guaranteed rate. TFLIC establishes a crediting rate for new deposits received during a calendar quarter, which will be applicable to such assets through the end of the calendar year. For other existing Fixed Fund assets, the crediting rate is established by TFLIC on a calendar year basis. The Crediting Rate as of December 31, 2024 and 2023 was 2.90% and 2.30%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) premature terminations of the contracts by the Plan, (2) Plan closings, (3) layoffs, (4) Plan terminations, (5) bankruptcies, (6) mergers and (7) early retirement incentives. No events are probable of occurring that might limit the ability of the Plan to transact at contract value and also limit the ability of the Plan to transact at contract value with participants. The Plan itself must allow participants reasonable access to their funds.

In addition, certain events and circumstances allow the issuer to terminate the fully benefit-responsive investment contracts with the Plan and settle at an amount different from contract value. Such events include the following: (1) if the Hospital wishes to terminate the Plan's interest, the amount paid out will be the value of the Plan's interest or (2) termination will occur on the date when both no current deposit arrangements have been made between participant and issuer and there are no Guaranteed Interest Funds with a value greater than zero.

6. Related Party Transactions:

Certain Plan investments are shares of mutual funds managed by State Street Bank and Trust Company and TFLIC. State Street Bank and Trust Company and TFLIC are the custodian and recordkeeper, respectively, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$50,089 and \$28,072 for the years ended December 31, 2024 and 2023, respectively.
